Violence Against Women Act Report

A goal of the Lawrence County Housing Authority is to fully comply with the Violence Against Women Act (VAWA). It is our objective to work with others to prevent offenses covered by VAWA to the degree we can.

Lawrence County Housing Authority provides or offers the following activities, services, or programs, either directly or in partnership with other service providers, to child or adult victims of domestic violence, dating violence, sexual assault, or stalking.

Through cooperation with the local domestic violence agency and local police departments, any cases of violence as described are referred for assistance. The local domestic violence agency is the Stop Woman Abuse Now (SWAN), located in Olney, Illinois.

Lawrence County Housing Authority provides or offers the following activities, services, or programs that help child and adult victims of domestic violence, dating violence, sexual assault, or stalking, to obtain or maintain housing.

The above listed agency's program staff is aware of our housing program and makes client referrals to our office. Apparently eligible clients are placed on our waiting list.

For persons already living in a Housing Authority unit who become victims as described, these are referred to police and the local domestic violence agency for assistance. If the management becomes aware of any violator who may be restricted through an order of protection, that person is prohibited from the premises and is considered a trespasser subject to arrest and removal. The police departments are cooperative and supportive in cases such as this, and willingly respond and enforce the protective orders.

Lawrence County Housing Authority provides or offers the following activities, services, or programs to prevent domestic violence, dating violence, sexual assault, and stalking, or to enhance victim safety in assisted families.

The same methods as described herein are used, making referrals to SWAN for counseling and support services, and attempting to enforce orders of protection with the cooperation of police department personnel.

Lawrence County Housing Authority has the following procedure in place to assure applicants and residents are aware of their rights and responsibilities under the Violence Against Women Act:

All residents have been notified of their rights and responsibilities under the Violence Against Women Act.

The orientation for new residents includes information on their rights and responsibilities under the Violence Against Women Act.

The Admissions & Continued Occupancy Policy (ACOP) and the Public Housing Dwelling Lease have been updated to include screening and termination language related to the Violence Against Women Act

Illinois Carbon Monoxide Detector Alarm Act

In accordance with Illinois Carbon Monoxide Detector Alarm Act PA 094-0741 (430 ILCS 135) effective 1/1/07 the Lawrence County Housing Authority has installed detectors in each family unit of project IL 108-002. Projects IL 108-005, 108-006, and 108-007 have central boilers and detectors are installed outside the boiler rooms. Projects IL 108-001 and 108-003 are all electric and no carbon monoxide detectors are required. This follows the written policy interpretation (Policy #06-FP-001) of the Office of the Illinois State Fire Marshall.
