ii. Executive Summary of the Annual PHA Plan

The West Plains Housing Authority is a medium PHMAP High-Performer agency located in Howell County, Missouri. The WPHA manages 272 units of public housing at four developments.

The mission of the WPHA is:

The West Plains Housing Authority is committed to promoting adequate and affordable housing without discrimination for low-income, very low-income families, persons with disabilities or the elderly.

The WPHA will accomplish its mission ideals through its goals and objectives:

1. Providing decent, safe and affordable housing in your community.
2. Ensuring equal opportunity in housing for everyone
3. Promoting self-sufficiency and asset development of financially disadvantaged families and individuals.
4. Increase resident participation through resident council and/or advisory committee.
5. To provide timely response to residents' request for maintenance problems.
6. To return vacated units with new resident in 20 days.
7. To continue to enforce our "One Strike" policies for resident and applicants.
8. To improve and/or maintain our financial stability through aggressive rent collections and improved reserve position

The WPHA's financial resources include an operating fund, capital fund, dwelling rental income and Housing Choice Voucher Program Administrative fees which will be used to operate the agency in the most cost effective means possible and still provide the services and activities for its residents.

The WPHA has assessed the housing needs of West Plains and surrounding Howell County area and has determined that it is currently and will continue to meet the housing needs of the community to the extent practical for a medium size agency. The WPHA has approved a Deconcentration Policy and will utilize Local Preferences to attract and encourage applicants that can qualify for public housing. The WPHA has determined that its housing strategy complies with the state of Missouri's Consolidated Plan.

The WPHA has updated and rewritten its Admissions and Continued Occupancy Plan,

Dwelling Lease and Grievance procedures to comply with all QHWRA requirements. The WPHA has established a minimum rent of \$25.00 and developed new market value rents which were implemented October 1, 2002.

The WPHA has conducted a physical needs assessment to determine its modernization requirements and has developed an Annual and 5 year Action Plan to address its Capital Improvements. In addition, due to the reduction of CFP funding the WPHA intends to contribute operating reserves periodically to accelerate selected work items.

The WPHA has identified compliance with the Community Service requirements by rewriting its Admission and Continued Occupancy Plan and Dwelling lease to address those adult members of any family whom must perform community service activities annually. In addition, the WPHA has developed a self-certification form that is enclosed.

The WPHA has no plans to demolish or dispose of any of its properties. The WPHA has jointly addressed with the local police department to develop safety and crime prevention that adequately meets the needs of its residents. In response to the latest Resident survey the WPHA will have a lighting study performed at both scattered sites to determine if additional security lighting is required or if existing lighting should be redirected. The WPHA also, through its newly hired Resident Coordinator will respond to needs of these residents by holding quarterly meetings with follow-up to requested information, provide additional in-sight into the admissions process and generally provide more accessibility to management. .

The WPHA has developed an agency wide Pet Policy that allows any family to have a pet if they follow a set of rules. This policy has been made available for public and resident comment.

The WPHA has certified that it has and will continue to adhere to all Civil Rights requirements and will affirmatively further fair housing in addition, the WPHA has included a copy of its most recent fiscal year audit reports as part of the documentation made available for public review during the 45 days prior to submission of WPHA's Agency Plan to HUD on October 18, 2007.

The WPHA has developed a very effective facility maintenance plan to maintain it's properties and manage its, operation through the proper utilization of the following Annual Plan components:

Fish	In tanks or aquariums, not to exceed 20 gallons in capacity; poisonous or dangerous fish are not permitted.								
Dogs	Not to exceed 20 lbs. Weight at full growth. Dogs must be spayed or neutered. 2. No more than one dog or cat shall be permitted in a household. In the case of birds, a maximum of two birds may be permitted. There shall be no limit as to the number of fish, but no more than one aquarium with a maximum capacity of 20 gallons shall be permitted. A resident with a dog or cat may also have other categories of "common household pets" as defined above.
 3. Pets other than a dog or cat shall be confined to an appropriate cage or container. Such a pet may be removed from its cage while inside the owner's apartment for the purpose of handling, but shall not generally be unrestrained.
 4. Only one dog or cat is allowed per household. **NO PIT BULLS OR CHOWS WILL BE PERMITTED.** All dogs and cats will need to be on a leash, or otherwise restrained at all times when they are outside. Neither dogs nor cats shall be permitted to run loose. No animals are to be tied outside the unit. **NO OUTSIDE DOG HOUSES.** Pets will not be allowed in the Community Buildings, Office or any public building under the control of the Housing Authority at any time.

5. Guests of residents are NOT permitted to bring pets of any kind on the Housing Authority property.
6. Pet owners shall maintain their pet in such a manner as to prevent any damage to their unit, yard, or common areas or the community in which they live. The animal shall be maintained so as not to be a nuisance or a threat to the health or safety of neighbors, WPHA employees, or the public, by reason of noise, unpleasant odors or other objectionable situations. Resident shall prevent their dog from urinating or defecating on buildings, trees, shrubs, bushes or flowers on the WPHA property.
7. Each pet owner shall be fully responsible for the care of the pet, including proper disposal of pet waste in a safe and sanitary manner. Residents are to provide litter boxes for cat waste, which are to be kept in the unit. Tenants shall not allow waste to accumulate. Resident shall dispose of waste by placing it in a plastic bag, sealing bag and deliver unbroken to trash containers. Residents are responsible for the immediate cleaning up of their pet's droppings, INSIDE AND OUTSIDE of their unit and on WPHA property and properly disposing of said droppings in trash containers. Improper disposal of pet waste is a lease violation and may be grounds for eviction.
8. All pets shall be inoculated in accordance with applicable state and local laws. The resident must provide WPHA with a certificate signed by veterinarian, each year, that distemper and rabies shots, or boosters have been given. No pet shall be kept in violation of State Humane or Health Laws, or Local Ordinance. All cats and dogs shall be spayed or neutered, unless a veterinarian certifies that the spaying or neutering would be inappropriate or unnecessary (because of health, age, etc.)
9. Resident shall not permit any disturbance by their pet which would interfere with the peaceful enjoyment of other tenants: whether by barking, howling, biting, scratching, chirping or other such activities.
10. Resident shall not alter their unit, patio or unit area to create any enclosure for an animal or any other reason.
11. Residents are responsible for any and all damages, including costs of fumigation caused by their pets.
12. All residents are prohibited from feeding stray animals. The feeding of stray animals shall constitute having a pet without approval of the WPHA and shall be considered cause for eviction.
13. All pets shall be registered with the Management Office PRIOR to their introduction to the community.
14. Any litigation resulting from actions by pets shall be the sole responsibility of the pet owner. The pet owner agrees to indemnify and hold harmless the WPHA from all claims, causes of action damages or expenses, including attorney's fees, resulting from the action or the activities of his or her pet. The WPHA accepts NO RESPONSIBILITY for the pet under any circumstance. The WPHA strongly advises resident to obtain liability insurance. State Law provides that it is a crime to not control your pet; failure to do so the first (1st) time is a misdemeanor; the second (2nd) time is a felony.

Deconcentration Policy

It is the policy of the West Plains Housing Authority of (WPHA) to house families in a manner that will prevent a concentration of poverty families and/or concentration of higher income families in any one development. The specific objective of the WPHA is to house no less than 40% of its inventory with families that have income at or below 30% of the area median income by public housing development. Also the WPHA will take actions to insure that no individual development has a concentration of higher income families in one or more of the developments. To insure that the WPHA does not concentrate families with higher income levels, it is the goal of the WPHA not to house more than 60% of its units in any one development with families whose income exceeds 30% of the area median income. The WPHA will track the status of family income, by development, on a monthly basis by utilizing income reports generated by the WPHA.

To accomplish the deconcentration goals the WPHA will take the following actions:

- A. At the beginning of each fiscal year, the WPHA will establish a goal for housing 40% of its new admissions with families whose incomes are at or below the area median income. The annual goal will be calculated by taking 40% of the total number of move-ins from the previous fiscal year.
- B. To accomplish the goals of:
 - 1. Housing not less than 40% of its inventory on an annual basis with families that have incomes at or below 30% of area median income, and
 - 2. Not housing families with incomes that exceed 30% of the area median income in developments that have 60% or more of the total household living the development with incomes that exceed 30% of the area median income, the WPHA's Tenant Selection and Assignment Plan, which is a part of this policy, provides for the utilization of local preferences with regards to applicant selection from its waiting list.

Attachment H

Implementation of Public Housing Resident Community Service Requirement

The West Plains Housing Authority's policy is designed to identify which adult family members are subject to or exempt from the service requirements; to explain how the PHA will administer its program; to identify PHA and/or third party certification opportunities available to eligible adult family members; and to assure resident compliance with identified work activities with fair and equitable actions.

PHA Responsibilities

1. Eligibility Determination

The PHA will review every existing resident file to determine each Adult member's status regarding community service per the guidelines of 24CFR, Part 960.6.

- a. As family status is determined a registered letter or other certifiable document of receipt will be sent to each adult member of that family to notify them of their status (exempt or non-exempt) and explaining the steps they should immediately proceed with through their housing representative.
- b. The PHA will include a copy of the general information section of its Community Service Policy and a listing of PHA and/or third party work activities that are eligible for certification of the community service requirement.
- c. At the scheduled meeting with each non-exempt adult family member, not only will the parameters of the community service requirement be reviewed but also the PHA and/or third party work activities will be identified and selected for compliance with the annual obligation for certification at their annual lease renewal date.

2. Work Activity Opportunities

The West Plains Housing Authority has elected to provide to those adult family members that must perform community service activities the opportunity to select either PHA sanctioned work activities or Third Party certifiable work items. The administration of the certification process would be:

a. PHA Provided Activities.

When qualifying activities are provided by the Authority directly, designated Authority employee(s) shall provide signed certification that the family member has performed the proper number of hours for the selected service activities.

b. Third Party Certification

When qualifying activities are administered by any organization other than PHA, the family member must provide signed certification (see III A (c)) to the Authority by such third party organization that said family member has performed appropriate service activities for the required hours.

c. Verification of Compliance.

The Authority is required to review family compliance with service requirement, and must verify such compliance annually at least thirty (30) days before the end of the twelve (12) month lease term (annual re-certification time). Evidence of service performance and/or exemption must be maintained in the participant files.

d. Notice of Noncompliance.

If the Authority determines that, a family member who is subject to fulfilling a service requirement, but who has violated the family's obligation (a noncompliant resident) the Authority must notify the specific family member of this determination.

The Notice of Noncompliance must:

1. Briefly, describe the noncompliance (inadequate number of hours).
2. State that the Authority will not renew the lease at the end of the twelve (12) month lease term unless:

The resident or any other noncompliant adult family member enters into a written agreement with the Authority to cure the noncompliance and in fact perform to the letter of agreement.

- Or -

The family provides written assurance satisfactory, to the PHA that the resident or other noncompliant adult family member no longer resides in the unit.

This Notice of Noncompliance must also state that the resident may request a grievance hearing and that the resident may exercise any available judicial remedy to seek timely redress for the Authority's non-renewal of the lease because of a noncompliance determination.

e. Resident agreement to comply with the service requirement.

The written agreement entered into with the Authority to cure the service requirement noncompliance by the resident and any other adult family member must:

1. Agree to complete additional service hours needed to make up the total number of hours required over the twelve (12) month term of the new lease.
2. State that all other members of the family subject to the service requirement are in current compliance with the service requirement or are no longer residing in the unit.

VIOLENCE AGAINST WOMEN ACT POLICY WEST PLAINS HOUSING AUTHORITY

1.0 PURPOSE

The purpose of this Policy is to reduce domestic violence, dating violence, and stalking and to prevent homelessness by:

- a) protecting the safety of victims;
- b) creating long term housing solutions for victims;
- c) building collaborations among victim service providers; and
- d) assisting Housing Authority to respond appropriately to the violence while maintaining a safe environment for Housing Authority, employees, tenants, applicants, Section 8 participants, program participants and others.

The Policy will assist the West Plains Housing Authority (WPHA) in providing rights under the Violence Against Women Act to its applicants, public housing residents, Section 8 participants and other program participants.

2.0 MISSION STATEMENT

WPHA's policy is to comply with the 2005 VAWA Pub. L. 109-162; Stat 2960 signed into law on January 5, 2006 and codified at 42 U.S.C. - 1437d (1) and 437f(d), (o) & 1 and (u).

WPHA shall not discriminate against an applicant, public housing resident, Section 8 program participant or other program participant on the basis of the rights or privileges provided under the VAWA.

This Policy is incorporated into WPHA's "Admission & Continuing Occupancy of Low Rent Housing" and "Section 8 Program Administrative Plan" and applies to all WPHA housing programs.

3.0 DEFINITIONS

The definitions in this Section apply only to this Policy.

3.1 CONFIDENTIALITY:

Means that WPHA will not enter information provided to WPHA under 4.0 and 4.1 into a shared database or provide this information to any related entity except as stated in 4.2.

3.2 DATING VIOLENCE:

Violence committed by a person

- a) who is or has been in a social relationship of a romantic or intimate nature with the victim; and
- b) where the existence of such a relationship shall be determined based on a

consideration of the following factors:

- i) the length of the relationship
- ii) the type of relationship
- iii) the frequency of interaction between the persons involved in the relationship 42USC s. 1437d(u)(3)(A).

3.3 DOMESTIC VIOLENCE:

Felony or misdemeanor crimes of violence committed by a current or former spouse of the victim, committed by a person with whom the victim shares a child in common, committed by a person who is cohabitating with or has cohabitated with the victim as a spouse, committed by a person similarly situated to a spouse of the victim under the domestic or family violence laws of Missouri, or committed by any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the State of Missouri 42 USC s. 1437d(u)(3)(B).

3.4 IMMEDIATE FAMILY MEMBER

A spouse, parent, brother or sister, or child of a victim or an individual to whom the victim stands in loco parent; or any other person living in the household of the victim and related to the victim by blood or marriage. 42 USC s. 1437d(u)(3)(D).

3.5 LONG TERM HOUSING:

Is housing that is sustainable, accessible, affordable and safer for the foreseeable future which:

- a) the person rents or owns;
- b) is subsidized by a voucher or other program as long as the person meets the eligibility requirements of the program;
- c) directly provided by WPHA, is not time limited and the person meets the eligibility requirements of the program.

3.6 PERPETRATOR:

A person who commits an act of domestic violence, dating domestic violence or stalking against a victim.

3.7 STALKING;

- a) to follow, pursue or repeatedly commit acts with the intent to kill, injure, harass or intimidate the victim;
- b) to place under surveillance with the intent to kill, injure, harass or intimidate the victim;
- c) in the course of, or as a result of such following, pursuit, surveillance, or repeatedly committed acts, to place the victim in reasonable fear of the death of, or serious bodily injury to the victim; or
- d) to cause substantial emotional harm to the victim, a member of the immediate

family of the victim or the spouse or intimate partner of the victim 42 USC - 1437d(u)(3)(c).

3.8 VICTIM

Is a person who is the victim of domestic violence, dating violence, or stalking under this Policy and who has timely and completely completed the certification under 4.0 and 4.1 or as requested by WPHA.

3.9 FAILURE TO PROVIDE CERTIFICATION UNDER 4.0 AND 4.1

The person shall provide completed and accurate certifications to WPHA, owner or manager within 14 days after the party requested in writing that the person complete the certifications. If the person does not provide a completed and accurate certification within the 14 business days, WPHA, the owner or manager may take action to deny or terminate participation or tenancy under 42 USC s. 1437I(5)&(6); 42 USC s. 1437(d)(c)(3); 42 USC s. 1437 f(c)(9); 42 USC s. 1437f(d)(1)(B)(ii)&(iii); 42 USC s. 1437f(o)(7)(C)&(D); or 42 USC s. 1437f(o)(20) or for other good cause.

4.0 HUD APPROVED CERTIFICATION

For each incident that a person is claiming abuse, the person shall certify to WPHA, owner or manager their victim status by completing a HUD approved certification form. The person shall certify the date, time and description of the incidents, that the incidents are bona fide incidents of actual or threatened abuses and meet the requirements of VAWA and this Policy. The person shall provide information to identify the perpetrator including but not limited to the name and, if known, all alias names, date of birth, address, contact information such as postal, email or internet address, telephone or facsimile number or other information.

4.1 OTHER CERTIFICATION

A person who is claiming victim status shall provide to WPHA, an owner or manager:

- a) documentation signed by the victim and an employee, agent or volunteer of a victim service provider, an attorney or a medical professional from whom the victim has sought assistance in addressing domestic violence, dating violence or stalking or the effects of the abuse, in which the professional attests under penalty of perjury (28 USC s. 1746) to the professional's belief that the incident(s) in question are bona fide incidents of abuse; or
- b) a federal, state, tribal, territorial, local police or court record.

4.2 CONFIDENTIALITY

WPHA, the owner and manager shall keep all information provided to WPHA under this Section confidential. WPHA, owner and manager shall not enter the information into a shared database or provide to any related entity except to the extent that:

- a) the victim requests or consents to the disclosure in writing;

- b) the disclosure is required for:
 - (i) eviction from public housing under 42 USC - 1437 l (5) & (6) (See Section 5 in this Policy);
 - (ii) termination of Section 8 assistance under 42 USC s. 1437f(c)(9); 42 USC s. 1437(d)(1)(B)(ii)&(iii); 42 USC s. 1437f(o)(7)(C)&(D); or 42 USC s. 1437f(o)(20) (See Section 5 in this Policy); or
- c) the disclosure is required by applicable law.

4.3 APPROPRIATE BASIS FOR DENIAL OF ADMISSION, ASSISTANCE OR TENANCY

- a) WPHA shall not deny participation or admission to a program on the basis of a person's victim status, if the person otherwise qualifies for admission or assistance.
- b) An incident or incidents of actual or threatened domestic violence, dating violence, or stalking will not be a serious or repeated violation of the lease by the victim and shall not be good cause for denying to a victim admission to a program, terminating Section 8 assistance or occupancy rights, or evicting a tenant.
- c) Criminal activity directly related to domestic violence, dating violence or stalking engaged in by a member of a tenant's household or any guest or other person under the tenant's control shall not be cause for termination of assistance, tenancy or occupancy rights if the tenant or an immediate member of the tenant's family is the victim of that domestic violence, dating violence or stalking.
- d) Notwithstanding Sections 4.4(a), (b) and (c), WPHA, an owner or manager may bifurcate a lease to evict, remove or terminate assistance to any individual who is a tenant or lawful occupant and who engages in criminal acts of physical violence against family members or others without evicting, removing, terminating assistance to or otherwise penalizing the victim of the violence who is also a tenant or lawful occupant. 42 USC s. 1437d (1)(6)(B)
- e) Nothing in Sections 4.4(a), (b) and (c) shall limit the authority of WPHA, an owner or manager, when notified, to honor court orders addressing rights of access to or control of the property, including civil protection orders issued to protect the victim and issued to address the distribution or possession of property among the household members when the family breaks up.
- f) Nothing in Sections 4.4(a), (b) and (c) limits WPHA, an owner or manager's authority to evict or terminate assistance to any tenant for any violation of lease not premised on the act or acts of violence against the tenant or a member of the tenant's household. However, WPHA, owner or manager may not hold a victim to a more demanding standard.
- g) Nothing in Sections 4.4(a), (b) and (c) limits WPHA, an owner or manager's authority to evict or terminate assistance, or deny admission to a program if the WPHA, owner or manager can show an actual and imminent threat to other tenants, neighbors, guests, employees of WPHA, an owner or manager, persons

- employed at or providing service to the property or others if the tenant family is not evicted or terminated from assistance or denied admission.
- h) Nothing in Sections 4.4(a), (b) and (c) limits WPHA, an owner or manager's authority to deny admission, terminate assistance or evict a person who engages in criminal acts including but not limited to acts of physical violence or stalking against family members or others.
 - i) A Section 8 recipient who moves out of an assisted dwelling unit to protect their health or safety and who:
 - A) is a victim under this Policy;
 - B) reasonably believes he or she is imminently threatened by harm from further violence if he or she remains in the unit; and
 - C) has complied with all other obligations of the Section 8 program will not be denied portability to a unit located in another jurisdiction, and may receive a voucher and move to another Section 8 jurisdiction.
 - j) A public housing tenant who wants a transfer to protect his or her health or safety and who:
 - A) is victim under this Policy;
 - B) reasonably believes he or she was imminently threatened by harm from further violence if he or she remains in the unit; and
 - C) has complied with all other obligations of the public housing income program may transfer to another PHA unit, receive a Section 8 voucher and stay in jurisdiction or move to another Section 8 jurisdiction.

5.0 ACTIONS AGAINST A PERPETRATOR

WPHA may evict, terminate assistance, deny admission to a program or trespass a perpetrator from its property under this Policy. The victim shall take action to control or prevent the domestic violence, dating violence or stalking. The action may include but is not limited to:

- a) obtaining and enforcing a restraining or no contact order or Order of Protection against the perpetrator;
- b) obtaining and enforcing a trespass against the perpetrator;
- c) enforcing WPHA or law enforcement's trespass against the perpetrator;
- d) preventing the delivery of the perpetrator's mail to the victim's unit;
- e) providing identifying information listed in 4.0; and
- f) other reasonable measures.

6.0 NOTICE TO APPLICANTS, PARTICIPANTS, TENANTS AND SECTION 8 MANAGERS AND OWNERS

WPHA shall provide notice to applicants, participants, tenants, managers and owners of their rights and obligations pertaining to Confidentiality and Appropriate Basis for Denial of Admission, Assistance or Tenancy.

7.0 REPORTING REQUIREMENTS

WPHA shall include in its 5 year plan a statement of goals, objectives, policies or programs that will serve the needs of victims. WPHA shall also include a description of activities, services or programs provided or offered either directly or in partnership with other service providers to victims, to help victims obtain or maintain housing or to prevent the abuse or to enhance the safety of victims.

8.0 CONFLICT AND SCOPE

This Policy does not enlarge WPHA's duty under the law, regulation or ordinance. If this Policy conflicts with the applicable law, regulation or ordinance, the law, regulation or ordinance shall control. If this Policy conflicts with another WPHA policy, such as its Statement of Policies or Section 8 Administration Plan, this Policy will control.

9.0 AMENDMENT

The Executive Director may amend this policy when it is reasonably necessary to effectuate the Policy's intent, purpose or interpretation. The proposed amendment along with the rationale for the amendment shall be submitted to the Executive Director for consideration where reasonably necessary. The Board of Commissioners must approve the amendment. The amendment shall be effective and incorporated on the date that the Board of Commissioners approves the amendment.

WHEREAS, this Policy is now in it's final form and has been approved by the Housing Authority's legal council.

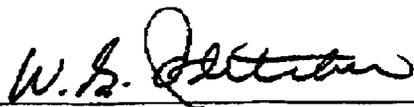
