The Consolidated Plan of North Carolina 2006-2010, dated January 1, 2006, list three levels of priorities with regards to the rental programs managed by the Wadesboro Housing Authority. Of those listed as a "High Priority Renters" on page 47 of the plan, it is targeting renters earning 0-30% of median family income in urban areas and 0-50% of median family income in rural areas. "Medium Priority Renters", page 65, are described as those earning between 51-60% of median family income. In its Public Housing program, Wadesboro Housing Authority admits persons or families with incomes of 30% or less of the median family income in at least 40% of all new admissions. The remaining 60% are reserved for those individuals or families earning 31-80% of the median family income. Current admissions data for 2007 indicates that 19 of 20, or 90%, of new admissions since January 1, 2007 were at or below 30% of median family income. In its Section 8 Housing Choice Voucher Program, Wadesboro Housing Authority targets families earning 30% or less of the median family income for 75% of all new admissions, a "High Priority Renter". The remaining 25% are reserved for families earning between 31-50% of the median family income, a "Medium Priority Renter".

On page 103 of the North Carolina Consolidated Plan 2006-2010, "Lead Based Paint Assessment" is addressed. Wadesboro Housing Authority has taken steps to certify that no Conventional Public Housing apartment contains any lead based paint or lead based paint hazard. This was completed in 1988. In the Section 8 Housing Choice Voucher Program, Wadesboro Housing Authority encourages potential participants to look for houses built after 1978 and those that were built prior to 1978 that have been screened for lead based paint.
