Planning Area I - Related Goals of the SMHA

- A. In conjunction with the Freed Housing Corporation and other organizations, create the capacity to develop and operate a range of housing programs.**

Objectives

1. Develop a long-range plan for housing development, identifying the type, probable location, potential partners and required resources
2. Identify sources of funding for development activities and become familiar with the processes for obtaining the funds
3. Establish necessary partnerships and acquire the resources for development
4. Develop a property management entity that can perform the function of managing the properties once completed.

- B. Develop 25 units of quality, affordable housing on a scattered-site basis for rental by lower- and moderate-income individuals & families.**

Objectives

1. Form strategic alliances and partnerships with for-profit and non-profit developers of affordable housing.
2. In cooperation with strategic partners, prepare proposals for phased development of scattered site housing in non-impacted locations.
3. Through networking and direct presentation, obtain support for housing development proposal from governmental officials, housing finance agencies and, where necessary, the local community.
4. Acquire capital, sites and regulatory approvals for development.
5. Develop 25 units in years 3 through 5.

C. Develop 25 units of quality, affordable housing offering a supportive environment, physical accessibility, and independent living for lower- and moderate-income elderly persons.

Objectives

1. Form strategic partnerships with non-profit sponsors of elderly housing and related eldercare services.
2. In cooperation with strategic partners, prepare proposals for development of elderly housing in multiple locations. Consult with agencies, advocates and housing providers serving the elderly to ascertain design performance, use and service standards.
3. Secure financing, sites and regulatory approvals for development
4. Develop 25 units of elderly housing in years 3 through 5.

D. Facilitate/Create 15 units of affordable housing for ownership by lower-income families.

Objectives

1. Enter into a formal partnership with non-profit sponsors of affordable home ownership.
2. Develop a financing model for buyers that can be effectively implemented under prevailing conditions.
3. Identify and secure financial resources and in-kind services to support the initiation of the development of the housing and the operation of the purchase program.
4. Acquire, rehabilitate, and/or newly construct homes for purchase by lower income families.

E. Complete construction of projects that are already funded.

Objectives

1. Complete the pre construction process and construct 13 units of public housing as an addition to Constitution Hall in Louisville, Ohio.
2. Complete the pre-construction process and construct 28 units of assisted housing in Lake Township under the Section 202 Supportive Housing for the elderly program.

F. Participate in the revitalization of the neighborhoods in the urban centers in Stark County such as the City of Canton, the City of Alliance and the City of Massillon.

Objectives

1. In conjunction with the Freed Housing Corp., partner with local governments, non-profit agencies, private investors, residents, etc. to devise a plan to develop properties for affordable homeownership in these areas.
2. Identify potential funding sources and obtain the funding.
3. Construct and/or rehabilitate properties in the designated areas.
4. Assist potential buyers by offering homeownership education and counseling.

G. Obtain rental assistance to secure quality, affordable housing offering a supportive environment, physical accessibility, and independent living for 10 homeless households and/or persons with disabilities.

Objectives

1. Form strategic partnerships with non-profit sponsors of housing for the homeless and disabled.
2. In cooperation with strategic partners and the interagency council on homelessness, prepare a plan for the provision of supportive housing programs for the homeless.
3. In partnership with other agencies, secure funds for the provision of supportive housing programs.
4. Assist in program implementation as necessary.

H. Preserve the affordable nature of units of subsidized housing in Stark County that are at risk of being removed from the affordable housing market.

Objectives

1. In conjunction with other community partners, develop strategies and identify resources to acquire, control or otherwise prevent properties from losing their low-income eligibility.
2. Administer Tenant-Based Vouchers for persons displaced by expired use restrictions.
3. Facilitate the identification and acquisition of financing to undertake required capital improvements to ensure long-term viability of properties.
4. Complete required capital improvements.

A. Increase public and corporate awareness and acceptance of the need for affordable housing in all communities.

Objectives

Objectives

1. Identify the areas of the county to be targeted for enhanced program marketing.
2. Develop and utilize revised orientation program for voucher-holders to emphasize their option to occupy units in non-impacted areas.
3. Develop and implement landlord outreach and orientation program to attract owners of units in targeted areas.

C. Deconcentrate existing public housing developments to achieve an occupancy that is in compliance with the rule to deconcentrate poverty and to promote integration in public housing.

Objectives

1. Identify properties for which de-concentration targets are to be established.
2. Modify and implement admissions and unit assignment policies to facilitate income mixing in applicable housing developments.
3. Develop and implement incentives to attract and retain higher-income residents.
4. Establish and utilize systems to monitor the impact and effect of policies and incentives.

HUD Strategic Goal: Promote self-sufficiency and asset development of families and individuals

Planning Area III - Related Goals of the SMHA

A. Increase the number of housing assistance beneficiaries that are employed by 10%

Objectives

1. Develop and implement tenant-selection policies that place a priority on occupancy by families with members who are working, going to school or who are in job training programs.
2. Working in partnership with job training, education, and supportive service agencies, facilitate activities that enhance the employability of adults living in households receiving housing assistance.
3. Working in partnership with job training, education, and supportive service agencies, facilitate job placement and employment of adults living in households receiving housing assistance.
4. Strengthen existing and create new partnerships for the continued implementation of the Resident Economic Advancement Program (REAP).
5. Revise and implement an enhanced program marketing effort to achieve full enrollment in REAP.
6. Create and implement incentives to encourage participants to complete their participation in REAP.

B. Enable beneficiaries of housing assistance programs (public housing residents and Section 8 Tenant-Based Assistance recipients) and other members of the community to become homeowners.

Objectives

1. Continue to implement the Section 8 Homeownership program and have 25 participants purchase homes.

2. Continue to conduct homebuyer training and counseling and facilitate the provision of these services to homeownership candidates as a HUD certified housing counseling agency.
3. Conduct homebuyer education group counseling services with 200 total participants over the next five years.
4. Provide one-on-one pre-purchase counseling to 100 individuals over the next five years
5. Provide mortgage delinquency services to 50 individuals and assist 25 individuals to avoid foreclosure over the next five years.
6. Other than Section 8 voucher program participants, 15 individuals will purchase a home.

C. Enable 20 families to participate in an Individual Development Account Program to accumulate assets to attend school, start a business or purchase a home.

Objectives

1. Research agencies with similar programs and develop a program format.
2. In partnership with the SMHA Credit Union, secure grant funds to provide match dollars to program participants.
3. Implement the program by selecting the participants, conducting required classes, establishing accounts at the credit union, etc.

D. In conjunction with the Stark Metropolitan Housing Authority Credit Union, encourage residents to become members of the credit union and increase their financial knowledge and capacity

Objectives

1. Develop and implement a marketing strategy to encourage residents to become members of the credit union.
2. In conjunction with other programs sponsored by the housing authority, incorporate financial education into the agenda, case management plans, curriculum, etc. for residents of all ages.
3. Educate residents on the concept of credit and how to achieve and maintain good credit.

HUD Strategic Goal: Improve quality of life and economic viability

Planning Area IV - Related Goals of the SMHA

A. Improve the physical condition of existing SMHA-owned or SMHA-managed housing units to achieve comparability with standard quality housing in the local private housing market.

Objectives

1. Conduct a comprehensive physical needs assessment to identify improvements needed to correct deficiencies and to achieve market standards.
2. Prepare a 5-year capital improvement plan.
3. Undertake and complete capital improvements to achieve market standards in the physical conditions and amenities of existing public housing.
4. Achieve a PHAS physical inspection score of 27 (90%) or greater.
5. Prepare and submit a demolition/disposition plan to HUD for 936-938 Mahoning Rd. N.E., Canton and Guy Mack Homes.
6. Have an on-going program to evaluate housing units and to identify other properties that should be considered for demolition and/or disposition.

B. Increase the level of elderly resident satisfaction with their housing, services and programs.

Objectives

1. Facilitate the provision of programs for all seniors and disabled residents that enhance or preserve their ability to live independently.
2. Secure funding to implement the SMHA HEART program that will provide residents with medical care, podiatry care, blood pressure monitoring, meals, referrals to services, and exercise classes.
3. Undertake capital improvements required to achieve market standards for physical condition and amenities (see objectives A1-A4 above).

4. Make a change in the Admissions and Occupancy Policy to establish a local preference for applicants 50 years of age and over placing them above other singles on the waiting list when leasing one bedroom units.
5. Continue to evaluate the possibility of designating several properties as elderly only.

C. Improve/enhance the provision of security at SMHA developments as resources permit.

Objectives

1. Complete an assessment of the current SMHA Security program to identify performance issues, gaps in service, availability of resources, program mission, etc.
2. Develop a plan to address issues identified in the assessment.
3. Identify possible sources of additional resources for a security program and pursue additional funding.
4. In conjunction with the Resident Advisory Board, explore the possibility of developing neighborhood or building watch groups and/or safety committees.
5. Assess and evaluate the housing applicant screening process and take steps to improve resident selection.

D. Increase the economic viability of the SMHA by reducing the need for HUD funding for operations.

Objectives

1. Reduce SMHA per service unit expenditures by 5% (adjusted for inflation) over the next 5 years by achieving economies through improvements in efficiency, reduction in utility consumption, and cost controls.
2. Increase internally generated rental income by 10% over the next 5 years through changes in admissions policies and facilitation of resident employment and training programs.
3. Improve the collection of billed rents and reduce uncollectible debt and achieve a grade of A on the tenant receivable outstanding sub indicator for the PHAS.
4. Generate additional income through non-HUD sources.

5. Implement the project based accounting and management system and use the information to improve management practices.

E. Increase the ability of the SMHA to provide quality services by improving employee performance, productivity and customer service.

Objectives

1. Increase employee job knowledge and skill levels by completing a comprehensive training program.
2. Change the organizational chart to more clearly define lines of authority and accountability. Reassign responsibilities to increase efficiency. Revise flow of work and work scheduling to increase efficiency.
3. Revise job descriptions and performance evaluation criteria to increase employee awareness of their individual productivity and job performance.
4. Update all policies and procedures and train staff accordingly.
5. Develop an on-going training program for supervisors.
6. With input from the Resident Advisory Board, develop an on-going training program for staff in the area of customer service.
7. Develop and implement a strategy that will promote team building among housing authority employees.

F. Develop a Canton Senior Center that will enhance the provision of services to elderly housing program participants and other elderly residents of the community as well as contributing to the economic development and revitalization of Downtown Canton.

Objectives

1. In conjunction with local government, non-profit service providers and for profit entities, develop a plan to create a senior center in downtown Canton at the Knights of Columbus property.
2. Secure the funds necessary for the capital improvements to this property.
3. Bid the construction work and complete the construction at the property.

4. Open the center for occupancy by service providers, businesses, etc. and provide services and programs for the elderly residents of the community.

G. In conjunction with local governments, non-profit providers and for profit entities, develop community centers that will provide services to housing authority program participants and contribute to neighborhood economic development, while eliminating the duplication of services.

Objectives

1. Investigate the feasibility of developing a social service center at the Allen School property and develop a plan for implementation of the project.
2. Explore and evaluate other opportunities for these types of partnerships as the opportunities present themselves.

STARK METROPOLITAN HOUSING AUTHORITY AGENCY PLAN

Executive Summary

Purpose

On February 19, 1999, HUD issued regulations implementing provisions of the Quality Housing and Work Responsibility Act of 1998 (QHWRA). These regulations required each Public Housing Authority (PHA) to develop a Five-Year Plan with a statement of its Mission, Goals, and Objectives. QHWRA also required PHAs to prepare an Annual Plan with a statement of housing needs of the lower income population in its community, along with the strategies, policies and resources to be used in addressing those needs. According to QHWRA, the Five-Year Plan and Annual Plan are to be developed in consultation with PHA Public Housing and Section 8 residents. These plans are also to be offered for review and comment by the public. Finally, the goals and major activities of Five-Year and Annual Plans are to be consistent with key housing-related objectives identified in the Consolidated Plans of the governmental unit(s) within the PHA's jurisdiction. The Stark Metropolitan Housing Authority (SMHA), a public housing authority, is subject to compliance with the planning requirements of QHWRA.

Background

During the period of July - December 2004, the SMHA engaged in a collaborative planning process resulting in drafts of the Five-Year and Annual Plans. Public Housing and Section 8 residents, officials from local government, human service agencies, non-profit housing organizations, and other SMHA partners participated in focus group sessions to identify the critical housing and related needs of lower income families in Stark County. These individuals and organizations also proposed strategies for improving the living conditions of these families. Through their participation and input, these stakeholders helped the SMHA refine its mission and affirm the identity of the primary customers. They also helped the SMHA devise its approach for carrying out that mission through the provision of affordable housing, creation of quality neighborhoods, and facilitation of appropriate supportive services.

Drafts of the plan were shared with the stakeholders and meetings were held with the Resident Advisory Board as well as with other interested organizations to review the drafts. The SMHA also complied with the mandatory requirement for the public review and comment process along with the public hearing. The attached document represents the Agency Plan (including the Five-Year and Annual Plans) of the Stark Metropolitan Housing Authority which has been refined as a result of the considerable review and comment process.

Challenge Statement

The SMHA's service area encompasses the jurisdictions of Stark County Government and the City of Canton. Both governmental units are CDBG Entitlement Communities and therefore required to develop, and regularly update, Consolidated Plans. Based on the data and conclusions contained in the current Consolidated Plans for those governmental units, the key housing-related challenges faced by lower income families are:

1. Limited supply and locations of affordable housing for Extremely Low- and Very Low-Income families;
2. Limited availability & accessibility of affordable housing for the elderly & disabled;
3. Limited availability of affordable homeownership opportunities for Low-Income families.
4. Limited availability of employment opportunities that provide adequate sustainable wages.

In addition to data and conclusions contained in the Consolidated Plans, the SMHA and its partners identified several obstacles to the provision of affordable housing. They included, but were not necessarily limited to:

1. Lack of land zoned for multi-family housing;
2. Lack of public support for affordable housing development;
3. High cost of housing development; and

Lower income families, especially those, who are current and potential recipients of SMHA program benefits, were determined to have non-housing challenges that impact their ability to obtain suitable quality housing. Among those challenges and obstacles are:

1. High unemployment due to a lack of job skills and job preparedness;
2. Lower levels of educational attainment;
3. Low wages; and
4. High level of dependence on federal assistance.
5. Employment that does not provide adequate, sustainable wages.

Mission, Goals, Strategies

The mission of the SMHA is to ***"provide eligible residents of Stark County with quality affordable housing in decent, safe, and nourishing neighborhoods. By working in partnership with the public and private sectors, the SMHA provides families with housing choice and the opportunity to achieve self-sufficiency."*** This mission is to be accomplished through the development of affordable housing, ensuring equal opportunity in housing, promoting self-sufficiency, and improving the quality of life for lower income residents.

Affordable Housing

Consistent with HUD's Strategic Goal of "*Increasing the availability of decent, safe and affordable housing in American Communities*", the SMHA will develop 116 units of affordable housing. Rental housing will be targeted to the extremely low- and very-low income families, while homeownership opportunities will be created for low-income families. Housing opportunities for the elderly and disabled will also be created.

The SMHA will accomplish its related goals through the creation of public/private partnerships to facilitate affordable housing development. It will identify and pursue non-traditional sources of funding for these housing activities and utilize mixed-income and mixed-finance approaches where feasible.

Key activities to be undertaken in this plan include creating the capacity to effectively engage in housing development, the formation of partnerships, and identification of affordable housing development opportunities.

Equal Housing Opportunity

With respect to HUD's strategic goal of "*Ensuring equal opportunity in housing for all Americans*", the SMHA will seek to facilitate affordable housing opportunities in areas outside of those with concentrations of low-income families. This includes expanding housing options for Section 8 program participants as well as developing affordable housing outside of areas of low-income concentrations.

The SMHA will accomplish several of its related goals through the use of education and public information as the primary strategy. By creating a better-informed general population and a more knowledgeable group of program recipients and potential housing providers, resistance and obstacles to dispersed affordable housing can be reduced. The implementation of new policies will be the primary method of accomplishing deconcentration in public housing.

Activities will focus on identifying targets for the public information and education effort, developing outreach and education strategies, and forging partnerships to help with changing public perceptions of affordable housing and its recipients. Activities will also focus on implementing policies (i.e., income targeting, income-skipping, preferential transfers, etc.) to encourage income mixing in public housing.

Self-Sufficiency

The SMHA will address HUD's strategic goal of "*Promoting self-sufficiency and asset development*" of families and individuals by creating an environment where residents who want to achieve self-sufficiency will have every opportunity to do so. Utilizing existing and newly created partnerships to

offer an array of services, the SMHA will facilitate employment, training, and educational opportunities to program participants. Greater resident responsibility for work will be accomplished through implementation of policies and procedures that encourage work and reward success. Homeownership will be a vehicle through which asset development will be accomplished.

Activities will focus on the implementation of policies that encourage work, the assessment of supportive service/education/employment/training needs of residents, and modifications to existing programs to better meet those needs. Policies to be implemented include admissions preferences (for families that are working, going to school, or are in a training program), rent policies (income exclusions, flat rents), and community work requirements. Partnerships with service agencies will also be strengthened in the first year.

Quality of Life

Consistent with HUD's strategic goal of *"Improving quality of life and economic viability"*, the SMHA will plan and execute physical improvements, social improvements, and operational improvements resulting in an improved living environment and enhanced customer service.

The SMHA plans to accomplish the above goals through careful planning and execution of required capital improvements, utilization of partnerships to plan and initiate neighborhood improvements, and operational/administrative changes to enhance agency efficiency.

Activities will include property improvements, enhanced security, assessing the needs of elderly residents, assessing the SMHA organization in light of its goals and objectives, and identifying methods for improving the efficiency and effectiveness of its program delivery.

Conclusion

The SMHA's mission, goals and objectives are consistent with the needs and priorities expressed by local government in their Consolidated Plans. It is commendable that the housing authority has put so much money and time into the Metropolitan Cenntrre, but that does not help or assist in a plan to rehabilitate the number of units available for housing low-income citizens. 

Organizational Chart





EXECUTIVE ORGANIZATIONAL CHART 2006



SECTION 8 HOMEOWNERSHIP PROGRAM CAPACITY STATEMENT

The Stark MHA has developed a Section 8 homeownership plan.

The plan has provisions requiring participants to do the following:

The buyer must have a down payment of at least 3% of the purchase price of which at least 1% must come from the family's own resources.

The buyer must secure financing that is provided, insured or guaranteed by the state or Federal government; comply with the secondary mortgage market underwriting requirements; or comply with generally accepted private sector underwriting standards.

COMMUNITY SERVICE REQUIREMENT PLAN

In accordance with HUD Notice PIH 2003-17, the Authority has reinstated the Community Service and Self-Sufficiency requirement. The top priority will be to involve the residents in 8 hours of self-sufficiency activities each month. In lieu of that, work assignments will be developed at the housing authority, volunteer community service, and other activities as defined in the QHWRA.

The authority has a memorandum of understanding with the Stark County Department of Job and Family Services.

Pet Rules and Regulations

POLICY

The Stark Metropolitan Housing Authority (SMHA) does comply with Federal regulations and will permit a common household pet in accordance with this policy. Common household pets as authorized by this policy means a domesticated animal such as a dog, cat, fish, birds, and rodents that are traditionally kept in the home for pleasure rather than commercial purposes. Any animals not permitted in residential units by state or local laws may not be kept by SMHA residents, including exotic or wild animal or snakes.

Residents of elderly or designated handicapped units are permitted small birds, caged animals, fish, cats, or dogs. Individuals with a documented disability requiring service animals, not residing in any of the above type units or not meeting other requirements (i.e. size/type of animal) must request specific modifications of this policy.

Residents who own pets under previous policies may continue to have the pets that they currently own. Any time that they request have a new pet, this request must be in compliance with the rule in effect at that time.

I. APPROVAL

A. Criteria

Request for permission to have a pet must be submitted prior to bringing a pet into the unit. The pet owner and the landlord (SMHA) must enter into a "Pet Agreement" (Appendix 2). In addition, the pet owner must provide proof of the pet's good health and suitability under the standards set forth in these rules and regulations. For dogs and cats, proof must be given (and renewed at the time of resident's re-examination) of the animal's licensing and vaccination record, etc. Cats and dogs must be neutered or spayed. Proof of spaying or neutering must also be submitted. If the pet being registered is under-age for spaying and neutering, proof that this procedure has been undertaken must be presented to the authority at a designated time. Cats are required to have front paws declawed. All licenses and tags must be current.

Prior to admittance of a pet into the facility, residents will be required to complete the following forms:

1. Pet Policy Certification (see Appendix 1)
2. Pet Agreement (see Appendix 2)
3. Veterinarian's Certification (see Appendix 3)

B. Vaccination Requirements

Dogs and cats must have the proper inoculations required by law, and certified by a veterinarian licensed to practice in the State of Ohio.

II. DEFINITIONS

A common household pet is a domesticated animal, including dog, cat, bird, fish or rodent such as a gerbil or hamster.

A “service animal” is an animal which has been trained and certified to provide services to an individual with a disability.

A service animal will be permitted once proper documentation is submitted. However, animal control and veterinary practices will still be enforced.

A “common area” is any area to which all residents have access, and is not under the direct control of any individual resident.

“Management” refers to any employee or representative of the Stark Metropolitan Housing Authority.

III. PET DENSITY

Only one of the following is acceptable.

- A. No more than one dog or one cat may be kept in any unit.
- B. No more than two, small caged birds may be kept in any unit.
- C. An aquarium for fish may not exceed twenty (20) gallons.
- D. NO more than two (2) small animals, i.e. mice, gerbil, or hamster or one guinea pig or one rabbit may be kept in any unit. Small animals must be kept in a cage. (Cage sizes outlined in Exhibit B).

IV. SIZE/BREEDS

Cats and dogs shall be limited to small breeds where adult height at the shoulder shall not exceed twelve (15) inches. The size limitations do not apply to service animals.

Pitbulls and rotweilers are prohibited. In all other cases, local ordinances will apply.



V. DAMAGES/PET DEPOSIT

- A. The resident is responsible for reasonable expenses incurred by Stark MHA as a result of damages directly attributable to the presence of the pet, including cleaning and related waste removal, the cost of repairs and replacements to the dwelling unit and fumigation of the dwelling unit. If the resident is in occupancy when such costs occur, the resident will be billed for such costs as a current charge. No deposit will be charged for service animals.
- B. A pet deposit of \$250 will be charged for each dwelling unit where a dog or cat resides. The deposit may be paid as a \$50 initial payment, with the remainder to be paid in agreed upon consecutive monthly payments until the \$250 is reached. SMHA reserves the right to change this deposit amount at any time, consistent with Federal guidelines.
- C. Resident's liability for damages caused by his/her pet is not limited to the amount of the pet deposit and the resident will be required to reimburse SMHA for the real cost of any and all damages by his/her pet where they exceed the amount of the pet deposit.
- D. Upon move-out, units occupied by a cat or dog will be inspected by the housing manager for any infestation or other damage resulting from the pet. If the unit is found to be infested, the extermination charge will be the responsibility of the pet owner. The pet deposit will be returned at any time the pet no longer resides in the unit, minus any charges for damage caused by the pet. The resident is permitted, and encouraged, to be present for any and all inspections.

VI. PET RULES

A. Dogs and Cats

- 1. Dogs will not be permitted at the following family housing developments:
 - Jackson-Sherrick
 - Sunset Homes
 - Linwood Acres
 - Mahoning Manor
 - Gage Gardens
 - Ellisdale Homes
 - Willow Homes
 - Underhill Homes
 - Franklin Homes
 - Neal Court
 - Leshdale
- 2. Dogs and cats shall be quartered within the resident pet owner's unit. When dogs or cats are outside of the unit, they must be kept on a leash no longer than six (6) feet and under control, led by a reasonable person at all times. Under no circumstances

shall any dog or cat be permitted to run loose in any common area. Dogs and cats will not be permitted to be quartered outside of the unit.

3. The unit must be kept free of odors and maintained in a clean and sanitary condition. All animal waste or litter from a cat litter box must be removed daily. Obnoxious odors can cause health problems and will not be tolerated.
 - a. Wastes must be placed in a plastic bag, tightly secured and deposited in a trash dumpster. Poorly disposed of waste will not be tolerated. At no time will pet waste be placed in trash chutes or in the unit.
 - b. Residents are not permitted to exercise their pet or permit their pet to excrete waste in interior common areas of the development premises.
4. Resident pet owners agree to be responsible for immediately cleaning up any waste, dirt, etc. caused by their pet in a common area. Resident pet owners shall also be responsible for immediately removing and properly disposing of any pet excreta, feces, urine, etc.
5. If management has to remove any pet waste, a twenty five-dollar (\$25) charge will be made. Repeated violations (three) will necessitate the owner removing the pet permanently from the premises. Failure to comply may result in termination of the resident's Dwelling Lease.
6. When a resident who owns a cat or dog calls in a work order, he/she must inform the work order clerk that he/she owns the pet. The resident is then responsible for securing the pet in the unit, before the staff will complete the work order.
7. SMHA and its staff are not responsible for any action, injuries or damages caused by any resident's pet. A pet is the sole responsibility and liability of the pet owner. ANY PET, WHICH CAUSES BODILY INJURY TO ANY RESIDENT, GUEST OR STAFF MEMBER, SHALL BE IMMEDIATELY REMOVED FROM THE PREMISES WITHOUT PRIOR NOTIFICATION. (POSSIBLY PERMANENTLY).
8. Resident pet owners agree to control the noise of their pet such that it does not constitute a nuisance to any residents. Failure to control pet noise may result in the removal of the pet from the premises.
9. No dog or cat shall be left unattended in any unit for longer than twelve (12) hours. All other animals shall not be left unattended for more than twenty-four (24) hours.
10. All resident pet owners shall provide adequate care, nutrition, exercise and medical attention for their pets. Pets which appear to be poorly cared for or which are left unattended for longer than limits indicated in #7 above will be reported to the appropriate authority and removed from the premises at the pet owner's expense.
11. The pet owner will submit to the development office the names, addresses and telephone number of two responsible parties (not at the same address) who will care

for the pet if the pet owner, for any reason, is unable to care for the pet. If the person is unable or unwilling to accept the responsibility, the pet owner authorizes management to contact state or local authorities to enter the apartment and remove the pet for a period not to exceed thirty (30) days. SMHA will not be responsible for the well being of the pet or any cost incurred during the thirty (30) day period. If there is no resolution regarding the care of the pet at the end of this period, the pet and the expenses incurred become the sole responsibility of the pet owner.

12. In the event of the death of the pet, it is agreed by the owner that management shall have discretion to dispose of the pet consistent with Federal guidelines if the main caretakers are unwilling to take responsibility, or if written instructions with respect to such disposal are not provided to the development office in advance by the resident. Cost of pet removal and subsequent fees will be charged to the resident. Under no circumstances are pets to be buried or disposed of on the premises or in trash containers or dumpsters.
 - a. Information regarding providers of pet disposal services is provided on Exhibit A.
13. Resident pet owners acknowledge that other residents may have chemical sensitivities or allergies related to pets and/or are easily frightened by such pets. The resident, therefore, agrees to exercise common sense and common courtesy with respect to the other residents' right to peaceful and quiet enjoyment of the premises. If using common laundry facilities, it is strongly recommended that the pet owner run an additional wash cycle and clean out all filters before leaving the wash room.
14. After proper written notification (Appendix 4), management may require the removal of the pet from the premises on a permanent or temporary basis for the following causes:
 - a. Excessive pet noise or odor after being advised by management.
 - b. Unruly or dangerous behavior.
 - c. Excessive damage of the resident's apartment.
 - d. Repeated problems with the pet or any infestations.
 - e. Failure of the resident to provide for adequate care of his/her pet.
 - f. Leaving a pet unattended for more than the allotted time period.
 - g. Failure of the resident to provide adequate and appropriate vaccination of the pet.
 - h. Tenant's death, serious illness and/or refusal or inability to care for the pet.

The resident will be given an additional notice to remove the pet that shall contain a brief statement defining the violation of the pet rules, a requirement that the resident must remove the pet within forty-eight (48) hours of the notice and a statement that failure to remove the pet will result in the initiation of termination of the lease agreement.

- 15. In the event of an emergency, the pet owner gives permission for the removal of the pet from the premises immediately for serious problems including, but not limited to, the following:
 - a. Pet becomes vicious.
 - b. Pet displays symptoms of serious illness.
 - c. Pet demonstrates other behavior that constitutes an immediate threat to the health and safety of a resident, guest, staff member or other authorized person.

- 16. Pets not owned by the resident are strictly prohibited with the exception of specially trained service animals that assist persons having a disability. These pets are not required to meet the limitations as to size or number. However, all other aspects of these rules and regulations will apply.

- 17. "Pet sitting" is not permitted for any pet not already within the same development.

- 18. Residents will not feed or water stray or wild animals.

B. Birds

- 1. Birds must be kept caged within the resident's unit at all times.

- 2. Cages must be cleaned not less than twice a week. Waste must be disposed of in sealed trash bags and placed in the trash dumpster. Litter cannot be flushed down the toilet.



C. Fish

- 1. The aquarium shall not exceed twenty (20) gallons and shall be placed on a management-approved stand in a safe location within the unit.



- 2. Water damage to walls, carpets, flooring or the ceiling of the unit below caused by breakage or spillage of or from the aquarium shall be the responsibility of the tenant who shall be billed for repair costs, as required.

D. Other Animals

1. Animals of the rodent family (i.e. mice, hamsters, gerbils or a guinea pig, or a rabbit) must be kept caged at all times.
2. Cages must be kept clean. A thorough cleaning, not less than twice a week is recommended.
3. Any other issues such as noise, odor and behavior apply the same as for dogs and cats.



VII. NOTIFICATION POLICY

In the event that any pet owner violates these pet rules, management shall provide written notice of such violations as follows (Appendix 4):

A. Creation of a Nuisance

The owner of any pet which creates a nuisance upon the grounds or causes excessive noise, odor or unruly behavior shall be notified of such nuisance in writing by management and shall be given five (5) calendar days to correct such nuisance. Failure to comply may result in requiring the removal of the pet and/or termination of the pet owner's Dwelling Lease.

B. Dangerous Behavior

1. Any pet which physically threatens a resident, guest, staff member or other authorized persons within or on the development grounds shall be considered dangerous. SMHA shall provide written notification to the pet owner of the dangerous behavior and the pet owner shall have five (5) calendar days to correct the animal's behavior. It is the responsibility of the pet owner to correct the violation. Failure to comply may result in the removal of the pet and/or termination of the pet owner's Dwelling Lease. If the resident disagrees, they may request a formal hearing in accordance with the SMHA Grievance Procedure.
2. Any pet which causes physical harm to any resident, guest or other authorized person present upon the development grounds shall be immediately removed from the premises by management with written notice.

VIII. INSPECTION POLICY

- A. Management is given permission to enter the pet owner's unit for the purpose of inspecting if a signed written complaint is received by management, or if

management feels conduct or condition of the pet or pet owner warrants same. The inspection will be made during reasonable hours, after proper notice has been given to the pet owner (48 hours' notice). In an emergency situation, entry will be made immediately. Notice will be given to the pet owner at such emergency entry, giving the reason for such entry.

B. PET RULES AND REGULATIONS

AFFIDAVIT

I have read and understand the Pet Rules and Regulations of the Stark Metropolitan Housing Authority and agree to comply fully with their provisions. I understand that failure to comply may constitute reason for removal of my pet. Where required by management to remove my pet from the premises, I agree to effect such removal and understand that my failure to do so constitutes grounds for eviction.

APPENDIX 2

Pet Agreement

The agreement entered into this ___ day of _____, 20___, by and between Stark Metropolitan Housing Authority and _____ (Resident). In consideration of their mutual promises, the parties agree as follows:

1. Resident desires and has received permission from SMHA to keep the pet named _____ and described as _____

2. This Agreement is an Addendum to and part of the Dwelling Lease between the SMHA and Resident, executed on _____, 20___. In the event of default by Resident of any of the terms of this Agreement and all succeeding leases, the resident agrees upon proper written notice of default from SMHA, to cure the default, remove the pet or vacate the premises. Resident agrees that SMHA may revoke the permission to keep said pet on the premises by giving Resident proper written notice.

3. As a special deposit for cats and dogs, Resident agrees to pay SMHA the sum of \$250, which shall be paid in an initial payment of \$_____ and _____ monthly payments of \$_____. When the resident vacates the property, SMHA may use this deposit as is reasonably necessary to take care of any damages or cleaning caused by or in connection with said pet. At the termination of this Agreement, any balance shall be refunded to the Resident within thirty (30) days. Resident agrees to pay SMHA for any damages caused by the pet in excess of this deposit and the security deposit on demand by SMHA. Damages, cleaning, etc. that occur while the resident lives in the unit will be billed as current charges.

4. Resident agrees to comply with:

- a. The Pet Policy
- b. All other applicable government laws and regulations such as, but not limited to, licensing, etc.

5. Resident represents that the pet is quiet and housebroken, and will not cause any damage or annoy other residents.

6. Resident agrees that the pet will not be permitted outside the Resident's unit unless restrained by a leash. Use of the grounds or premises of SMHA for sanitary purposes is prohibited.

7. Resident shall not permit the pet to cause any damage, discomfort, annoyance or nuisance, or in any way to inconvenience or cause complaints from any other resident. Any soiling created by the pet shall be immediately cleaned up by the Resident. If management has to remove any waste left by any pet, a twenty-five dollar (\$25) charge will be made. Repeated violations (three) will necessitate removal of the pet permanently from the premises for failure to comply and may result in termination of the Dwelling Lease.

8. Resident agrees to remedy any emergency situations involving their pet (e.g. attack by pet on staff members, another resident or a guest) immediately and any nuisance or dangerous behavior within five (5) days.

9. Resident will be financially responsible for any infestation of fleas or other insects that affects his/her own unit or any adjacent unit as a result of his/her pet.

10. Any pet left unattended for twelve (12) hours or more or whose health is jeopardized due to mistreatment or inappropriate care will be removed. The pet owner will be reported to the appropriately deemed authority to remove the pet at the expense of the Resident.

11. Resident agrees to maintain their pet in a healthy condition and to update the Veterinarian's Certification (Appendix 3) at the time of the annual re-examination.

12. Resident agrees that SMHA is in no way responsible nor liable for any action, injuries or damages caused by the resident's pet. A pet is the sole responsibility and liability of the pet owner. Nor is SMHA responsible for the safekeeping or well being of the pet.

13. Resident has read and agrees to comply with this Pet Policy and agrees to comply with any rules and regulations that may be reasonably adopted in the future.



PROGRESS REPORT

Planning area I – Increase the availability of decent, safe and affordable housing in the community

A. Create the capacity to develop and operate a range of housing programs.

The nonprofit, Freed Housing Corp. is fully established and operational. The development of a long-range plan is in process.

B. Develop 25 units of scattered site, rental properties for individuals and families

No activities have taken place regarding this objective. We are continuing to explore potential funding sources.

C. Develop 25 rental units for elderly persons

The housing authority, Freed Corp. and Lake Twp. Senior Center were funded to develop 28 units of elderly housing under the Section 202 Supportive Housing for the Elderly grant program. Construction began in Fall 2005 and was completed in December 2006, and the units are fully occupied. The housing authority completed construction of an additional 13 units of public housing at Constitution Hall in Louisville in the Fall of 2005 and the units are fully occupied. This is a total of 41 units for elderly persons, which exceeds the goal of 25 units. The housing authority and Freed Corp. are in discussion with the City of Alliance to explore the possibility of applying for Section 202 funds for a property in the city.

D. Create 25 units for homeownership

The housing authority in conjunction with its non-profit affiliate and local governments continues to use HOME funds and the HUD \$1 house program to develop units for affordable homeownership. Thirteen total homes have been developed, two during the past year. There are 9 planned for the upcoming year.

There have also been 19 families that used their Section 8 Housing Choice Voucher for the purchase of a home.

E. Complete construction of projects that are already funded

The 13 units of public housing at Constitution Hall in Louisville, Ohio were completed in November 2005. Construction of 28 units of assisted housing in Lake Township under the Section 202 Supportive Housing for the Elderly program was completed in December 2006.

F. Participate in the revitalization of neighborhoods in the county's urban centers

The Freed Housing Corporation (FHC) has received HOME funds from the City of Canton to participate in the revitalization of the Summit neighborhood in Canton. This project is on going. Freed Housing submitted an application for HOME funds with the City of Canton to participate in their general neighborhood revitalization program, but was not selected. FHC will continue to pursue these types of opportunities as they become available.

G. Obtain rental assistance for 10 homeless households and/or persons with disabilities

The housing authority director has participated with the formation and the strategic planning strategy for the Stark County Interagency Council on Homelessness. We continue to renew funds and administer programs through the continuum of care process. The Freed Housing Corp and the housing authority made application for 12 units of Shelter Plus Care funding to be used at the Hillview Apartments. The funding announcements for 2007 have not been made to date. The Freed Housing Corp. is also participating in the housing institute sponsored by the Corporation for Supportive Housing and will be applying for funding to do a mixed finance development for the homeless.

H. Preserve other affordable housing in the community

No initiatives have taken place in this area. We continue to improve the condition and management of Washington Town Homes and Hillview Apartments that were acquired previously.

Planning area II – Ensure Equal Opportunity in Housing for All Americans

A. increase public and corporate awareness

The Executive Director and Deputy Director will assume the responsibility of public relations and public information activities. Time is allotted to participate in events and activities that increase interaction with community leaders. A positive relationship has been established with the press that has resulted in coverage of major projects.

B. 10% Increase in use of Tenant Based Assistance in areas where incomes are above 50% of median

The Section 8 Director has taken steps to increase occupancy in nontraditional, higher income areas.

C. Deconcentration in public housing developments

The authority has completed its assessment and is implementing policies to correct deficiencies. Due to economic trends in the community and the composition of the SMHA waiting list, we have not reached this goal to date. In addition, higher income residents have been successful in moving to the private market and in purchasing homes.

Planning Area III – Promote Self Sufficiency and asset development of families and individuals

A. Increase the number of employed residents by 10%

The tenant selection policies that support education and work have been implemented. The authority was successful in applying for additional funding from the ROSS grant to continue the REAP program. The community service requirement plan has been revised and implemented.

C. Participation in an IDA program

Members of the community services staff have had several meetings with potential sponsors of an IDA program to explore the possibility of beginning a program.

D. Increase the capacity of the SMHA Credit Union

The membership at the credit union continues to grow. The credit union board developed a strategic plan to promote growth, self- sufficiency and improved service. They are in the process of implementing the strategies identified in the plan.

Planning Area IV – Improve the quality of life and economic viability

A. Improve physical condition of SMHA units

The physical assessment of the units is ongoing. The responsibility for the annual inspection of units has been assigned to the Property Managers under the project based accounting model. The application submitted by the housing authority to participate in the Capital Fund Finance Program and secure bonds for work needed at Plaza Terrace, Hart Apartments and Lincoln Apartments was approved and the bonds were sold. Bids are being solicited for this work. The application for the disposition of the property on Mahoning Rd. N.E., and Guy Mack Homes was approved and the properties were given to ABLE, INC, a non-profit that works with homeless youth.

B. Increase level of elderly satisfaction

The revision to the Admissions and Occupancy Policy for the preference for those 50 and over was implemented. Currently, 82% of the occupants in the high rises are 50 years old or older. The authority was funded for the ROSS Elderly grant and the program has been implemented. The funding for the work at Plaza Terrace, Hart Apartments and Lincoln Apartments has been secured and bids are being solicited to select a contractor.

C. Improve/enhance security at SMHA developments

Lack of resources has limited progress on this goal. The off-duty police patrols in the Canton and Massillon areas are ongoing. Communication continues to be good with local police departments. With the retirement of several staff, the security staff was restructured to include three part-time officers and three full-time officers. Resident meetings were conducted at several of the sites to discuss security issues, to request that residents assist in the effort and to discuss the development of crime watch programs. Whenever possible, staff has worked with other groups in their areas as well to address security and safety.

D. Increase the economic viability of SMHA

Policies to promote resident employment and training are in place. The collection of debts owed by previous residents has improved. A minimum rent was implemented for the public housing program. The asset based management and project based accounting model was implemented beginning April 2007 and should impact the use of resources.

E. Improve Employee Performance

Staff training is ongoing. This past year training has been conducted on project based accounting, Section 8 voucher program, customer awareness, supervisor training, and safety training. Staff has also attended various conferences and training sessions. The quality control program was successful in improving compliance with HUD regulations and is on-going. The employee handbook was revised and implemented in 2006. Implementation of the project based management model has improved accountability at the various sites.

F. Develop the Canton Senior Center

Steps were taken to secure the necessary funding for this project and construction was completed in June of 2007. The tenant spaces for the medical clinic, the adult day care and the restaurant are still in various stages of development. In the upcoming year, the space will be fully occupied and programs and activities will be scheduled for the senior residents.

G. Develop other community centers

No additional work has been completed for this goal.

VOLUNTARY CONVERSION ASSESSMENT

As per the requirements set forth in Voluntary Conversion of Developments, 24 CFR Part 972, Final Rule 6-22-01, Stark MHA is required to certify, based upon review, whether the conversion of PHA developments from site-based assistance to tenant-based assistance is an appropriate action for the authority to take. The authority has done an assessment of all of our properties by reviewing occupancy rates, appraised values and PHAS scores for physical inspections. Based upon this information, Stark MHA certifies that none of our public housing properties are appropriate for conversion at this time.

SECTION 8 PHA PROJECT- BASED VOUCHERS

The Stark MHA solicited proposals in 2002 with the intention of project-basing a total of fifty (50) vouchers. SMHA received 3 proposals and we were prepared to implement all of them. However, all three locations were in high poverty areas and required waivers before they could be implemented. One of the three nonprofits applied for the waiver and the request was denied. We are currently at full occupancy on the voucher program. We will not be soliciting any proposals this year.

VIOLENCE AGAINST WOMEN ACT (VAWA)

The Stark Metropolitan Housing Authority has traditionally had policies that mirrored the underlying premises of the VAWA. Even so, the agency has taken the following steps to implement the requirements:

- The processes to revise the Section 8 Administrative plan and the Public Housing Admissions and Continued Occupancy Plan have been initiated.
- Internal forms have been developed to certify the status of victims for use until HUD issues a form.
- Residents of all programs will receive notification of the law at their annual recertification and they will be asked to sign to verify receipt of the information.
- All Section 8 landlords have been sent written notification regarding the law. It was also discussed at the annual landlord meeting by a local attorney from Legal Aid.
- Staff has knowledge of available programs in the community and will continue to make referrals.
- One of the housing authority staff serves on the Stark County Domestic Violence Collaborative

During the plan year, Stark MHA will conduct staff training to educate staff about making referrals for services for victims. Several educational programs and the distribution of information will also be completed to educate residents regarding this issue.
