## **Attachment #A**

### **Violence Against Women Act adopted into Policy Evictions**

Serious or repeated violations by a resident family of the material provisions of the Lease shall cause the Authority to begin eviction proceedings in accordance with State Law and lease provisions. Families are entitled to utilize provisions of the Authority's Grievance Procedure to attempt settlement of disputes with the Authority. In cases where an eviction is a result of domestic violence only the resident causing the violence may be evicted if the victim follows the procedure below.

Under the Violence Against Women Act the Authority may request that the affected victim complete, sign and submit, within 14 business days of the request the HUD 50066 certification form. If the individual does not produce the form of the information the may provided in lieu of the certification by the 14th business day or any extension of that date provided by the Authority, none of the protections afforded to victims of domestic violence, dating violence or staling will apply. The Authority would therefore be free to evict in the circumstances authorized by otherwise applicable law and lease provisions.
