Attachment "A"

VAWA Policy

The Wewoka Housing Authority has a service agreement with the Family Resource Center of Seminole County for the victims of domestic violence and sexual assault. They have, in place, a 24 hour crisis line for victims or WHA referrals. This center provides counseling, temporary shelter (if needed) and referrals for outreach not provided in house.

To allow victims to maintain housing, the WHA's plan states that an owner or manager may bifurcate a lease to terminate assistance to any resident who engages in physical violence against family members or others without penalizing or removing a victim who is also a tenant.

To prevent future abuse, the victim can either receive a new voucher (if a section 8 resident) or a transfer (public housing) within or out of the jurisdiction. The WHA will also enforce trespass against a perpetrator under this policy.

All applicants with the WHA are notified of the VAWA policy during briefing for occupancy. This policy is also on display in the lobby of the WHA M&M Building.
