Through a combination of strong work ethic, innovation and experience, our staff will provide quality services and comprehensive solutions that are reliable, diverse and cost effective. We pledge to promote economic opportunities and safe, decent living environments for all residents free from discrimination.

Continue full utilization of voucher funding and seeking of property in non-poverty areas for Section 8 participants. Training opportunities for managers in asset management and maintenance staff. Continue cooperation with the City in its efforts to revitalize downtown area as it relates and enhances the quality of life for our residents. Continue to explore possibilities for location of public housing units in demographic areas to accomplish deconcentration. Look for grants and funding opportunities that would assist residents toward self-sufficiency. Continue reconfiguration of units through modernization to provide for more availability of one and two bedroom units – reconfigure at least 80 apartments

As a requirement in the Violence Against Women and Justice Department Reauthorization Act, The PCHA provides for notification to applicants and residents of public housing and housing choice voucher of the protection for victims of abuse. The PCHA has partnered with the Crisis Center of Russell County to assist victims in obtaining housing through providing documentation of domestic violence as a source of funding for utility deposits. The Crisis Center provides brochures and programs with the project managers and residents to discuss the help available through the Center. PCHA is sensitive to the possible violence that could occur if a victim's assailant finds where the victim lives. The 30 day notice prior to transfer is waived and owners of property on the housing choice voucher program is apprised of the problem and requested to waive the notice of transfer. Based on information provided by the Alabama Consolidated Plan and HUD data, the need for affordable housing is growing. Not only the elderly and disabled, but families with low or no income due to massive job losses in the current economy have a need for affordable housing. The supply of affordable, decent housing is decreasing. The need for one and two bedroom apartments in Phenix City is 100% greater than three and four bedroom apartments as evidenced by our waiting lists. The PCHA has no available one and two bedroom public housing units with twenty applicants for one bedroom and forty-six applicants for two bedroom on the waiting lists. Section 8 has closed its waiting list and anticipates it will not be open for at least six to nine months. All current funding is being utilized as well as the restricted reserves. Funding constraints prevent issuance of additional vouchers. When funding is available though budget increase or HAP decrease, vouchers will be issued through lottery system.
9.1	Strategy for Addressing Housing Needs. Provide a brief description of the PHA's strategy for addressing the housing needs of families in the jurisdiction and on the waiting list in the upcoming year. Note: Small, Section 8 only, and High Performing PHAs complete only for Annual Plan submission with the 5-Year Plan. PCHA now maintains site-based waiting lists. This decision was made to decrease the turnaround time for rental of apartments. Applications are processed more rapidly and applicants next on the waiting list are notified in a more timely fashion when vacancy maintenance is complete. Managers meet bi-weekly to discuss housing needs relative to bedroom sizes needed and problem areas. PCHA will continue to perform modernization through reconfiguration of apartments to provide the one and two bedroom units for the needs of the community. Section 8 program will continue to analyze comparables on an annual basis. Property owner meetings will continue on a quarterly basis to inform and explain the benefits of the voucher program and discuss payment standards and fair market rents.

The PCHA has been able to maintain its mission to promote adequate and affordable housing through utilization of Capital Funds, participation in the housing authority bond issue and proper application of housing policies. Some goals over the past 5 years were to: increase occupancy, acquire units through replacement housing, adequately utilize Section 8 housing choice vouchers increasing the number of voucher participants, improve turnaround time in public housing and partnership with local college and bring 60+ year old apartments into more market standards including better parking, interior renovations and curb appeal. Progress toward these goals are; overall vacancy rate of the Authority 5 years ago was approximately 12 to 13% with one development with a 16% vacancy and another with a 24% vacancy rate. Currently, occupancy rate is consistently 98 to 99%. Development with 16% vacancy rate averages 3% and development with 24% vacancy rate averages 2%. 70 units were sold to City for construction of Troy University campus and 76 units were purchased with proceeds for replacement housing. The Section 8 program has gone from underutilization of funds and average of 575 voucher participants to full utilization of funds and average of 675 voucher participants. Turnaround time in public housing decreased in past two years from 82.5 days to 47 days. Over past 5 years completed modernization on over 100 apartments adding convenient parking, washer/dryer connections and central heating and air. Apartments total electric thus decreasing utility bills, added landscaping and exterior renovations to alleviate the look of the projects. Success of these changes are reflected in 100% occupancy and positive comments from both residents and community. Through partnership with Troy University, after-school program is very successful. Our goal is to have educated, well-prepared children who will get college educations and job ready. (b) Significant Amendment and Substantial Deviation/Modification.
