



RESOLUTION NO. PHA 2009-006

A RESOLUTION OF THE PUBLIC HOUSING AUTHORITY OF THE CITY OF HAWAIIAN GARDENS (PHA), COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, CERTIFYING THAT THE PHA WILL IMPLEMENT THE PUBLIC HOUSING PROGRAM OF THE AGENCY IN CONFORMITY WITH TITLE VI OF THE CIVIL RIGHTS ACT OF 1964, THE FAIR HOUSING ACT, SECTION 504 OF THE REHABILITATION ACT OF 1973, AND TITLE II OF THE AMERICANS WITH DISABILITIES ACT OF 1990, AND WILL AFFIRMATIVELY FURTHER FAIR HOUSING.

WHEREAS, the PHA is required by Section 511 of the Quality Housing and Work Responsibility Act of 1998 (QHWRA) to prepare the Public Housing Agency Five Year Plan and Annual Plan; and

WHEREAS, the Annual Plan provides information about the PHA's operation, policies, and resources to provide housing assistance to low income families for the upcoming year; and

WHEREAS, the Five Year Plan describes the PHA mission, long term goals and strategy for accomplishing those goals; and

WHEREAS, the PHA is exempt from the requirement to prepare and submit an annual PHA Plan in accordance with Section 2701 and 2702 of Title VII, the Small Public Housing Authorities Paperwork Reduction Act; and

WHEREAS, qualified PHA's shall on an annual basis in accordance with section 5A(b)(3)(B) of the Act, as amended by section 2702 of the Housing and Economic Recovery Act (HERA), certify that the PHA will implement the public housing program of the agency in conformity with title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and the Title II of the Americans with Disabilities Act of 1990, and will affirmatively further fair housing.


NOW, THEREFORE, BE IT RESOLVED by the City of Hawaiian Gardens Public Housing Authority as follows:
