Include a report on the progress the PHA has made in meeting the goals and objectives described in the previous 5-Year Plan.</p> <p><b>Goals and Objectives for FY 2010 – 2014</b></p> <p><i>Goal: Increase availability of decent, safe and affordable housing.</i> HRA will apply for additional Section 8 vouchers as they become available from HUD. Through its non-profit entity, RDI, it will seek financial resources for the development of 20 rental units. HRA will project-base another 75 units of rental housing for vulnerable populations and for families. The Authority will continue its outreach efforts by means of quarterly meetings for rental property owners, service providers, advocates and state agencies, and will expand these efforts by responding to requests for in-service training on an as needed basis. HRA will continue its program administration in a manner that will ensure on-going high performing status.</p> <p><i>Goal: Improve community quality of life and economic vitality.</i> HRA, through RDI, will seek financial resources to develop 20 units of housing for vulnerable populations such as elderly persons, disrupted families, veterans, and youth aging out of foster care.</p> <p><i>Goal: Promote self-sufficiency and asset development of families and individuals.</i> HRA will continue to promote self-sufficiency and asset development of families and individuals through the implementation of the Family Self-Sufficiency and Section 8 Homeownership programs. HRA will also encourage prospective Section 8 homebuyers to consider the purchase zero net energy homes in order to maximize income.</p> <p><i>Goal: Ensure Equal Opportunity in Housing for all Americans.</i> HRA will continue to operate its tenant and project-based programs in full compliance with all equal opportunity laws and regulations. It will review its policies on a quarterly basis to determine if they ensure equal opportunity and affirmatively further fair housing.</p> <p><b>Progress Report on 5-Year Plan, FY 2005 – 2009</b> HRA has met all the goals and objectives described in its 5-Year Plan for 2005 – 2009.</p> <p><i>Goal: Increase availability of decent, safe and affordable housing.</i></p> <p>*HRA applied for additional Section 8 vouchers that were offered in annual HUD NOFAs. HRA applied for 130 fair share vouchers (57 received), 75 mainstream vouchers for people with disabilities, and 26 Reallocation vouchers in 2002. In 2003 HRA applied for 50 mainstream vouchers for people with disabilities, and applied again for 20 Mainstream Disability Vouchers in 2005. In 2009 HRA applied for 50 Family Unification Program Vouchers</p> <p>*HRA’s non-profit entity, Rural Development, Inc. (RDI), is a nationally recognized developer of over 100 units of affordable green housing for homeowners. RDI has also developed more than 128 units of rental housing, including supportive housing for persons with substance abuse issues.</p> <p>*HRA implemented a Project-Based Assistance Program in 2007. Thirty-two project-based vouchers are currently being utilized by individual tenants who have been homeless, who are aging out of the foster care system, who are dealing with mental health or substance abuse issues, or by families. An application has been forwarded to HUD requesting the project-basing of two units for persons with disabilities in a new project in Greenfield, MA, called the Wisdom Way Solar Village.</p> <p>*To expand its outreach efforts, HRA has worked very closely with area landlords, Housing Consumer Education Centers, social service agencies, advocacy groups and state agencies. As a part of this outreach, all parties were invited to attend quarterly informational meetings at which HRA presented new regulations, updates to current HUD regulations, the Violence against Women Act (VAWA), the Limited English Proficiency Act (LEP), Reasonable Accommodation requirements, and information on rights for families with disabilities.</p> <p>*The HRA regularly monitored all rental market areas within its jurisdiction and utilized the 110% of the FMR in Franklin County and in all other towns in its area. HRA’s utility allowance charts were continually monitored and changes were made when a utility had a change of 10% or more or at least annually as required by HUD. The Authority’s successful efforts to ensure equal opportunity for housing assistance are documented by our program participants’ lease ups throughout all of the towns of Franklin County, Athol, and Amherst. The HRA has been able to achieve and sustain a high performer rating on the annual SEMAP assessment. To date HRA has a 100% lease-up rating, a 100% reporting rate in PIC, and 104% expenditure rate for our ABA. EIV is accessed to verify clients’ incomes on all annual re-certifications and interim changes. The Authority briefed new applicants on a regular basis and offered on-going mobility and program counseling options.</p> <p><i>Goal: Improve community quality of life and economic vitality.</i> Through its non-profit entity Rural Development, Inc., HRA has developed 128 units of rental housing including units for persons with substance abuse issues, for youth aging out of the foster care system, sober housing units for single individuals, and family units.</p> <p><i>Goal: Promote self-sufficiency and asset development of families and individuals.</i> HRA promoted self-sufficiency and asset development through its FSS and Section 8 to Home Ownership programs, which are joint efforts of the Greenfield Housing Authority (GHA) and the HRA. The HRA FSS program participation grew from an initial allocation of 10 mandatory vouchers to a current participation by 50 clients with voluntary vouchers. Due to the success of the FSS program, the HRA joined the GHA in 2002 and formed a Section 8 to Homeownership program that is currently being offered to all FSS participants. To date nine closings have taken place.</p> <p><i>Goal: Ensure Equal Opportunity in Housing for all Americans.</i> HRA operates its tenant and project-based programs in full compliance with all equal opportunity laws and regulations. HRA’s Fair Housing Coordinator, who also works with Spanish-speaking applicants, coordinates the agency’s Fair Housing Committee that regularly reviews HRA’s policies to determine if they continue to ensure equal opportunity and affirmatively further fair housing.</p>

The identification of housing needs must address issues of affordability, supply, quality, accessibility, size of units, and location.</p> <p>The FY 2005 - 2009 Massachusetts Consolidated Plan identifies five housing-related challenges across the Commonwealth. Even though the state provides among the highest levels of housing assistance in the nation, high housing costs present a major barrier for both renters and owners alike. The five challenges include: the need for physical adaptations to homes and/or supportive services to live independently, an aged housing inventory that is costly to maintain and operate, high fuel costs, an aging public housing stock in need of investment for preservation, and reduced state resources. More than 550,000 extremely low and very low income households are paying a disproportionate amount of income for housing and/or are living in overcrowded or substandard conditions. Seventy-three percent of these households are renters. All regions across the state identified affordable housing, housing rehabilitation and preservation, and public infrastructure improvements as priorities during the Consolidated Planning process. Housing that is affordable and accessible to populations with special needs is inadequate. Finally, there is an especially acute need for moderately priced rental housing, and homeownership opportunities in a range of prices.</p> <p>In 2008 the Commonwealth commissioned a study to assess the current housing market and to project the likely demand for housing and unit production from 2008 through 2012. The study concluded that while Massachusetts outpaces the nation in the number of tenant subsidies it provides, the state's housing safety net has not met the need for housing assistance in a difficult environment. Statewide annual housing shortages have been in evidence since 2000. Current and projected slowdowns in building will likely lead to continued housing shortages through 2012. Even in regions of net housing surpluses, affordability problems indicate that surplus housing may be poorly matched to the needs of the region's householders. Stagnant income growth and continued supply shortfalls are likely to largely offset the affordability benefits of declining prices statewide.</p>

With respect to public housing projects owned, assisted, or operated by the public housing agency, a plan describing the capital improvements necessary to ensure long-term physical and social viability of the projects must be completed along with the required forms. Items identified in 8.1 through 8.3, must be signed where directed and transmitted electronically along with the PHA's Annual Plan submission.

**8.1 Capital Fund Program Annual Statement/Performance and Evaluation Report.** PHAs must complete the *Capital Fund Program Annual Statement/Performance and Evaluation Report* (form HUD-50075.1), for each Capital Fund Program (CFP) to be undertaken with the current year's CFP funds or with CFFP proceeds. Additionally, the form shall be used for the following purposes:

- (a) To submit the initial budget for a new grant or CFFP;
- (b) To report on the Performance and Evaluation Report progress on any open grants previously funded or CFFP; and
- (c) To record a budget revision on a previously approved open grant or CFFP, e.g., additions or deletions of work items, modification of budgeted amounts that have been undertaken since the submission of the last Annual Plan. The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

**8.2 Capital Fund Program Five-Year Action Plan**

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

**8.3 Capital Fund Financing Program (CFFP).** Separate, written HUD approval is required if the PHA proposes to pledge any

portion of its CFP/RHF funds to repay debt incurred to finance capital improvements. The PHA must identify in its Annual and 5-year capital plans the amount of the annual payments required to service the debt. The PHA must also submit an annual statement detailing the use of the CFFP proceeds. See guidance on HUD's website at:

**9.0 Housing Needs.** Provide a statement of the housing needs of families residing in the jurisdiction served by the PHA and the means by which the PHA intends, to the maximum extent practicable, to address those needs. **(Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).**

**9.1 Strategy for Addressing Housing Needs.** Provide a description of the PHA's strategy for addressing the housing needs of families in the jurisdiction and on the waiting list in the upcoming year. **(Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).**

**10.0 Additional Information.** Describe the following, as well as any additional information requested by HUD:

- (a) **Progress in Meeting Mission and Goals.** PHAs must include (i) a statement of the PHAs progress in meeting the mission and goals described in the 5-Year Plan; (ii) the basic criteria the PHA will use for determining a significant amendment from its 5-year Plan; and a significant amendment or modification to its 5-Year Plan and Annual Plan. **(Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).**
- (b) **Significant Amendment and Substantial Deviation/Modification.** PHA must provide the definition of "significant amendment" and "substantial deviation/modification". **(Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan.)**

- (c) PHAs must include or reference any applicable memorandum of agreement with HUD or any plan to improve performance. **(Note: Standard and Troubled PHAs complete annually).**

**11.0 Required Submission for HUD Field Office Review.** In order to be a complete package, PHAs must submit items (a) through (g), with signature by mail or electronically with scanned signatures. Items (h) and (i) shall be submitted electronically as an attachment to the PHA Plan.

- (d) Form SF-LLL, *Disclosure of Lobbying Activities (PHAs receiving CFP grants only)*
- (e) Form SF-LLL-A, *Disclosure of Lobbying Activities Continuation Sheet (PHAs receiving CFP grants only)*
- (f) Resident Advisory Board (RAB) comments.
- (g) Challenged Elements. Include any element(s) of the PHA Plan that is challenged.
- (h) Form HUD-50075.1, *Capital Fund Program Annual Statement/Performance and Evaluation Report (Must be attached electronically for PHAs receiving CFP grants only)*. See instructions in 8.1.
- (i) Form HUD-50075.2, *Capital Fund Program Five-Year Action Plan (Must be attached electronically for PHAs receiving CFP grants only)*. See instructions in 8.2.

1. The Plan is consistent with the applicable comprehensive housing affordability strategy (or any plan incorporating such strategy) for the jurisdiction in which the PHA is located.
2. The Plan contains a certification by the appropriate State or local officials that the Plan is consistent with the applicable Consolidated Plan, which includes a certification that requires the preparation of an Analysis of Impediments to Fair Housing Choice, for the PHA's jurisdiction and a description of the manner in which the PHA Plan is consistent with the applicable Consolidated Plan.
3. The PHA certifies that there has been no change, significant or otherwise, to the Capital Fund Program (and Capital Fund Program/Replacement Housing Factor) Annual Statement(s), since submission of its last approved Annual Plan. The Capital Fund Program Annual Statement/Annual Statement/Performance and Evaluation Report must be submitted annually even if there is no change.
4. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
6. The PHA certifies that it will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
7. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
8. For PHA Plan that includes a policy for site based waiting lists:
  - The PHA regularly submits required data to HUD's 50058 PIC/IMS Module in an accurate, complete and timely manner (as specified in PIH Notice 2006-24);
  - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
  - Adoption of site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
  - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;
  - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(c)(1).
9. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
10. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
11. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.


12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.
13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments), 2 CFR Part 225, and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments).
19. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
20. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.
21. The PHA provides assurance as part of this certification that:
  - (i) The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;
  - (ii) The changes were duly approved by the PHA Board of Directors (or similar governing body); and
  - (iii) The revised policies and programs are available for review and inspection, at the principal office of the PHA during normal business hours.
22. The PHA certifies that it is in compliance with all applicable Federal statutory and regulatory requirements.
