ii. Executive Summary of the Annual PHA Plan

Luna Pier Housing Commission continues to improve the quality, safety and affordability of our housing complex. 2009 will see our complex go through a metamorphosis as we make several major infrastructure improvements. We will be completely refurbishing the upper levels of our two (2) senior/disabled buildings, making parking lot improvements and replacing windows and doors in our family townhouses. These improvements are possible as a result of being awarded Emergency and Stimulus Funds. In addition we will be implementing energy conservation through out the complex by installing water conservative shower heads and toilets in all units. We have contracted for an Energy Audit and plan to apply for funding from the Energy Conservation Competitive Grants Program that will be available to PHA's. We also will begin planning to bring suitable and appropriate housing for the disabled to our family environment. Currently we have zero facilities for the disabled in our family units. Our director and maintenance staff will be attending the Emergency Preparedness Workshop offered by HUD and will secure a plan for LPHC before the end of the fiscal year. We continue to work on improving our internal policies for improvement and our financial accountability continued to improve. We have many processes in place to assure that all funds are responsibility allocated and that repairs are prioritized. All Stimulus and Emergency funds will be accounted for as separate entities within our financial records.

Accessible Units: Accessible units will be first offered to families who may benefit from the accessible features who reside in the development that has the vacancy. If there are no families residing in that development needing the accessible unit, it shall then be offered to families residing in other

developments who may benefit from the accessible unit. If there are no families residing in the other developments needing the accessible unit, it shall then be offered to applicants on the waiting list who may benefit from the accessible features. Applicants for these units will be selected utilizing the same preference system as outlined above.

If there are no applicants who would benefit from the accessible features, the units will be offered to other applicants in the order that their names come to the top of the waiting list. Such applicants, however, will be requested to sign a lease rider stating they will accept a transfer (at the Housing Authority's expense) if, at a future time, a family requiring an accessible feature applies or a family requires a transfer from a non-accessible unit. Any family required to transfer will be given a 30-day notice.

1.0 FAIR HOUSING

The following is an extract from our adopted Admissions and Continued Occupancy Policy.

The application process will involve two phases. The first phase is the initial application for housing assistance or the pre-application. The pre-application requires the family to provide limited basic information establishing any preferences to which they may be entitled. This first phase results in the family's placement on the waiting list.

Upon receipt of the family's pre-application, the Luna Pier Housing Commission will make a preliminary determination of eligibility. The Luna Pier Housing Commission will notify the family in writing of the date and time of placement on the waiting list, and the approximate wait before housing may be offered. If the Luna Pier Housing Commission determines the family to be ineligible, the notice will state the reasons therefore and will offer the family the opportunity of an informal review of the determination.

The applicant may at any time report changes in their applicant status including changes in family composition, income, or preference factors. The Luna Pier Housing Commission will annotate the applicant's file and will update their place on the waiting list. Confirmation of the changes will be confirmed with the family in writing.

The second phase is the final determination of eligibility, referred to as the full application. The full application takes place when the family nears the top of the waiting list. The Luna Pier Housing Commission will ensure that verification of all preferences, eligibility, suitability and selection factors are current in order to determine the family's final eligibility for admission into the Public Housing Program.

8.3 Suitability

- A. Applicant families will be evaluated to determine whether, based on their recent behavior, such behavior could reasonably be expected to result in compliance with the public housing lease. The Luna Pier Housing Commission will look at past conduct as an indicator of future conduct. Emphasis will be placed on whether a family's admission could reasonably be expected to have a detrimental effect on the development environment, other tenants, Luna Pier Housing Commission employees, or other people residing in the immediate vicinity of the property. Otherwise eligible families will be denied admission if they fail to meet the suitability criteria.
- B. The Luna Pier Housing Commission will consider objective and reasonable aspects of the family's background, including the following:
 - 1. History of meeting financial obligations, especially rent and any utility payments;
 - 2. Ability to maintain (or with assistance would have the ability to maintain) their housing in a decent and safe condition based on living or housekeeping habits and whether such habits could adversely affect the health, safety, or welfare of other tenants;
 - 3. History of criminal activity by any household member involving crimes of physical violence against persons or property and any other criminal activity including drug-related criminal activity that would adversely affect the health, safety, or well being of other tenants or staff or cause damage to the property;

4. History of disturbing neighbors or destruction of property;
 5. Having committed fraud in connection with any Federal housing assistance program, including the intentional misrepresentation of information related to their housing application or benefits derived there from; and
 6. History of abusing alcohol in a way that may interfere with the health, safety, or right to peaceful enjoyment by others.
 7. History if abuse behavior (physical or verbal) to neighbors, or former landlords.
- C. The Luna Pier Housing Commission will ask applicants to provide information demonstrating their ability to comply with the essential elements of the lease. The Luna Pier Housing Commission will verify the information provided. Such verification may include but may not be limited to the following:
1. A credit check of the head, spouse, co-head, and any other adult family members;
 2. A rental history check of all adult family members;
 3. A criminal background check on all adult household members, including live-in aides at no cost to the applicant. This check will be made through State or local law enforcement or court records in those cases where the household member has lived in the local jurisdiction for the last three years. Where the individual has lived outside the local area, the Luna Pier Housing Commission may contact law enforcement agencies where the individual had lived or request a check through the FBI's National Crime Information Center (NCIC). This criminal background check will proceed after each adult household member has signed a consent form designed by the Luna Pier Housing Commission.

The information received as a result of the criminal background check shall be used solely for screening, lease enforcement and eviction purposes. The information derived from the criminal background check shall be shared only with employees of the Luna Pier Housing Commission who have a job-related need to have access to the information. The information shall be maintained confidentially, not misused or improperly disseminated, and destroyed once the purpose(s) for which it was requested has been accomplished and the period for filing a challenge to the Luna Pier Housing Commission's action has expired without a challenge or final disposition of any litigation has occurred;

4. A home visit. The home visit provides the opportunity for the family to demonstrate their ability to maintain their home in a safe and sanitary manner. This inspection considers cleanliness and care of rooms, appliances, and appurtenances. The inspection may also consider any evidence of criminal activity; and
5. A check of the State's lifetime sex offender registration program for each adult household member, including live-in aides. No household with an individual registered under a State sex offender registration will be admitted to public housing. The Luna Pier Housing Commission will check with our State registry and if the applicant has resided in another State(s), with that State(s)'s list.

If an applicant is about to be denied housing based on either the criminal check or the sex offender registration program, the applicant will be informed of this fact and given an opportunity to dispute the accuracy of the information before the denial or eviction occurs.

16.0 Unit Transfers

16.1 Objectives of the Transfer Policy

The objectives of the Transfer Policy include the following:

- A. To address emergency situations.
- B. To fully utilize available housing resources while avoiding overcrowding by ensuring that each family occupies the appropriate size unit.
- C. To facilitate a relocation when required for modernization or other management purposes.
- D. To facilitate relocation of families with inadequate housing accommodations.
- E. To eliminate vacancy loss and other expenses due to unnecessary transfers.

16.2 Categories of Transfers

Category A: Emergency transfers. These transfers are necessary when conditions pose an immediate threat to the life, health, or safety of a family or one of its members. Such situations may involve defects of the unit or the building in which it is located, the health condition of a family member, a hate crime, the safety of witnesses to a crime, or a law enforcement matter particular to the neighborhood.

Category B: Immediate administrative transfers. These transfers are necessary in order to permit a family needing accessible features to move to a unit with such a feature or to enable modernization, revitalization, disposition or demolition work to proceed.

Category C: Regular administrative transfers. These transfers are made to offer incentives to families willing to help meet certain Luna Pier Housing Commission occupancy goals, to correct occupancy standards where the unit size is inappropriate for the size and composition of the family, to allow for non-emergency but medically advisable transfers, and other transfers approved by the Luna Pier Housing Commission when a transfer is the only or best way of solving a serious problem.

16.3 Documentation

When the transfer is at the request of the family, the family may be required to provide third party verification of the need for the transfer.

16.4 Processing Transfers

Transfers on the waiting list will be sorted by the above categories and within each category by date and time.

Transfers in category A and B will be housed ahead of any other families, including those on the applicant waiting list. Transfers in category A will be housed ahead of transfers in category B.

Transfers in category C will be housed along with applicants for admission.

Upon offer and acceptance of a unit, the family will execute all lease up documents and pay any rent and/or security deposit within two (2) business days of being informed the unit is ready to rent. The family will be allowed seven (7) calendar days to complete a transfer. The family will be responsible for paying rent at the old unit as well as the new unit for any period of time they have possession of both. The prorated rent and other charges (key deposit and any additional security deposit owing) must be paid at the time of lease execution.

The following is the policy for the rejection of an offer to transfer:

- A. If the family rejects with good cause any unit offered, they will not lose their place on the transfer waiting list.
- B. If the transfer is being made at the request of the Luna Pier Housing Commission and the family rejects two offers without good cause, the Luna Pier Housing Commission will take action to terminate their tenancy. If the reason for the transfer is that the current unit is too small to meet the Luna Pier Housing Commission's optimum occupancy standards, the family may request in writing to stay in the unit without being transferred so long as their occupancy will not exceed two people per living/sleeping room.
- C. If the transfer is being made at the family's request, the family may, without good cause and without penalty, turn down one offer. After turning down a second such offer without good cause, the family's name will be removed from the transfer list.

Criteria

The final rule on Deconcentration (24 CFR Part 903) describes public housing developments not subject to deconcentration. HUD determined that certain

developments should be exempt from the requirement to deconcentrate poverty because of the development's resident population, type or types of units, or number of units. Public housing developments that are exempt from application or the requirement to deconcentrate poverty and mix incomes are the following:

Sec 903.2 (b)(2):

- (i): Public housing developments operated by a PHA with fewer than 100 public housing units;
- (ii): Public housing developments operated by a PHA which house only elderly persons or persons with disabilities, or both;
- (iii): Public housing developments operated by a PHA that operates only one general occupancy, family public housing development;
- (iv): Public housing developments approved for demolition or for conversion to tenant-based assistance; and,
- (v): Public housing developments which include public housing units operated in accordance with a HUD-approved mixed-finance plan..

A public housing development includes units or buildings with the same project number. Also, contiguous sites with more than one project number may be considered one development.

Public housing developments that are subject to the requirement to deconcentrate poverty are general occupancy, family public housing developments, excluding those developments, identified above, as being exempt from the requirement, and are referred to as "covered developments."

Documentation:

The Housing Commission owns and operates a total of 102 public housing units. There are two developments. MI098-1 consists of 51 units with 21 units designed for general occupancy and 30 units designed for occupancy by elderly persons or persons with disabilities or both.

MI098-2 consists of 51 units with 21 units designed for general occupancy and 30 units designed for occupancy by elderly persons or persons with disabilities or both.

Based on the criteria outlined above, contiguous sites with more than one project number may be considered one development. MI098-1 and MI098-2 are considered as one development since they are on one site.

Our agency is part of the entire effort undertaken by the City of Luna Pier, Monroe County and the State of Michigan to address our jurisdiction's affordable housing needs. While we cannot ourselves meet the entire need identified in the Consolidated Plan, in accordance with our goals and objectives included in this Plan, we will try to address some of the identified need by using appropriate resources to maintain and preserve our existing stock. When appropriate and feasible, we will apply for additional grants and loans from federal, state and local sources, including private sources to enhance the affordable housing available in our community. We intend to continue working with our local partners to try and meet these identified needs.

This year we expect to continue to utilize the funds we receive for our existing programs to house people. We will be focusing on management improvements and modernization of our properties. Priorities and guidelines for programs often change from year to year and our decisions to pursue certain opportunities and resources may change over the coming year if there are program changes beyond our control.

Pet Policy

EXCLUSIONS

This policy does not apply to animals that are used to assist persons with disabilities. Assistive animals are allowed in all public housing facilities with no restrictions other than those imposed on all tenants to maintain their units and associated facilities in a decent, safe, and sanitary manner and to refrain from disturbing their neighbors.

PETS IN Public Housing

The Lotus Manor, Luna Pier Housing allows for pet ownership in its developments with the written pre-approval of the Housing Authority. Residents are responsible for any damage caused by their pets, including the cost of fumigating or cleaning their units. In exchange for this right, resident assumes full responsibility and liability for the pet and agrees to hold the Lotus Manor, Luna Pier Housing harmless from any claims caused by an action or inaction of the pet.

Approval

Residents must have the prior written approval of the Housing Authority before moving a pet into their unit. Residents must request approval on the Authorization for Pet Ownership Form that must be fully completed before the Housing Authority will approve the request. Residents must give the Housing Authority a picture of the pet so it can be identified if it is running loose.

Types and Number of Pets

The Lotus Manor, Luna Pier Housing will allow only common household pets. This means only domesticated animals such as a dog; cat, bird, fish in an aquarium or a turtle will be allowed in units. Common household pets do not include reptiles (except turtles). If this definition conflicts with a state or local law or regulation, the state or local law or regulation shall govern.

All dogs and cats must be spayed or neutered before they will be approved for living at Lotus Manor, Luna Pier Housing. A licensed veterinarian must verify this fact in writing to Lotus Manor.

The number of pets* per unit will be allowed according to this schedule.

Unit Size	Pets
One Bedroom	1
Two Bedrooms	1
Three Bedrooms	2
Four or More Bedrooms	2

Any animal deemed to be potentially harmful to the health or safety of others, including attack or fight trained dogs, will not be allowed.

No animal may exceed **40** pounds in weight projected to full adult size.

*One ten (10) Gallon Aquarium counts as one pet.

Inoculations

In order to be registered, pets must be appropriately inoculated against rabies, distemper and other conditions prescribed by state and/or local ordinances. They must comply with all other state and local public health, animal control, and anti-cruelty laws including any licensing requirements. A certification signed by a licensed veterinarian or state or local official shall be annually filed with the Lotus Manor, Luna Pier Housing to attest to the inoculations.

Pet Deposit

A pet deposit of **\$150** is required at the time of registering a pet. The deposit is refundable when the pet or the family vacates the unit, less any amounts owed due to damage beyond normal wear and tear. A separate deposit is required for each pet. The pet deposit is not applicable if the pet is ordered by a physician for medical reasons.

Financial Obligation of Residents

Any resident who owns or keeps a pet in their dwelling unit will be required to pay for any damages caused by the pet. Also, any pet-related insect infestation in the pet owner's unit will be the financial responsibility of the pet owner and the Lotus Manor, Luna Pier Housing reserves the right to exterminate and charge the resident.

Nuisance or Threat to Health or Safety

The pet and its living quarters must be maintained in a manner to prevent odors and any other unsanitary conditions in the owner's unit and surrounding areas.

Repeated substantiated complaints by neighbors or Lotus Manor, Luna Pier Housing personnel regarding pets disturbing the peace of neighbors through noise, odor, animal waste, or other nuisance may result in the owner having to remove the pet or move him/herself.

Pets that make noise continuously and/or incessantly for a period of 10 minutes or intermittently for one half hour or more to the disturbance of any person at any time of day or night shall be considered a nuisance.

Designation of Pet areas

Pets must be kept in the owner's apartment or on a leash at all times when outside the unit (no outdoor cages may be constructed). Pets belonging to family units will be allowed only on the lawn area adjacent to the owners unit. Pets belonging to the Senior Unit Tenants must be walked in the field west of the buildings. Pets are not allowed on the playgrounds or on ball fields/courts. Pets may not be left chained outside the owners unit without continuous supervision. Pet owners must clean up after their pets on a daily basis and are responsible for disposing of pet waste.

With the exception of assistive animals no pets shall be allowed in the community rooms community room kitchens, laundry rooms, libraries, public bathrooms, lobby, hallways, or office.

To accommodate residents who have medically certified allergic or phobic reactions to dogs, cats, or other pets, those pets may be barred from certain wings (or floors) in our development(s)/building(s). This shall be implemented based on demand for this service.

MISCELLANEOUS RULES

Pets may not be left unattended in a dwelling unit for over **eight (8)** hours. If the pet is left unattended and no arrangements have been made for its care, the HA will have the right to enter the premises and take the uncared for pet to be boarded at a local animal care facility at the total expense of the resident.

Pet bedding shall not be washed in any common laundry facilities.

Residents must take appropriate actions to protect their pets from fleas and ticks.

All dogs must wear a tag bearing the resident's name and phone number and the date of the latest rabies inoculation.

Pets cannot be kept, bred, or used for any commercial purpose.

Residents owning cats shall maintain waterproof litter boxes for cat waste. Refuse from litter boxes shall not accumulate or become unsightly or unsanitary. Litter shall be disposed of in an appropriate manner.

A pet owner shall physically control or confine his/her pet during the times when Lotus Manor employees, agents of the Lotus Manor or others must enter the pet owner's apartment to conduct business, provide services, enforce lease terms, etc.

If a pet cause's harm to any person, the pet's owner shall be required to permanently remove the pet from Lotus Manor's property within 24 hours of written notice from Lotus Manor. The pet owner may also be subject to termination of his/her dwelling lease.

A pet owner who violates any other conditions of this policy may be required to remove his/her pet from the development within 10 calendar days of written notice from the Lotus Manor. The pet owner may also be subject to termination of his/her dwelling lease.

Lotus Manor's grievance procedures shall be applicable to all individual grievances or disputes arising out of violations or alleged violations of this policy.

Visiting Pets

Pets that meet the size and type criteria outlined above may visit the projects/buildings where pets are allowed for up to two weeks with Lotus Manor, Luna Pier Housing approval and must provide management with licensed veterinarian documents verifying that the pet is healthy and has received all inoculations. Tenants who have visiting pets must abide by the conditions of this policy regarding health, sanitation, nuisances, and peaceful enjoyment of others. If visiting pets violate this policy or cause the tenant to violate the lease, the tenant will be required to remove the visiting pet.

REMOVAL OF PETS

The Lotus Manor, Luna Pier Housing, or an appropriate community authority, shall require the removal of any pet from a project if the pet's conduct or condition is determined to be a nuisance or threat to the health or safety of other occupants of the project or of other persons in the community where the project is located.

In the event of illness or death of pet owner, or in the case of an emergency which would prevent the pet owner from properly caring for the pet, Lotus Manor, Luna Pier Housing has permission to call the emergency caregiver designated by the resident or the local Pet Law Enforcement Agency to take the pet and care for it until family or friends would claim the pet and assume responsibility for it. Any expenses incurred will be the responsibility of the pet owner.

Residents agree to identify and hold harmless Lotus Manor, Luna Pier Housing Commission from any and all responsibility for injury or illness caused by resident- owned pets. I have reviewed and understand the above rules and agree to conform to the same and understand that violation of the rules may result in a requirement to permanently remove the pet from the unit or vacate the dwelling.

Community Service

Community Service and Self-Sufficiency Policy

In order to be eligible for continued occupancy, each adult family member must contribute eight (8) hours per month of volunteer community service / self-sufficiency activities (not including employment or political activities) within the community in which the public housing development is located, unless they are exempt from this requirement. The community service/self-sufficiency requirement allows residents an opportunity to "give something back" to their communities and facilitates upward mobility.

EXEMPTIONS:

The following adult family members of tenant families are exempt from this requirement:

- a. Family members who are 62 and older.
- b. Some family members who are blind or disabled as defined under Section 216 (f) or 1614 of the Social Security Act and who are unable to comply with the requirement.
- c. Family members who are the primary care giver for someone who is blind or disabled.
- d. Family members engaged in work activity as defined under Section 407 (d) of the Social Security Act (a minimum of 30 hours per week).
- e. Family members who are exempt from work activity under a State program funded under part A Title IV of the Social Security Act or under any other State welfare program, including welfare to work programs.
- f. Family members in a family receiving assistance under a State program funded under part A Title IV of the Social Security Act or under any State welfare program, including a welfare to work program and who are in compliance with that program.

NOTIFICATION

At least sixty (60) days before lease term expires, the LPHC shall identify all adult family members who are not exempt from the community service requirement/self-sufficiency requirement. The LPHC will notify all such family members of the community service/self-sufficiency requirement and provide them with opportunity to present compliance documentation or to claim exemption status. The LPHC will verify all claims of compliance and/or exemption.

The notification will advise family member(s) that failure to comply with the community service/self-sufficiency requirement could result in ineligibility of the family for continued occupancy at the end of their lease.

VOLUNTEER COMMUNITY SERVICE / SELF -SUFFICIENCY ACTIVITIES

Volunteer community service / self-sufficiency activities includes performing work or duties in the public that serves to improve the quality of life and/or enhance resident's self-sufficiency, and/or increase the self-responsibility of the resident within the community.

The LPHC residents may consult with social service agencies, local schools, the hospital and other organizations to help identify volunteer community service / self -sufficiency activities. The LPHC must approve all volunteer community service/self-sufficiency activities in order for residents to satisfy the requirement.

NOTIFICATION OF NON-COMPLIANCE

The LPHC will notify any family member found to be in non-compliance as follows:

- a. Identify the family member(s) whom as been determined to be in noncompliance;
- b. The determination is subject to the Grievance Procedure; and
- c. LPHC will describe the noncompliance; the lease may not be renewed at the end of the lease term and family eviction pursued;
- d. LPHC will offer the tenant the opportunity to comply with a written agreement to cure the noncompliance.

OPPORTUNITY FOR CURE

The LPHC will offer the family member(s) the opportunity to enter into a written agreement with the LPHC to cure the noncompliance with the community service/self-sufficiency requirements prior to the current lease expiration. The agreement shall include:

- a. The family member(s) to perform the additional number of hours of community service to satisfy the current lease;
- b. Along with the number of hours needed to comply with the community service requirement for the next 12 month term of the new lease;
- c. Assurance that all members of the family who are subject to these requirements are in compliance with the requirements;
- d. Written assurances that satisfy the LPHC that any noncompliant resident no longer resides in the unit.

If any applicable family member does not accept the terms of the written agreement to perform volunteer community service/self-sufficiency, or falls behind in the obligation under the agreement by more than four (4) hours, except for good cause as determined by the Executive Director, the LPHC shall take action to terminate the lease.

ELIGIBLE COMMUNITY SERVICE ACTIVITIES

Eligible community service activities that can be performed include, but are not limited to the following:

- Work at a local public or non-profit institution, including but not limited to school, Head Start, other before and after school programs, in school tutoring, child care centers, hospital, clinic, Hospice, nursing home, recreation center, senior center (does not include the Luna Pier Housing Commission), adult day care program, homeless shelter, feeding program, food bank (distributing either donated or commodity foods), or clothes closet (distributing donated clothing), Salvation Army, etc.
- Work with a non-profit organization that serves PHA residents or their children, including but not limited to Boy Scouts, Girl Scouts, Boy and Girls Club, 4-H Club, PAL; other children's recreation, mentoring, or education programs, Big Brothers or Big Sisters, community garden clean-up programs, beautification programs, etc.
- Work with any program funded under the Older Americans Act, including but not limited to senior meals program, senior centers, Meals on Wheels, etc.
- Work with churches, i.e. your local church
- Work with any other public or non-profit youth or senior organization
- Helping neighborhood groups with special projects
