*The Housing Authority's mission is to serve the needs of low-income, very low-income and extremely low-income families in the PHA's jurisdiction and to (1) increase the availability of decent, safe and affordable housing in its communities; (2) ensure equal opportunity in housing; (3) promote self-sufficiency and asset development of families and individuals; and (4) improve community quality of life and economic viability. The Housing Authority exists to serve people in need. Service to the residents must always be our first and foremost priority. It is our goal to provide excellence in service by being committed to improving the housing conditions and related social, educational and economic aspects which affect the overall living conditions of the community. To accomplish this goal, we must constantly strive to expand and improve housing and related service through dedication, integrity, compassion and responsiveness to all the needs of those we serve.*

**HACH Progress Statement:** *During FY 2008 the PHA improved equal opportunity in housing by continuing to advertise vacancies in the local newspapers, posting and sending flyers to organizations, churches, and colleges. Our vacancy rate has been lowered drastically. Applications for housing are provided to the local homeless shelter, and they assist the homeless families in completing the application. In addition, the PHA implemented an annual Section 8 Conference in efforts to improve equal opportunity and outreach potential voucher landlords and persons interested in public housing.*

## **B. Goals**

### **HUD Strategic Goal: Increase the availability of decent, safe, and affordable housing.**

- PHA Goal: Expand the supply of assisted housing
- Objectives:
- Apply for additional rental vouchers: *Currently, the PHA has 733 assisted vouchers contracted out of 733 for FY 2008. However, the PHA's goal is to apply for and increase rental vouchers to 786.*
  - Reduce public housing vacancies: *On-going outreach. The PHA advertises vacancies in the local newspaper every two weeks. In addition informational program flyers are distributed to local agencies such as the Texas Department of Human Services, Su Clinica Familiar, Salvation Army, and to homeless shelters such as Loaves and Fishes. Applications for housing are provided to the Loaves and Fishes agency and they assist the homeless families in completing the application for housing. Informational flyers are also posted at area Laundromats. In addition, the PHA participates in several community events through the Texas State Technical College by hosting a booth and providing public housing information. In accordance with the nondiscrimination requirements of Federal and State laws, and HUD guidelines for fair housing, the PHA includes the equal opportunity logo, statement, or slogan to all public announcements.*

**HACH Progress Statement:** *During FY 2008 the PHA was successful in achieving objectives listed above by advertising in the newspaper. The PHA advertises vacancies in the local newspapers every two (2) weeks and notices are posted in public places. Our current vacancy rate decreased from last year's rate of 6% to 4%. Vacant units undergoing modernization are not included in this calculation.*

- PHA Goal: Improve the quality of assisted housing  
Objectives:
  - Improve public housing management: (PHAS score) 91
  - Improve voucher management: (SEMAP score) 104
  - Increase customer satisfaction: *During FY 2008, the PHA will continue to work with residents on questions they have regarding our programs. We will continue to involve the residents in decisions being made regarding program concerns through quarterly Resident Advisory Board meetings.*
  - Concentrate on efforts to improve specific management functions: (list; e.g., public housing finance; voucher unit inspections) *During FY 2008 this goal was achieved and the PHA will continue to work with owners and residents to make sure that voucher unit inspections pass. We monitor our public housing finance to reduce overruns that may be done. We have achieved our goals in the PHAS indicator management score, receiving 30%. We will continue to train staff to improve specific management functions such as finance, Section 8 at all levels of management.*
  - Renovate or modernize public housing units: *During FY 2008 this goal was achieved and the PHA continues to modernize its housing developments.*
  - Demolish or dispose of obsolete public housing: *The PHA's application for disposition of Heritage Manor, a 104 unit development, was approved on April 3, 2007.*
  - Provide replacement public housing: *The number of replacement housing will be based on the sale proceeds of Heritage Manor and will be determined by the cost of development per unit at that time.*

**HACH Progress Statement:** *During FY 2008 the PHA was successful in achieving objectives listed above. At present time all developments have been improved. The PHA has made substantial rehabilitation of some of the units in the following areas: remodeled bathrooms, replaced kitchen cabinets, installed new flooring and re-texturing of walls and ceilings at various units. Additional security lighting was added to Le Moyne Gardens. During FY 2008 the PHA achieved a PHAS rating of "High Performer" with a score of 91%. The SEMAP passing score continued in 2008 with a score of 104%.*

- PHA Goal: Increase assisted housing choices  
Objectives:
  - Provide voucher mobility counseling: *To new and all current participants at briefing and at each unit transfer. The PHA will continue to provide counseling at the unit transfer and annual recertification.*

- Conduct outreach efforts to potential voucher landlords: *The PHA continues to recruit new landlords through partnerships with local real estate agencies and the annual Section 8 conference.*
- Increase voucher payment standards: *The PHA complies with the Federal register on Fair Market Rents and Payment Standards by reevaluating them for accuracy on an annual basis.*

  - Implement measures to deconcentrate poverty by bringing higher income public housing households into lower income developments:
  - Implement measures to promote income mixing in public housing by assuring access for lower income families into higher income developments:
  - Implement public housing security improvements: *Technical assistance on security surveillance has been implemented and is an on-going process. In addition, the PHA will continue to have an in-house police officer at each development, and will continue to involve police officers at each development, implementation, and/or on-going evaluation of the neighborhood watch programs. The PHA will continue to hold quarterly crime prevention meetings at each public housing development.*
  - Designate developments or buildings for particular resident groups (elderly, persons with disabilities)
  - Other: (list below)
    - *Implement affirmative measures to assist victims of domestic violence in avoiding their abusers and continuing occupancy in public housing. The PHA has continued to seek avenues to partner with local agencies and/or support groups who assist families who are victims of domestic violence. The PHA is currently assisting tenants who are victims of domestic violence by honoring their transfer requests and eliminating any transfer fees.*

**HACH Progress Statement:** *During FY 2008, the HACH's security surveillance continued to be a great success. HACH will continue to work at staying informed on new innovations that may benefit the improvement of quality of life and economic vitality. Additional security lighting was added to Le Moyne Gardens, and further lighting will be added to the other developments as funding allows. We now have four (4) in-house police officers at the developments, an increase from two (2) to four (4).*

**HUD Strategic Goal: Promote self-sufficiency and asset development of families and individuals**

- PHA Goal: Promote self-sufficiency and asset development of assisted households
- Objectives:
- Increase the number and percentage of employed persons in assisted families:
  - Provide or attract supportive services to improve assistance recipients' employability: *This will continue to be an on-going activity. The PHA will partner with local agencies that can provide guidance on filling out an application for employment, dressing for a successful interview, and how to conduct self at job interview. Agencies may include the Texas Workforce or local colleges. The PHA has entered into collaborative agreement with Avance, Inc., Rio Grande Valley Chapter in efforts to better serve the children and families residing at the developments.*
  - Provide or attract supportive services to increase independence for the elderly or families with disabilities.
  - Other: (list below)
    - *Partnership with local agencies to provide and/or attract supportive services to assist victims of domestic violence move out of abusive situations and begin again.*
    - *Provide referrals to potential homebuyers to the Harlingen Community Development Corporation (HCDC) and to the City of Harlingen. Both agencies provide down-payment and closing cost assistance to low and moderate-income families.*
    - *Provide tutoring and enrichment programs to students residing in public housing through the partnership formed between the PHA and the Harlingen Consolidated Independent School District.*
    - *The PHA coordinates with local social services agencies and home health agencies that provide medical health eligibility counseling, health screenings, and substance abuse prevention classes.*

**HACH Progress Statement:** *During FY 2008, the PHA continued to make the items listed above on-going and will continue to make it possible for the residents to become self-sufficient.*

- Undertake affirmative measures to ensure accessible housing to persons with all varieties of disabilities regardless of unit size required: *This is an on-going activity and we will continue to ensure accessible housing for persons with all varieties of disabilities and unit size, referring participants to other agencies that may provide them with better opportunities.*

**HACH Progress Statement:** *During FY 2008, all items above remain on-going. The PHA continued to improve the units and implemented security improvements. In addition the HACH plans to continue to have in-house police. The HACH currently has four (4) in-house police officers. The PHA has provided the staff training on fair housing rules and regulations. In addition the PHA has ensures that all advertisement and notices are prepared in a non-discriminatory manner. The PHA investigates all claims of discrimination.*

These important documents cover the public housing tenant selection and assignment plan, outreach services, PHA's responsibility to Section 8 owners/landlords, grievance procedures, etc.*

*The most important challenges to be met by the Housing Authority of the City of Harlingen during FY 2009 include:*

- *Identification of management needs to enable PHA staff to continue the process of transition of the major changes in the Operating Fund rule. (i.e. Project-Based Accounting, Asset Management, Cost Allocation Planning, and software upgrades.)*

- *Preserve and improve the public housing stock through the Capital Funds activities;*
- *Involve the public housing residents through the Annual Plan Resident Advisory Board;*
- *Train staff and commissioners to fully understand and take advantage of opportunities public housing laws and regulations to better serve our residents and the community; and*
- *Identify, develop and leverage services to enable low-income families to become self-sufficient.*
- *Provide homeownership opportunities by referring public housing residents to the Harlingen Community Development Corporation and to the City of Harlingen for down-payment and closing cost assistance.*

*In closing, this Annual PHA Plan exemplifies the commitment of the Housing Authority of the City of Harlingen to meet the housing needs of the full range of low-income residents. The Housing Authority of the City of Harlingen, in partnership with agencies from all levels of government, the business community, non-profit community groups, and residents will use this plan as a road map to reach the “higher quality of life” destination for the City of Harlingen.*

The City of Harlingen will provide HOME program funding to this public service agency in the amount of \$11,100.00 for tenant based rental assistance and \$10,000.00 of CDBG funds.*

*The HOME Buyer Program administered by the Harlingen Community Development Corporation (HCDC), provides down payment and closing cost assistance to low and moderate-income families. HCDC continues to advise and encourage the Housing Authority administrators to refer potential homebuyers presently residing in low rent housing. The City of Harlingen will provide funding to the HCDC in the amount of \$168,781.00.*

*The City of Harlingen will provide HOME Program funding to the Family Crisis Center for the abused and neglected children in the amount of \$10,800.00 to be used for tenant based rental assistance. The City will also provide \$5,000.00 of CDBG funds. The Family Crisis Center assist victims of domestic violence. The PHA refers tenants in their housing program who are experiencing domestic violence and want to get away from their abuser to the Family Crisis Center.*

**DE-CONCENTRATION AND INCOME TARGETING POLICY**  
*(of the Public Housing Admissions and Continued Occupancy Policy)*

Sub-Title A, Section 513 of the Quality Housing and Work Responsibility Act of 1998 (QHWRA), establishes two interrelated requirements for implementation by Public Housing Authorities: (1) Economic De-concentration of public housing developments and (2) Income Targeting to assure that families in the “extremely low” income category are proportionately represented in public housing and that pockets of poverty are reduced or eliminated. In order to implement these new requirements the PHA must promote these provisions as policies and revise their Admission and Continued Occupancy policies and procedures to comply.

Therefore, the Housing Authority of the City of Harlingen, Texas, (hereinafter referred to as PHA) hereby affirms its commitment to implementation of the two requirements by adopting the following policies:

A. Economic De-concentration:

Admission and Continued Occupancy Policies are revised to include the PHA’s policy of promoting economic de-concentration. Implementation of this program may require the PHA to determine the median income of residents in each development, determine the average income of residents in all developments, compute the Established Income Range (EIR), determine developments outside the EIR, and provide adequate explanations and/or policies as needed to promote economic de-concentration.

Implementation may include one or more of the following options:

- Skipping families on the waiting list based on income;
- Establishing preferences for working families;
- Establish preferences for families in job training programs;
- Establish preferences for families in education or training programs;
- Marketing campaign geared toward targeting income groups for specific developments;
- Additional supportive services;
- Additional amenities for all units;
- Ceiling rents;
- Flat rents for developments and unit sizes;
- Different tenant rent percentages per development;
- Different tenant rent percentages per bedroom size;
- Saturday and evening office hours;
- Security Deposit waivers;
- Revised transfer policies;
- Site-based waiting lists;
- Mass Media advertising/Public service announcements; and
- Giveaways.

B. Income Targeting

As public housing dwelling units become available for occupancy, responsible PHA employees will offer units to applicants on the waiting list. In accordance with the Quality Housing and Work Responsibility Act of 1998, the PHA encourages occupancy of its developments by a broad range of families with incomes up to eighty percent (80%) of the median income for the jurisdiction in which the PHA operates. Depending on the availability of applicants with proper demographics, at a minimum, 40% of all new admissions to public housing **on an annual basis** may be families with incomes at or below thirty percent (30%) (extremely low-income) of the area median income. The offer of assistance will be made without discrimination because of race, color, religion, sex, national origin, age, handicap or familial status.

In order to implement the income targeting program, the following policy is adopted:

- The PHA may select, based on date and time of application and preferences, two (2) families in the extremely low-income category and two (2) families from the lower/very low-income category alternately until the forty percent (40%) admission requirement of extremely low-income families is achieved (2 plus 2 policy).
- After the minimum level is reached; all selections may be made based solely on date, time and preferences. Any applicants passed over as a result of implementing this 2 plus 2 policy will retain their place on the waiting list and will be offered a unit in order of their placement on the waiting list.
- To the maximum extent possible, the offers will also be made to affect the PHA's policy of economic de-concentration.
- The PHA reserves the option, at any time, to reduce the targeting requirement for public housing by no more than ten percent (10%), if it increases the target figure for its Section 8 program from the required level of seventy-five percent (75%) of annual new admissions to no more than eighty-five percent (85%) of its annual new admissions. (Optional for PHAs with both Section 8 and Public Housing programs)

Implementation Of The Community Service Requirement

**Description of the Community Service Plan**

The Housing Authority of the City of Harlingen Community Service Policy is simple and definitive of Section 512 of the Quality and Work Responsibility Act of 1998. The Housing Authority of the City of Harlingen believes that the community service requirement should not be received by the resident to be a punitive or demeaning activity, but rather to be a rewarding activity that will benefit both the resident and the community. Community service offers public housing residents and opportunity to contribute to the communities that support them while gaining work experience. The requirement is easy and rewarding and the Housing Authority provides the residents with the name of agencies, the agencies point of contact and all required paper work necessary to accomplish the monthly service.

The Community Service Policy allows the PHA to identify those residents required to participate in the community service requirement. Participants will be required to contribute 8 hours of community service each month or to participate in a self-sufficiency program for 8 hours each month. Identified residents are responsible to determine the appropriateness of the voluntary service within guidelines provide in the policy. Allowed activities that may be included are listed in the policy. Voluntary political activities are prohibited from being considered to meet the Community Service requirement. Participation in self-sufficiency activities that may be included are listed in the policy. A list of exemptions that may be claimed from the requirement is provided in the policy. Family obligations and PHA obligations are addressed in detail. Lease requirements and documentation and non-compliance are all clearly addressed.

**Administrative Steps Taken To Implement The Requirement**

The following administrative steps were taken in implementing the PHA Community Service Policy. A written notification was sent to all residents regarding requirements on exempt status of each adult family member. Informed all residents that the program would be administered by the PHA, however; they are required to have their hours documented and signed by the agencies where they volunteered. Finally that the volunteer sheet required for filing would be provided by the PHA. The PHA maintains a tracking log.

## **Programmatic Aspects Of The Requirements**

Activities that the residents can participate in and receive community service credit are listed in the Community Service Policy. The Housing Authority is the primary agency that assists the residents in accomplishing their community service, For non-compliance with the Community Service Policy the PHA informed residents again of the requirements, then inform them of the consequences for non-compliance, i.e., grounds for eviction.

Description of Pet Policy

**Pet Policy (Elderly/Disabled)**

All residents are permitted to own and keep common domesticated household pets. Common household pet means a domesticated cat, dog, bird, gerbil, hamster, Guinea pig, and fish in aquariums.

Pet owners must agree to abide by the PHA's Pet Ownership Rules.

Each pet owner shall pay a refundable pet deposit of \$200.00 for a dog or cat and a refundable pet deposit of \$50.00 for aquariums.

No pet deposit is required for birds, gerbils, hamsters, guinea pigs or turtles..

Limit of one pet per household.

Limit for birds is two (2).

Pet owner may have only a small cat or a small dog. Limitations: weight not to exceed twenty (20) pounds; height shall not exceed fifteen (15) inches. **This does not apply to service animals that assist persons with disabilities.**

Pet owner shall license their pet as required by law.

Pet owner must not violate any state or local health or humane laws.

Pet must be spayed or neutered.

Pet must be maintained on leash and kept under control when taken outside the unit.

**Pet Policy (Family)**

All residents are permitted to own and keep common domesticated household pets, such as a cat, dog, bird, and fish, in their dwelling units, in accordance with PHA pet ownership rules

Common household pet means a domesticated cat, dog, bird, gerbil, hamster, Guinea pig and fish in aquariums

Each pet owner shall pay a non-refundable pet fee of \$200.00. A refundable deposit of \$50.00 will be charged for aquariums.

There is no pet deposit for birds, gerbils, hamsters, guinea pigs or turtles.

Each household shall have only one pet (except fish or birds).

The limit for birds is two (2).

The pet owner shall have only a small cat or a dog. The animal's weight shall not exceed twenty (20) pounds. The animal's height shall not exceed fifteen (15) inches. **Such limitations do not apply to a service animal used to assist a disabled resident**

Progress in Meeting 5-Year Plan Goals

The Housing Authority of the City of Harlingen has been successful in achieving its mission and 5 year plan goals during the fiscal year 2008. Goals are either completed or on target for completion as scheduled.

Concerning modernization the PHA has done substantial renovation of the dwelling units at each development. Due to budget constraints, the majorities of the planned renovations are performed in several phases and are on-going activities. The PHA continues to replace bathroom tubs, tile, lavatories, including the replacement of old cast iron plumbing and pipe vents. Other on-going renovations are: floor tile installation, exterior door replacement, playground equipment replacement, and energy saving dwelling equipment replacement. The kitchen cabinets, including the kitchen sinks and faucets continue to be replaced as funding allows and the re-texturing of ceilings and walls is an on-going process as well. In carrying out the Fair Housing Act and American Disability Act (ADA), the PHA has converted several dwelling units for occupancy to meet the standards as established by these Acts. Included in these standards are the following reinforced walls in the bathroom to allow installation of grab bars around the toilet, shower stall, and shower seat, where such facilities are provided; replaced kitchens and bathrooms such that an individual in a wheelchair can maneuver about the space; and installed lights/sound alarm devices and other environmental controls, where such facilities are needed. Replaced various sidewalks to allow at least one entrance passage into a dwelling unit by disabled persons in wheelchairs.

Concerning quality of life and crime and safety, PHA efforts reduced crime in the communities through having security guards, implementing neighborhood watch program and quarterly crime prevention meetings. The PHA continues to provide security lighting improvements and fencing improvements. In addition, the PHA continues to have an in-house police officer at each development, and will continue to involve police officers in the development, implementation, and/or ongoing evaluation of the neighborhood watch programs. The PHA continues to hold quarterly crime prevention meetings at each public housing development. The PHA has implemented "Trash Bash Day" to allow the residents to take pride in the upkeep and appearance of their development/community.

Concerning promoting self-sufficiency, the PHA has implemented after school tutoring and activities at the family learning centers. The Family Learning Center is a resource center housed in the development that offers a variety of educational opportunities to the residents, and works together with the Harlingen Consolidated School District to help students make education their priority, and consequently reducing the dropout rate. In addition, the PHA has entered into a collaborative agreement with Avance, Inc., Rio Grande Valley Chapter in efforts to better serve the children and families residing at the developments. Avance, Inc. provides classes in literacy, learning English and attaining a GED. The PHA continues to identify residents required to participate in community service. Community service offers public housing residents an

opportunity to contribute to the communities that support them while gaining work experience.

To ensure compliance with the HUD's latest rules and regulations, every policy was reviewed and updated as needed. Most significant was the update to the Admissions and Continued Occupancy Policy and the Section 8 Administrative Plan. The PHA complies with the Federal Register on Fair Market Rents and Payment Standards by reevaluating them for accuracy on an annual basis. In addition, the PHA reviews its policies and procedures, at least annually, to assure compliance with civil rights requirements.

Concerning ensuring equal opportunity, outreach efforts have been made by making renewed partnerships with community groups and medical facilities. Applications for housing are provided to the local homeless shelter, and they assist the homeless in completing the application. They are also provided to the Family Crisis Center, a public services agency that assists families who are victims of domestic violence. The PHA implemented an annual Section 8 Conference in an effort to improve equal opportunity and reach out to potential voucher landlords and persons interested in public housing. In addition, the PHA distributes quarterly newsletters to their participants informing them about general guidelines and other information. The PHA continues to post public housing notices in local welfare offices, public offices, colleges, churches, and Laundromats; and continues to participate in community events that serve the elderly, disabled, homeless, and victims of domestic violence.

All outreach efforts are accomplished in accordance with the non-discrimination requirements of Federal and state laws, and HUD guidelines for fair housing that require the use of the equal housing opportunity logo, statement or slogan.

VAWA Support and Assistance Statement

The Housing Authority of the City of Harlingen (HACH) has incorporated in its PHA Plan goals and objectives, and policies and procedures the applicable provisions of the Violence Against Women and Reauthorization Act of 2005 (VAWA) to support or assist victims of domestic violence, dating violence, or stalking.

The PHA goal to provide an improved living environment is being met by the HACH by its effort to implement affirmative measures to assist victims of domestic violence in avoiding their abusers and continuing occupancy in public housing.

Towards its effort to meet the PHA goal to promote self-sufficiency and asset development of assisted households, the HACH has continued to seek avenues to partner with local agencies and/or support groups who assist families who are victims of domestic violence to move out of abusive situations and begin again. The HACH has created a partnership with the Family Crisis Center that has set aside two (2) units to house families who are victims of domestic violence during the initial transition period of breaking away from the abuser. The HACH would be involved as a partner who would refer tenants in their housing program who are experiencing domestic violence and want to get away from their abuser.

In addition, the HACH is currently assisting tenants who are victims of domestic violence by honoring their transfer requests and eliminating any transfer fees.

The City of Harlingen will provide funding to the Family Crisis Center, for the abused and neglected children, in the amount of \$10,800.00.
