- *Identification of management needs to enable PHA staff to prepare for major upcoming changes in the Operating Fund Rule (s). (i.e. Project-based Accounting, Asset Management, Cost Allocation Planning, and software Upgrades)*

- *Increase the peaceful and safe environment by providing security services to it's Public Housing Residents.*
- *Preserve and improve the public housing stock through the Capital fund Activities.*
- *Involve the public housing residents and the section 8 participants through the Annual Plan Resident Advisory Board.*
- *Train Staff and Commissioners to fully understand and take advantage of opportunities in the new law and regulations to better serve our residents and the community; and*
- *Identify, develop and leverage services to enable low income families to become self-sufficient.*

In closing, this Annual PHA Plan exemplifies the commitment of the Crystal City Housing Authority to meet the housing needs of the full range of low income residents. The Crystal City Housing Authority, in partnership with agencies from all levels of govenement, the business community, non-profit community groups, and residents will use this plan as a road map to reach the "higher quality of life" destination for the City of Crystal City.

Sub-Title A, Section 513 of the Quality Housing and Work Responsibility Act of 1998 (QHWRA), establishes two interrelated requirements for implementation by Public Housing Authorities: (1) Economic De-concentration of public housing developments and (2) Income Targeting to assure that families in the “extremely low” income category are proportionately represented in public housing and that pockets of poverty are reduced or eliminated. In order to implement these new requirements the PHA must promote these provisions as policies and revise their Admission and Occupancy policies and procedures to comply.

Therefore, the Crystal City Housing Authority, Crystal City, Texas (hereinafter referred to as PHA) hereby affirms its commitment to implementation of the two requirements by adopting the following policies:

A. Economic De-concentration:

Admission and Continued Occupancy Policies are revised to include the PHA’s policy of promoting economic de-concentration. Implementation of this program may require the PHA to determine the median income of residents in each development, determine the average income of residents in all developments, compute the Established Income Range (EIR), determine developments outside the EIR, and provide adequate explanations and/or policies as needed to promote economic de-concentration.

Implementation may include one or more of the following options:

- ¥ Skipping families on the waiting list based on income;
- ¥ Establishing preferences for working families;
- ¥ Establish preferences for families in job training programs;
- ¥ Establish preferences for families in education or training programs;
- ¥ Marketing campaign geared toward targeting income groups for specific developments;
- ¥ Additional supportive services;
- ¥ Additional amenities for all units;
- ¥ Flat rents for developments and unit sizes;
- ¥ Different tenant rent percentages per development;
- ¥ Different tenant rent percentages per bedroom size;
- ¥ Saturday and evening office hours;
- ¥ Security Deposit waivers;
- ¥ Revised transfer policies;
- ¥ Site-based waiting lists;
- ¥ Mass Media advertising/Public service announcements; and
- ¥ Giveaways.

B. Income Targeting

As public housing dwelling units become available for occupancy, responsible PHA employees will offer units to applicants on the waiting list. In accordance with the Quality Housing and Work Responsibility Act of 1998, the PHA encourages occupancy of its developments by a broad range of families with incomes up to eighty percent (80%) of the median income for the jurisdiction in which the PHA operates. Depending on the availability of applicants with proper demographics, at a minimum, 40% of all new admissions to public housing **on an annual basis** may be families with incomes at or below thirty percent (30%)(extremely low-income) of the area median income. The offer of assistance will be made without discrimination because of race, color, religion, sex, national origin, age, handicap or familial status.

In order to implement the income targeting program, the following policy is adopted:

- The PHA may select, based on date and time of application and preferences, two (2) families in the extremely low-income category and two (2) families from the lower/very low-income category alternately until the forty percent (40%) admission requirement of extremely low-income families is achieved (2 plus 2 policy).
- After the minimum level is reached, all selections may be made based solely on date, time and preferences. Any applicants passed over as a result of implementing this 2 plus 2 policy will retain their place on the waiting list and will be offered a unit in order of their placement on the waiting list.
- To the maximum extent possible, the offers will also be made to effect the PHA's policy of economic de-concentration.
- The PHA reserves the option, at any time, to reduce the targeting requirement for public housing by no more than ten percent (10%), if it increases the target figure for its Section 8 program from the required level of seventy-five percent (75%) of annual new admissions to no more that eighty-five percent (85%) of its annual new admissions. (Optional for PHAs with both Section 8 and Public Housing programs)

IMPLEMENTATION OF THE COMMUNITY SERVICE REQUIREMENT

Description of the Community Service Policy

The Crystal City Housing Authority Community Service Policy is simple and definitive of Section 512 of the Quality and Work Responsibility Act of 1998. The Crystal City Housing Authority believes that the community service requirement should not be received by the resident to be a punitive or demeaning activity, but rather to be a rewarding activity that will benefit both the resident and the community. Community service offers public housing residents and opportunity to contribute to the communities that support them while gaining work experience. The requirement is easy and rewarding and the Housing Authority provides the residents with the name of agencies, the agencies point of contact and all required paper work necessary to accomplish the monthly service.

The Community Service Policy allows the PHA to identify those residents required to participate in the community service requirement. Participants will be required to contribute 8 hours of community service each month or to participate in a self-sufficiency program for 8 hours each month. Identified residents are responsible to determine the appropriateness of the voluntary service within guidelines provide in the policy. Allowed activities that may be included are listed in the policy. Voluntary political activities are prohibited from being considered to meet the Community Service requirement. Participation in self-sufficiency activities that may be included are listed in the policy. A list of exemptions that may be claimed from the requirement is provided in the policy. Family obligations and PHA obligations are addressed in detail. Lease requirements and documentation and non-compliance are all clearly addressed.

Administrative Steps to Implement Requirement

The Crystal City Housing Authority has made modifications in the lease agreements with the residents to include the community service requirement. The CCHA has provided written notification to our residents regarding the requirement or exempt status of each adult member. The CCHA has in place cooperative agreements with our local welfare and other agencies to assist us in verifying our resident's status.

Programmatic Aspect of the Requirement

The type of activities that our residents are subject to perform for community service includes but is not limited to:

- Clerical, custodial, maintenance, recreational, service oriented, tutoring, etc.

- The residents are advised of their non-compliance and are given an opportunity to cure this impediment.

Progress in Meeting 5-Year Plan Goals

The Crystal City Housing Authority has been successful in achieving its mission and 5 year plan goals during the fiscal year 2006. Goals are either completed or on target for completion as scheduled.

Concerning modernization, the PHA has done substantial renovation in all of its developments. Currently TX-1 through TX-6 have had all of the exterior work done such as replacing rotted or old siding, fascia & sophist and painting. Currently TX-6 is the last development left to be done. Work has been contracted out to do removal and reconstruction of sidewalks, erosion control and landscaping work in TX-1 & 5 and has been completed. Additional work has been contracted out for the same type of work for TX-1, 3 & 7. That work will be completed by December 2006.

Concerning self-sufficiency and crime and safety, PHA efforts reduced crime in the communities through our security department. Our effort to keep our residents safe from crime and violence has been very successful. The CCHA has a very good working relationship with our local law enforcement agencies.

Concerning improving the quality of life, the PHA has strengthened its community network by working with its partners in offering referral services to our residents.

To ensure compliance with the HUD's latest rules and regulations, every policy was reviewed and updated as needed. Most significant was the update to the Admissions and Continued Occupancy Policy and the Section 8 Administrative Plan.

Concerning ensuring equal opportunity outreach efforts have been made by making renewed partnerships with community groups and medical facilities.



**VIOLENCE AGAINST WOMEN ACT
VAWA**

The Housing Authority of the City of Crystal City has entered into a Memorandum of Understanding with WinterGarden Women's Shelter, Inc (WWS,Inc.) and four county Law Enforcement Department including the judicial System.

1. The WWS, Inc. memorandum services and programs provided are directly to the Housing Authority of the City of Crystal City and other partners within the memorandum. The services of WWS, Inc. will be provided to child and adult victims of domestic violence, dating violence, sexual assault, or stalking.
2. The WWS, Inc. services and programs provided or offered will help the child and adult victims of domestic violence, dating violence, sexual assault, or stalking to obtain or maintain housing.
3. WWS, Inc. services and programs provided educate, training, public awareness and advocacy, Victims Service Maintenance and Expansion and Counseling Services.

The memorandum of Understanding was signed and implemented February 2008. The Memorandum is on file and implemented.
