The estimated income per capita of Karnes County is \$13,800 with the average apartment renting for \$380. For the population of the county there are ample apartment units for rent. The housing shortage is in two and three bedroom homes that low to extremely low-income families can rent. This is based on the lack of housing for Section 8 participants in Karnes County. There have been no housing analysis studies done for housing needs in Karnes County. The low rent waiting list for Karnes City currently has no approved applicants on the waiting list. The public housing units currently vacant are a one bedroom, a two bedroom and a three bedroom.</p>



(4) The penalties that may be imposed upon employees for drug abuse violations occurring in the workplace.

(1) Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or

(2) Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal, State, or local health, law enforcement, or other appropriate agency;

g. Making a good faith effort to continue to maintain a drug-free workplace through implementation of paragraphs a. thru f.


