However, due to inadequate funding of the Section 8 Housing Choice Voucher Program, our Section 8 Waiting List had to be closed indefinitely. Due to lack of available funds no Housing Vouchers can be issued until this funding issue is resolved.

These units will be converted from Gas to Electric utilities. Central Heating and Air, insulated windows with security screens, storm doors, new electric appliances and new roofs will be installed. All units will be painted throughout. These upgrades will make these units much more appealing to prospective applicants who cannot afford to rent in the private sector.
