HACU has maintained 100% occupancy in the public housing complex, by expedited unit turn-over which meets or exceeds HUD's PHA requirements.

HACU has maintained 99% or higher occupancy in its HCV program, and has fully utilized its budget authority within the HUD permissible budget authority.

HACU continues to work with Upland Community Housing, Inc. (UCHI), a local non-profit, to increase affordable housing in the community.

HACU continues its partnership with UCHI to manage a tax-credit senior property, in order to increase the number of affordable housing units in the community.

HACU implemented the VAWA requirements in 2007, and is in full compliance. HACU refers applicants and participants that indicate they are victims of domestic violence to local agencies that are capable of providing needed services and assistance. HACU applicants and participants that indicate they are victims of domestic violence are required to submit certifications on the HUD approved form. HACU would bifurcate leases and vouchers, and require that HCV landlord do the same, to prevent termination to household members who are victims of domestic violence, as described in VAWA.




