Attachment A

Violence Against Women Act Information

The Gibson Housing Authority is striving to fully comply with all requirements of the Violence Against Women Act (VAWA) that pertain to public housing agencies. The Authority will not deny admission based solely on the fact that someone is or has been a victim of domestic violence, dating violence, or stalking. The Applicant must comply with all other admission requirements.

The Authority will not terminate assistance to a victim of domestic violence, dating violence, or stalking based solely on an incident or threat of such activity. The Authority still retains the right to terminate assistance for other criminal activity or good cause.

All information provided by an applicant or tenant regarding VAWA will be held in strict confidence and will not be shared with any other parties, unless required by law.

At this time, the Housing Authority does not intend to put a victim of domestic violence admissions preference in place. The Executive Director will periodically review the need for such preference and may add an admissions preference for victims of domestic violence if a need is determined.

The Housing Authority provides information pertaining to violence against women during the application process and at re-certification.
