2009 Progress: PHAS Scores were 90%

B. Objective:

Maintain public housing vacancies at a rate of 2% or less for 2010-2014 for all communities.

2009 Progress: The number of vacancies decreased significantly. Occupancy rate for Houston County has been at 99%

C. Objective:

Evaluate housing alternatives in the existing larger public housing communities utilizing HUD Revitalization programs.

2009-2010: Review information on the conditions of larger public housing communities and determine availability of HUD programs for revitalization or demolition. Study feasibility of HUD applications.

2010-2011: 202 Application and CDBG

2011-2012: HUD Grants

2012-2013: Study feasibility of HUD applications.

2013-2014: Study feasibility of HUD applications.

2009 Progress: The HCHA is researching funding resources with the City of Warner Robins, Houston County, community partners, and other HUD programs.

D. Objective:

Renovate and modernize public housing units according to the Capital Fund Program in an effort to reflect the private market. The Houston County Housing Authority Five Year Plan 2010-2014 will accomplish the projects as identified in the Capital Fund Plan

2010-2011: Update Physical Needs Assessment by completing a detailed inspection of HCHA residential buildings by engineers to determine current physical conditions and cost for improvements.

2011-2012: Begin the transition of converting units from electric to gas, provide additional lighting and enhance the marketability of the community through the use of signs and unit upgrades .

2009 Progress: The HCHA is researching funding resources with the City of Warner Robins, community partners, and other HUD programs.

II. Goal: Maintain and strengthen financial viability

A. Objective

Achieve positive cash flow within each managed program and asset. This includes weaning the Central Office Cost Center from the use of Capital Funds to maximize its use for capital improvements to the full benefit of our developments.

2010-2011: Develop non HUD income stream with private entities

2009 Progress: The HCHA is managed by Warner Robins Housing Authority which has 3 Amps and Central Office Cost Center. The community rooms are being rented out to the public.

III. Goal: Improve the public and community image of HCHA by developing and implementing a comprehensive Public Relations Plan.

A. Objective

Improve the delivery of quality customer service. Enhance operation efficiency by coordinating with community providers and upgrading equipment. Provide housing services to customers in a professional, respectful manner without regard to race, creed, or preference.

2010-2011: Continue case management and provide educational, training, and employment opportunities.

2011-2012: Continue to network with community partners and seek resident services and provide newsletters.

2012-2013: Review Programs and Community Partners and provide updates through newsletters

2013-2014: Review Programs and provide updates through newsletters.

2009 Progress: Communicated to the community through newsletters, provided training to Board of Commissioners, Staff, and residents. Started the process of a HCHA website for residents and the public to view. Positive feed back has been received in the delivery of customer services to the residents and changes in the community.

Improve the delivery of resident programs. Provide case management to provide resources in employment, education and training.

2010-2011: Hire Resident Program Coordinator and increase program services pending grant funding.

Housing Needs. Based on information provided by the applicable Consolidated Plan, information provided by HUD, and other generally available data, make a reasonable effort to identify the housing needs of the low-income, very low-income, and extremely low-income families who reside in the jurisdiction served by the PHA, including elderly families, families with disabilities, and households of various races and ethnic groups, and other families who are on the public housing and Section 8 tenant-based assistance waiting lists. The Houston County Housing Authority (HCHA) has provided the information regarding our waiting list based on the list as of February 04, 2010. The Public Housing Waiting List is maintained in our computer system. The Public Housing Waiting List is currently closed. Applications are taken in accordance with the HCHA Admissions with a total of 300 applicants waiting for housing. Here is additional information concerning the list.

- The Warner Robins and Houston County Housing Authority has a waiting list of 300 applications. This indicates a significant need for additional housing. The last day the Warner Robins and Houston County Housing Authority accepted applications were on February 04, 2010.
- The Authority maintains a site based waiting list which an applicant chooses a community in which they desire to live.
- There are a large number of single persons on our waiting list that are under age 47. Many of these applicants have disabilities and the HCHA continues to work with other non-profits to identify housing resources for this population.
- The need for family housing continues to be at the one and two bedroom level, with a secondary need for three bedroom units.
- A large numbers of applicants seek other housing assistance because of the waiting period. By increasing affordable housing options, we will be better able to reach these families in need by decreasing the waiting time for an available unit.
- Continue to provide effective maintenance and management policies to minimize the number of public housing units off line.
- Continue to reduce the time to turn a vacated unit.
- Continue to reduce the time to renovate public housing units
- Continue to utilize the ACOP for guidance
- Continue to communicate with the City and local organizations in building partnerships to assist with housing concerns.
- Provide avenues for residents and non residents to express ideas or concerns as it relates to the Housing Authority.
- Explore options in acquiring property or other units to expand housing stock.
- Reduce turnover time and renovation times of public housing units.
