1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

### **Rockport Housing Authority's Policy On Violence Against Women Act (VAWA)**

The Rockport Housing Authority complies with the provisions set forth by VAWA. The Rockport Housing Authority works with other service providers such as Crisis Connection (Domestic Violence Task Force) that covers the needs of the entire county. We work closely with Child Protective Services and the Police Department to help child and adult victims of domestic violence, dating violence, or stalking obtain affordable housing. A community resource guide is given out to all new clients and is available at the office. In this brochure they will find resources from all the Social Services facilities that can help them in their time of need. The PHA has also set a preference for women in this situation. Written documentation from an advocate, police department, court records, doctors, family, neighbor or friend. The verification will be looked at on a case by case basis. Without the written verification, the PHA cannot allow the preference on the waiting list. All information provided to the PHA is kept strictly confidential. Notice of these rights under the **Violence Against Women Act (VAWA)** is provided to residents.
