We will Continue to take affirmative measures through modernization to provide a suitable living Environment for families with disabilities such as providing accessible ramps, lever door knobs and Sidewalks to enable individuals access to dwelling units.</b>  <b>Goals and Objectives are on target from the last 5-year plan. The PHA has had to use some of the modernization monies for operating costs however the installation of roofing, gutters and downspouts is complete and the PHA continues to complete HVAC upgrades as needed.</b>  <b>Over the next five years the Housing Authority will be concentrating in interior renovations such as bathroom upgrades, kitchen upgrades and replacement of flooring.
