

The VPHA has made many improvements to the facility over the past 5 years. Units have been completely re-roofed with metal roofs, showers have been installed at Miriah Lane, which previously only had bath tubs. Landscaping has been updated with new trees and sod for beautification and sidewalks and curbs have been repaired and additional sidewalks have been added. The Oxidation pond system has been updated with new equipment to allow the pond to work more efficiently, and to increase production. A new park has recently been completed complete with a playground system for the children, benches picnic tables and shaded areas.


