Progress made since the previous five-year plan includes continued efforts to adequately maintain housing stock with improvements funded through the Capital Fund Program and appropriate training of personnel in inspections and maintenance. Ongoing efforts continue in improving customer service through delivery of program information and response to service requests, and cooperation and assistance from local agencies that provide supportive services to enable elderly and disabled residents to enjoy and maintain independent living. <b>PHA Goal 3:</b> Increase assisted housing choices. Progress made since the previous five-year plan includes continued efforts to investigate development of income-based assisted living and exploration of alternative programs to conventional housing; i.e. homeownership and rental rehabilitation. <b>HUD Strategic Goal 2:</b> Improve community quality of life and economic vitality. <b>PHA Goal:</b> Provide an improved living environment. <b>Objectives:</b> implement measures to deconcentrate poverty by bringing higher income public housing households into lower income developments, implement measures to promote income mixing in public housing by assuring access for lower income families into higher income developments, designate developments or building for particular resident groups (elderly, persons with disabilities). Progress made since the previous five-year plan includes adoption of admission preferences for working families which has resulted in higher income families moving into lower income neighborhoods, and adoption of a smoke-free buildings policy which has resulted in increased interest and an improved living environment. While maintaining the required deconcentration threshold of 40% of new admissions at or below 30% of AMI, the housing commission has realized increased revenue from higher income families and has been able to reduce vacancies by offering affordable rents to working families. <b>HUD Strategic Goal 3:</b> Promote self-sufficiency and asset development of families and individuals. <b>PHA Goal:</b> Promote self-sufficiency and asset development of assisted households. <b>Objectives:</b> Increase the number and percentage of employed persons in assisted families, provide or attract supportive services to increase independence for the elderly or families with disabilities. Progress made since the previous five-year plan includes educating residents about incentives for employment and self-sufficiency efforts as an alternative to performing Community Service, enforcing the requirement for Community Service for eligible individuals and/or families, and continued outreach efforts to local agencies that provide support and/or services to elderly and disabled individuals in order to assist in maintaining independent living. <b>HUD Strategic Goal 4:</b> Ensure Equal Opportunity in Housing for all Americans. <b>PHA goal:</b> Ensure equal opportunity and affirmatively further fair housing. <b>Objectives:</b> Undertake affirmative measures to ensure access to assisted housing, regardless of race, color, religion, national origin, gender, familial status or disability. 6. **Designated Housing for Elderly and Disabled Families.** With respect to public housing projects owned, assisted, or operated by the PHA, describe any projects (or portions thereof), in the upcoming fiscal year, that the PHA has designated or will apply for designation for occupancy by elderly and disabled families. Additionally, the form shall be used for the following purposes:

- (a) To submit the initial budget for a new grant or CFFP;
- (b) To report on the Performance and Evaluation Report progress on any open grants previously funded or CFFP; and
- (c) To record a budget revision on a previously approved open grant or CFFP, e.g., additions or deletions of work items, modification of budgeted amounts that have been undertaken since the submission of the last Annual Plan. The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

**8.2 Capital Fund Program Five-Year Action Plan**

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

**8.3 Capital Fund Financing Program (CFFP).** Separate, written HUD approval is required if the PHA proposes to pledge any

portion of its CFP/RHF funds to repay debt incurred to finance capital improvements. The PHA must identify in its Annual and 5-year capital plans the amount of the annual payments required to service the debt. The PHA must also submit an annual statement detailing the use of the CFFP proceeds. See guidance on HUD's website at:




