- (c) To record a budget revision on a previously approved open grant or CFFP, e.g., additions or deletions of work items, modification of budgeted amounts that have been undertaken since the submission of the last Annual Plan. The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

8.2 Capital Fund Program Five-Year Action Plan

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

portion of its CFP/RHF funds to repay debt incurred to finance capital improvements. 1. The Plan is consistent with the applicable comprehensive housing affordability strategy (or any plan incorporating such strategy) for the jurisdiction in which the PHA is located.
2. The Plan contains a certification by the appropriate State or local officials that the Plan is consistent with the applicable Consolidated Plan, which includes a certification that requires the preparation of an Analysis of Impediments to Fair Housing Choice, for the PHA's jurisdiction and a description of the manner in which the PHA Plan is consistent with the applicable Consolidated Plan.
3. The PHA certifies that there has been no change, significant or otherwise, to the Capital Fund Program (and Capital Fund Program/Replacement Housing Factor) Annual Statement(s), since submission of its last approved Annual Plan. The Capital Fund Program Annual Statement/Annual Statement/Performance and Evaluation Report must be submitted annually even if there is no change.
4. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
6. The PHA certifies that it will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.

 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(c)(1).
9. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
10. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
11. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.

13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments), 2 CFR Part 225, and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments).
19. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
20. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.
21. The PHA provides assurance as part of this certification that:
 - (i) The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;
 - (ii) The changes were duly approved by the PHA Board of Directors (or similar governing body); and
 - (iii) The revised policies and programs are available for review and inspection, at the principal office of the PHA during normal business hours.
22. The PHA certifies that it is in compliance with all applicable Federal statutory and regulatory requirements.



The Traverse City Housing Commission does not participate in lobbying activities.

6.0 PHA Plan Update.

1. At this time there have no changes to the manner in which the TCHC operates its waiting list. There is a possibility of changes in the waiting list procedures if the TCHC receives a grant for the Family Unification Program Vouchers which it has applied for. If funding is received the TCHC will add preferences to the waiting list for family unification and youths aging out of foster care, in accordance with HUD guidelines and the grant application submitted for this program. (See the current TCHC Admission and Continued Occupancy Policy and Section 8 Administrative plan for additional information).

2. The financial resources that the TCHC anticipates receiving funding from include tenant rents, HUD rental subsidy, roof top leases (used for excess repairs/purchases not covered by operating budget or capital fund program for capital improvements), Family Self-Sufficiency Coordinator grant (wages and benefits, only), HCV HAP and Administrative Fees (wages, benefits, travel, training, etc.), Grand Traverse County for Community Residential Liaison position (wages, benefits, travel, training, administrative expenses, etc.), Grand Traverse County for CDBG Administrative fees earned (wages, benefits, travel, training, administrative expenses, etc.), Grand Traverse County for Home Purchase Repair Program administrative fees earned (wages, benefits, travel, training, administrative expenses, etc.), laundry and pop machine revenue (continue providing the soda for pop machine, electricity (for both pop machine and laundry equipment)).

3. At this time there are no suggested changes to the rent structure (flat rents and minimum rents) currently charged for all TCHC communities. A review of the area rents and FMR's will be conducted in the future and a determination will be made as to whether the current charges are sufficient or if changes should be made.

4. The TCHC has in place a maintenance plan which directs the manner in which the properties under the TCHC control are maintained, including a pest management program. The TCHC maintains an Administrative Plan for the Section 8 HCV program and an Admission and Continued Occupancy Policy for the low rent program.

5. Attached to this Plan is a copy of the Grievance Procedure for both the Low-Rent and Section 8 HCV programs.

6. The TCHC does not have units specifically designated for elderly or disabled families/individuals.

7. (1) Community Service Requirement – required by HUD is the only program in place. **(2)** Attached to this plan is the Community Service Policy of the TCHC. **(3)** The TCHC strives to motivate residents who are required to participate in community service/economic self-sufficiency. Participation in the community service/economic self-sufficiency program is reviewed on an annual basis at re-certification time. Residents who may have been participating in welfare programs or have been unemployed for a period of 1 year are eligible for income disallowance.

8. The TCHC works closely with the City Police Department and their Sector Patrol Officer. The TCHC also has a County Sheriff's Deputy living on site at their family community to deter crime. This practice has been in place for approximately 11 years and has served to keep crime, i.e., destruction of property, drugs, domestic violence, etc., at a bare minimum. This statement can be measured by the fact that upon opening the apartment community, police activity was on an almost daily basis,

compared to the current amount of activity with a police officer living on site. The presence of this police officer has served us well in providing our residents with a sense of security.

9. Pets are allowed at all TCHC public housing communities. See the attached Pet Policy for additional information.

10. The TCHC has in the past reviewed its programs for impediments to the civil rights of all applicants and participants. There were no impediments noted during that review. The TCHC will continue to observe and monitor its programs for potential civil rights impediments.

11. Fiscal Year Audit ending June 30, 2009 showed the TCHC in good financial condition with no findings noted in its operations.

12. The TCHC is not required to carry out asset management functions.

13. In answer to all three (3) questions of Part 13, the TCHC does not directly offer programs to its participants. The TCHC works with our local domestic violence agency who has staff and volunteers who are specifically trained to handle the issues that a person(s) who is a victim of DV. The staff and volunteers are equipped to provide the assistance that a victim of DV may require for their emotional needs through counseling and shelter, if needed.

The TCHC will take the appropriate actions, as required by HUD, in response to an incident or incidents of domestic violence, dating violence or stalking, affecting individuals assisted by the TCHC.

(d) Homeownership. The TCHC has had a Section 8 HCV Homeownership program in place since April 1, 2001. Since the inception of the program, the TCHC has experienced 4 families moving from a rental situation to becoming a homeowner, utilizing their HCV voucher. The TCHC continues to work with our HCV participants to garner their interest in the homeownership program.

(e) Project-based Vouchers. In accordance with the most recent 5-Year Plan (2008 – 2012), the TCHC has entered into a Project-based Voucher agreement with two (2) local supportive housing apartment communities. Through these agreements, the TCHC is providing 14 units of project based assistance. There is a possibility of working with one of the local supportive housing providers in the future by providing additional project-based vouchers elsewhere.

January 7, 2010
Resident Advisory Board Meeting

PRESENT: Chris Mazur, Louis Kanan, Marjorie Allen, Louise Dworski, Lee Delancey, Shirley Elaikis, James Friend, Suzanne Donohoe

First order of business was to introduce each resident. Once introductions were completed the RAB began a review of the policies that had been revised.

PET POLCIY: A couple of changes and additions were discussed. The RAB suggested clarifying the number of birds and provide further language with respect to aquariums. It was also mentioned to add piranha to the examples of pets not allowed. Suggestion was made to add language regarding fertilizing the lawn and the owner's responsibility to keep the pet off the lawn until the fertilizer had dried; providing language that the owner holds the TCHC harmless and they accept full responsibility. The TAB members felt that the monthly pet fee of \$10 was high. A compromise was reached to change the monthly pet fee to \$5 each month and remove the pre-payment language. It was suggested that the monthly pet fee be re-visited in a couple of years. **ACTION:** The suggested changes suggested by the RAB have been added to the policy.

TRANSFER POLICY: Further clarification was requested on the transfer of Security Deposit from the old apartment to the new apartment. **ACTION:** The suggested wording of the RAB was added to the policy.

PEST CONTROL POLICY: First paragraph – remove Maintenance Supervisor, insert Executive Director. **ACTION:** The proposed changes are appropriate as the TCHC no longer has a Maintenance Supervisor.

DISPOSITION POLICY: A couple of wording changes were suggested in order to help the policy read better. **ACTION:** The changes allow the policy language to flow better – changes added.

CREDIT CARD POLICY: Add an "A" to the last word in the second line, first paragraph to complete the sentence

COMMUNITY SERVICE POLICY: Page 2, 2nd line – change "do" to "does at the head of this section. **ACTION:** Make changes where appropriate

MAINTENANCE PLAN: Several wording changes were suggested.
ACTION: The suggestion actions were taken under advisement and added to the lease agreement.

**PHA Certifications of Compliance with the PHA Plans and Related Regulations:
Board Resolution to Accompany the PHA 5-Year and Annual PHA Plan**

Acting on behalf of the Board of Commissioners of the Public Housing Agency (PHA) listed below, as its Chairman or other authorized PHA official if there is no Board of Commissioners, I approve the submission of the 5-Year and/or Annual PHA Plan for the PHA fiscal year beginning July 1, 2010, hereinafter referred to as "the Plan", of which this document is a part and make the following certifications and agreements with the Department of Housing and Urban Development (HUD) in connection with the submission of the Plan and implementation thereof:

1. The Plan is consistent with the applicable comprehensive housing affordability strategy (or any plan incorporating such strategy) for the jurisdiction in which the PHA is located.
2. The Plan contains a certification by the appropriate State or local officials that the Plan is consistent with the applicable Consolidated Plan, which includes a certification that requires the preparation of an Analysis of Impediments to Fair Housing Choice, for the PHA's jurisdiction and a description of the manner in which the PHA Plan is consistent with the applicable Consolidated Plan.
3. The PHA certifies that there has been no change, significant or otherwise, to the Capital Fund Program (and Capital Fund Program/Replacement Housing Factor) Annual Statement(s), since submission of its last approved Annual Plan. The Capital Fund Program Annual Statement/Annual Statement/Performance and Evaluation Report must be submitted annually even if there is no change.
4. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
6. The PHA certifies that it will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
7. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
8. For PHA Plan that includes a policy for site based waiting lists:
 - The PHA regularly submits required data to HUD's 50058 PIC/IMS Module in an accurate, complete and timely manner (as specified in PIH Notice 2006-24);
 - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;
 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(c)(1).
9. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
10. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
11. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.

13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments), 2 CFR Part 225, and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments).
19. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
20. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.
21. The PHA provides assurance as part of this certification that:
 - (i) The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;
 - (ii) The changes were duly approved by the PHA Board of Directors (or similar governing body); and
 - (iii) The revised policies and programs are available for review and inspection, at the principal office of the PHA during normal business hours.
22. The PHA certifies that it is in compliance with all applicable Federal statutory and regulatory requirements.


