### **Progress Report**

**Goal One: The Grand Rapids HRA was successful in securing a provider for an assisted living service in our 401 River Road building. The service provided meals, laundry, healthcare and an exercise program for tenants. Our workforce ensures continuity with our tenants and we maintain our buildings at a level of 97 – 100% occupancy.**

**Goal Two: The Grand Rapids HRA is currently in the process of acquisition of a 48 unit section 8 complex. The HRA has been negotiations since February of 2009 and has a signed purchase agreement in place. We are now in the process to obtain funding through grants and loans. We will not know the final result until February of 2010.**

**Goal Three: We have three separate funds at the Grand Rapids HRA and all funds operate so that income exceeds expenses every year with no drop in comfort to our tenants or deficiencies to our buildings.**
