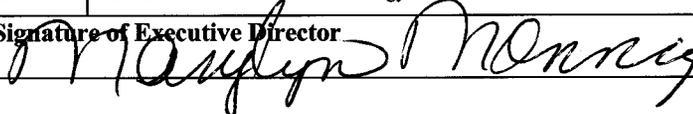

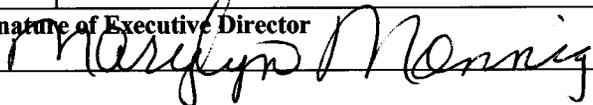

**A Goal of the Glasgow Housing Authority is to fully comply with the Violence Against Women Act, (VAWA) It is our objective to work with others to prevent offences covered by VAWA to the degree we can. The Glasgow Housing Authority provides or offers the following activities, services, or programs, either directly or in partnership with other service providers, to child or adult victims of domestic violence, dating violence, sexual assault, or stalking. The Glasgow Housing Staff works with the Glasgow Police Department and Howard County Sheriffs Department and also closely with the Prosecuting Attorney office and Probation and Parole officers and Division of Family Services in all surrounding counties. The Glasgow Housing Authority will direct child and adult victims to local agencies that offer help that may include, transportation services, counseling, food, medical etc. Also GHA will guide victims to existing local agencies that provide help in many different areas. GHA also encourages local Police Departments to actively patrol all Housing Authority properties and to alert Housing Authority Staff if any such individuals are seen and or if Police Department is aware of any such individual in the area. GHA also provides a monthly newsletter that addresses specific rights of applicants and Residents that gives assurances that we will actively participate with local departments to insure that all are aware of their individual rights as to the VAWA and that their information will be held in strict confidentiality.**
