The total population of the county is 53,309. Darke County has a very small minority population which is 1.9%. The county has a population 16.4% of persons 65 years of age and older. The LMI is 37.03%.</b></p> <p><b>Fair Housing Impediments is the need for more affordable and available housing.</b></p> <p><b>The waiting list of the DCMHA now has 398 families waiting at this time. Of this total 113 or 28 % are Elderly Head of Households. 268 or 67% are Female head of households and 130 or 33% are male head of households. Disabled Households are 132 or 33% and households with children 255 or 64% of the 398 applicants on the Waiting List are families with children. Of these applicants 326 or 82% households are at or below 30% of the Median Income. Very low income applicants are 70 households or 18% of the Waiting List.</b></p> <p><b>Households on the Waiting List are comprised of one child is 113 or 28%, two children 80 or 20%, three children 28 or .07%, four children 7 or .02%, five children .01% and lastly 1or .002% family with nine children.</b></p> <p><b>Of those applicants on the Section 8 Housing Choice Voucher Waiting List the Primary Race Recap states that 361 or 91% are white, 8 or .02% are Black, 4 or .01% are Native American/Native Alaskan, and 10 or .03% unknown. The Ethnicity Recap states that 101 or 25% are Non Hispanic and 4 or .01% are Hispanic Applicants.</b></p> <p><b>Darke County Metropolitan Housing Authority works with landlords and families with disabilities regarding accessibility to housing units available to them. Home visits are conducted as needed. Use of a higher payment standard (with approval) can be used to obtain a suitable housing unit. Extensions are provided when a family with a disability is unable to obtain a suitable housing. DCMHA will apply for special-purpose vouchers targeted to families with disabilities, should they become available. DCMHA works closely with local non-profit agencies, tax credit housing and combination that assist families with disabilities.</b></p> <p><b>DCMHA turn -over is 35 or 12% per year which keeps families on the waiting list for a longer period of time. The wait is now approximately two years. Darke County has lost industry and families are doubling up or couch hopping even though quality rental dwellings are available, there are not enough vouchers for families to utilize. The Darke County Metropolitan Housing Authority's Section 8 Housing Choice Voucher Waiting List is currently open.</b></p>

- (c) To record a budget revision on a previously approved open grant or CFFP, e.g., additions or deletions of work items, modification of budgeted amounts that have been undertaken since the submission of the last Annual Plan. The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

**8.2 Capital Fund Program Five-Year Action Plan**

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

**VIOLENCE AGAINST WOMEN ACT (VAWA)**

The Darke County Metropolitan Housing Authority has and continues to work diligently to educate and enforce individuals regarding their rights under the VAWA, although there is no written agreement among the agencies, these collaborations will continue.

The Authority notifies all Section 8 Landlords and prospective participants of the VAWA Act and assists victims when needed to insure their safety and continued participation in the Section 8 Program. Tenants have and will continue to receive notification of the Law at Annual Recertification and were asked to sign that they did receive this information.

Staff has knowledge of available programs in the community and will continue to make referrals.

The Director and Assistant Director attend the annual meeting of the Shelter for Violence and they work with us on the Continuum of Care Point in Time Study.

Ongoing staff training will be conducted to educate staff about making referrals for services that victims can utilize. Educational Programs and distribution of information will also be completed to educate residents regarding this issue.




