The siding project was an approved item in the Agency 5-year plan and so a Public Hearing was not required at that time. The project was publicly advertised for bid and Dzielak Construction was awarded as low bidder. The project is 95% complete at this time.

Mrs. Allen explained that the purpose of this hearing was to comment on the revised 5 year Action Plan that was being submitted to HUD to reflect changes in job items since the ARRA monies were being used to complete the siding project. Since the 2008 and 2009 Capital Funds were going to be combined to cover the cost of the siding project changes were made to those grants. The 2008 grant would now cover the approved items of the 2011 grant which would replace hallway floor tiles, stair treads, and an added item of exterior/interior lighting fixtures . The 2009 grant will be used to cover the cost of a drainage project. Due to heavy rains this season a situation arose at Prospect Park Apartments that required additional drainage to handle excess waters now coming down from the Park above.

Future job items in the action plan include replacing refrigerators and stoves, Kitchen floor tiles and counter tops and bathroom floor tiles and vanities in 43 apartments located at Prospect Park Apartments, 746 Prospect Street, Susquehanna, Pa.

There being no further questions or public comment, the hearing was adjourned at 7:20 p.m.
