1. Resident Advisory Board (RAB) Comments:

The Waverly Housing Authority staff and Resident Advisory Board (RAB) members discussed the FY 2010 Agency Plan and the detailed list of proposed FY 2010 and 5-Year capital fund improvements at formal RAB and Public Hearings meetings conducted on July 7, 2010. The following suggestions were made:

- **What is the status of the kitchen cabinets in the units that were recently flooded?**
WHA Response: *Kitchens that were affected will not require new cabinets.*
- **Security cameras?**
WHA Response: *The WHA will include it in the Five-Year CFP budget. Installation will depend on funding levels.*
- **Can the WHA install speed bumps?**
WHA Response: The streets are maintained by the City of Waverly; therefore this improvement would have to be approved by the City. The WHA does not have the authority to make any street/right of way changes and/or improvements. In the past the City has not been responsive to this request.

2. Proposed Goals and Objectives:

PHA Goal: Improve the quality of assisted housing

Objectives:

- Renovate or modernize public housing units in order to provide better housing, promote energy conservation, and reduce future maintenance repair costs.

PHA Goal: Promote energy efficiency practices and products when performing rehabilitation, repair and replacement.

Objectives:

- Incorporate, when applicable, Energy Star Program qualified products and practices.

PHA Goal: Support the requirements of the Violence Against Women Act (VAWA)

Objectives:

- Implement policies and procedures that support the VAWA
- Continue VAWA resident awareness efforts

3. Progress in Meeting Goals and Objectives from 2005 Five-Year Plan:

Goal: Expand the supply of assisted housing

Progress:

- The WHA administration and maintenance staff continue our ongoing coordination efforts to reduce public housing vacancies and unit turn-around time.

Goal – Improve the quality of assisted housing

Progress:

- The WHA is making extra efforts to keep residents informed of policies and programs through frequent notices and meetings related to the Agency Plan process.
- The WHA is continually upgrading and modernizing its public housing units. With the administration of the Capital Fund Program, we are able to better plan and implement improvements.

- The implementation of our recent capital improvements has enabled the WHA to continue with the installation of new tankless water heaters and door/hardware improvements.
- The WHA continues our efforts to attain high performer status.

Goal – Increase assisted housing choices

Progress:

- The WHA continues our ongoing outreach efforts to potential voucher landlords.

Goal – Improve community quality of life and economic vitality

Progress:

- The WHA coordinates drug and crime prevention efforts with the local law enforcement officials. Police provide on-going monitoring and crime data to the WHA for analysis and action.

Goal – Promote self-sufficiency and asset development of assisted households

Progress:

- The WHA continues to promote self-sufficiency through the coordination of services and activities offered by the State of Tennessee “Families First” welfare to work program.
- The WHA also promotes adult education and GED classes.

Goal – Ensure equal opportunity in housing for all Americans

Progress:

- The WHA continues to operate its public housing program to ensure equal access to all regardless of race, color, religion, national origin, sex, familial status and disability. Our inspections, maintenance and modernization programs are spread equally among all of our units within our developments.
- The WHA provides training to Public Housing applicants and residents.

a. Substantial Deviation from the 5-Year Plan

In addition, if there is a change in funding of greater than 20 percent of the Operating Budget and/or the Comprehensive Grant Program, this will be considered an amendment/modification to the Plans, except for emergencies that are beyond the control of the PHA. If the item/activity is included in the 5-Year Comprehensive Grant Program, it will not be considered a significant change although the cost may exceed the 20 percent threshold; therefore, not requiring HUD review and approval.

3-III.F. PROHIBITION AGAINST DENIAL OF ASSISTANCE TO VITIMS OF DOMESTIC VIOLENCE, DATING VIOLENCE, AND STALKING (Pub.L. 109-162)

The Violence against Women Reauthorization Act of 2005 (VAWA) prohibits denial of admission to an otherwise qualified applicant on the basis that the applicant is or has been a victim of domestic violence, dating violence, or stalking. Specifically, Section 607(2) of VAWA adds the following provision to Section 6 of the U.S. Housing Act of 1937, which lists contract provisions and requirements for the public housing program;

Every contract for contributions shall provide that...the public housing agency shall not deny admission to the project to any applicant on the basis that the applicant is or has been a victim of domestic violence, dating violence, or stalking if the applicant otherwise qualifies for assistance or admission, and that nothing in this section shall be construed to supersede any provision of any Federal, State, or local law that provides greater protection than this section for victims of domestic violence , dating violence, or stalking.

Definitions

As used in VAWA:

- The term *domestic violence* includes felony or misdemeanor crimes of violence committed by a current or former spouse of the victim., by a person with whom the victim shares a child in common, by a person who is cohabitating with or has cohabitated with the victim as a spouse, by a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction receiving grant monies, or by any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction.
- The term *dating violence* means violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim; and where the existence of such a relationship shall be determined based on a consideration of the following factors:
 - ✓ The length of the relationship
 - ✓ The type of relationship
 - ✓ The frequency of interaction between the persons involved in the relationship

- The term *stalking* means:
 - ✓ To follow, pursue, or repeatedly commit acts with the intent to kill, injure, harass, or intimidate; or
 - ✓ To place under surveillance with the intent to kill, injure, harass or intimidate another person; and
 - ✓ In the course of, or as a result of, such following, pursuit, surveillance, or repeatedly committed acts, to place a person in reasonable fear of the death of, or serious bodily injury to, or to cause substantial emotional harm to (1) that person, (2) a member of the immediate family of the person, or (3) the spouse or intimate partner of that person.

- The term *immediate family* means, with respect to a person:
 - ✓ A spouse, parent, brother, or sister, or child of that person, or an individual to whom that person stands in the position or place of a parent; or
 - ✓ Any other person living in the household of that person and related to that person by blood or marriage.

Notification and Victim Documentation

PHA Policy

The PHA acknowledges that a victim of domestic violence, dating violence, or stalking may have an unfavorable history that would warrant denial under the PHA's policies. Therefore, if the PHA makes a determination to deny admission to an applicant family on the basis of an unfavorable history, the PHA will include in its notice of denial a statement of the protection against denial provided by VAWA and will offer the applicant the opportunity to provide documentation affirming that the cause of the unfavorable history is that a member of the applicant family is or has been a victim of domestic violence, dating violence, or stalking.

The documentations must include two elements:

1. A signed statement by the victim that provides the name of the perpetrator and certifies that the incidents in question are bona fide incidents of actual or threatened domestic violence, dating violence, or stalking.
2. One of the following:
 - A police or court record documenting the actual or threatened abuse, or

A statement signed by an employee, agent, or volunteer of a victim service provider; an attorney; a medical professional; or another knowledgeable professional from whom the victim has sought assistance in addressing the actual or threatened abuse. The professional must attest under penalty of perjury that the incidents in question are bona fide in incidents of abuse, and the victim must sign or attest to the statement.

The applicant must submit the required documentation with her or his request for an informal hearing (see Section 14-I.B) or must request an extension in writing at that time. If the applicant so requests, the PHA will grant an extension of 10 business days, and will postpone scheduling the applicants in formal hearing until after it has received the documentation or the extension period has elapsed. If after reviewing the documentation provided by the applicant the PHA determines the family is eligible for assistance, no informal hearing will be scheduled and the PHA will proceed with admission of the applicant family.

Perpetrator Removal or Documentation of Rehabilitation

PHA Policy

In cases where an applicant family includes the perpetrator as well as the victim of domestic violence, dating violence, or stalking, the PHA will proceed as above but will require, in addition, either (a) that the perpetrator be revoked from the applicant household and not reside in the public housing unit or (b) that the family provide documentation that the perpetrator has successfully completed, or is successfully undergoing rehabilitation or treatment.

If the family elects the second option, the documentation must be signed by an employee or agent of a domestic violence service provider or by a medical or other knowledgeable professional from whom the perpetrator has sought or is receiving assistance in addressing the abuse. The signer must attest under penalty of perjury to his or her belief that the rehabilitation was successfully completed or is progressing successfully, the victim and perpetrator must also sign or attest to the documentation.

This additional documentation must be submitted within the same time frame as the documentation required above from the victim.

PHA Confidentiality Requirements

All information provided to the PHA regarding domestic violence, dating violence, or stalking, including the fact that an individual is a victim of such violence or stalking, must be retained in confidence and may neither be entered into any shared database nor provided to any related entity, except to the extent that the disclosure (a) is requested or consented to by the individual in writing, (b) is required for use in an eviction proceeding, or (c) is otherwise required by applicable law.
