



10.0 Additional Information

The Hamilton Housing Authority has met the 2005 plan by maintaining and improving the apartments by upgrading and remodeling bathrooms, replacing aged refrigerators and cook stoves. Apartments have been upgraded with dry wall repair and replacement along with painting as needed. Ground work has been done to remove trees and shrubs that could have caused damages to apartments and improve the living quality of the residence. Drainage concerns were addressed and corrected to prevent water damage from occurring in some apartments.

General upgrades of plumbing and electrical work was done on an as needed bases. This included but not limited to new water heaters, faucets, building drain lines, replacement of electrical panels to upgrade for safety. Replacement of HVACs as needed to meet the needs of tenants on an as needed basis.

Painting and rehab of apartments are done on an as needed basis before tenants move in. This has helped keep apartments in a high standard of repair.
