Include a report on the progress the PHA has made in meeting the goals and objectives described in the previous 5-Year Plan.</p> <p>As a division of West Valley City, the West Valley City Housing Authority is directly involved in the development of the Consolidated Plan. The influence of the Housing Authority has resulted in an increased awareness and attention to housing needs, as well as the issues facing low-income residents. The City has committed support for low income housing programs and housing units for the homeless population as well as disabled and elderly citizens and those qualifying for Shelter Plus Care and HOPWA funds. The plan also includes the following commitments:</p> <p>a: To promote the highest quality of life economically feasible, the West Valley City Housing Authority will, on an annual basis, identify and assess the quality and level of services provided to residents.</p> <p>b: Provide staff and Board of Directors with the tools necessary to effectively and efficiently execute their roles and responsibilities specific to the West Valley City Housing Authority.</p> <p>c: West Valley City Housing Authority will develop and nurture a positive image in our community.</p> <p>d: Increase and create additional affordable housing options for West Valley City residents.</p> <p>In addition it is the PHA's goal to expand the supply of assisted housing, improve the quality of assisted housing, increase assisted housing choices, improve community quality of life and economic vitality; Promote self sufficiency and asset development of families and individuals and ensure equal opportunity an affirmatively further fair housing.</p> <p>The Housing Authority has spent the last five years working to expand the supply of assisted housing. Some efforts have been more successful than others. All applications for additional Section 8 Vouchers have not been approved. However, five to seven HOPWA vouchers have been funded through Salt Lake City. The Housing Authority was able to reapply and receive approval to administer an average of 21 Shelter Plus Care vouchers which were approved and funded by HUD to the Salt Lake County Continuum of Care. Salt Lake County Continuum of Car Collaborates with West Valley City and many other partners.</p> <p>The goal to improve the quality of assisted housing was met with the housing authority improving both their PHAS and SEMAP scores. Capital Funds and CDBG funds have been used to remodel or rehabilitate several of the public housing units during the last five years. The goal to increase housing choices was met by counseling tenants on voucher mobility and educating new landlords about the program.</p> <p>Provide an improved living environment by implementing measures to de-concentrate poverty by bringing higher income public households into lower income developments is one goal that really cannot be quantified because the public housing units are single family homes scattered throughout residential sub-divisions. The West Valley City Housing Authority also strives to ensure equal housing opportunities for all Americans by advertising accessible units, working with clients who have special needs, post Equal Housing Opportunities advertisements among other things.</p>

The Voucher Program will accomplish this by careful review of payment standards within our county jurisdiction, maximizing the number of affordable units available within its current resources, and applying for additional funding, when available. We will maintain or increase Section 8 lease-up rates by continuing to market the program to landlords, particularly those outside areas of high concentrations of poverty and minority populations. It is important to continue effectively screening applicants to increase landlord acceptance of the program, and further develop mutually supportive relationships that expand our ability to provide affordable housing while enhancing the value of investment. We will continue to conduct ongoing public relations and outreach with affordable housing advocates, social service agencies and landlords concerning program availability, thereby enhancing program visibility.</p> <p>Creating new initiatives that will increase community sustainability through affordable housing options can be achieved by coordination, working and/or partnering with other agencies and organizations in providing new and improved accessibility to housing and supportive services for low-income, very low-income, and extremely low-income families.</p> <p>Educating the public about the importance of safe, decent, affordable housing will remain a priority. Communities will become more viable and strengthened through economic development and improved infrastructure and services. This creates a safe and suitable living environment through accessibility to various facilities and services and other critical community needs for the low-income, very low-income, and extremely low-income families.</p>

The Authority has been a consistent "High Performer" in the Section Eight Management Assessment Program (SEMAP) rating system and had no findings from a Fiscal Year 2009 Review. The Section 8 Housing Choice Voucher Administrative Plan to incorporate the provisions of the Violence Against Women Act (VAWA) and implementation of Enterprise Income Verification (EIV) requirements. It also addressed Limited English Proficiency (LEP) requirements. In addition, the Voucher Program has been granted additional funds from the HOME Program in order to continue the implementation of a Tenant-Based Rental Assistance (TBRA) Program, which will allow the Authority to expand the number of very low-income and extremely low-income families it can assist.</p> <p>(b) <b>Significant Amendment and Substantial Deviation/Modification.</b> Provide the PHA's definition of "significant amendment" and "substantial deviation/modification"</p> <p>It is the intent of the West Valley City Housing Authority to adhere to the mission, goals and objectives outlined in the Five-Year Plan. 8.1 **Capital Fund Program Annual Statement/Performance and Evaluation Report.** PHAs must complete the *Capital Fund Program Annual Statement/Performance and Evaluation Report* (form HUD-50075.1), for each Capital Fund Program (CFP) to be undertaken with the current year's CFP funds or with CFFP proceeds. Additionally, the form shall be used for the following purposes:

- (a) To submit the initial budget for a new grant or CFFP;
- (b) To report on the Performance and Evaluation Report progress on any open grants previously funded or CFFP; and
- (c) To record a budget revision on a previously approved open grant or CFFP, e.g., additions or deletions of work items, modification of budgeted amounts that have been undertaken since the submission of the last Annual Plan. The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

#### 8.2 Capital Fund Program Five-Year Action Plan

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

8.3 **Capital Fund Financing Program (CFFP).** Separate, written HUD approval is required if the PHA proposes to pledge any

portion of its CFP/RHF funds to repay debt incurred to finance capital improvements. The PHA must identify in its Annual and 5-year capital plans the amount of the annual payments required to service the debt. The PHA must also submit an annual statement detailing the use of the CFFP proceeds. See guidance on HUD's website at:

**9.0 Housing Needs.** Provide a statement of the housing needs of families residing in the jurisdiction served by the PHA and the means by which the PHA intends, to the maximum extent practicable, to address those needs. (Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).

**9.1 Strategy for Addressing Housing Needs.** Provide a description of the PHA's strategy for addressing the housing needs of families in the jurisdiction and on the waiting list in the upcoming year. (Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).

**10.0 Additional Information.** Describe the following, as well as any additional information requested by HUD:

- (a) **Progress in Meeting Mission and Goals.** PHAs must include (i) a statement of the PHAs progress in meeting the mission and goals described in the 5-Year Plan; (ii) the basic criteria the PHA will use for determining a significant amendment from its 5-year Plan; and a significant amendment or modification to its 5-Year Plan and Annual Plan. (Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).
- (b) **Significant Amendment and Substantial Deviation/Modification.** PHA must provide the definition of "significant amendment" and "substantial deviation/modification". (Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan.)

- (c) PHAs must include or reference any applicable memorandum of agreement with HUD or any plan to improve performance. (Note: Standard and Troubled PHAs complete annually).

**11.0 Required Submission for HUD Field Office Review.** In order to be a complete package, PHAs must submit items (a) through (g), with signature by mail or electronically with scanned signatures. Items (h) and (i) shall be submitted electronically as an attachment to the PHA Plan.

- (b) Form HUD-50070, *Certification for a Drug-Free Workplace (PHAs receiving CFP grants only)*
- (c) Form HUD-50071, *Certification of Payments to Influence Federal Transactions (PHAs receiving CFP grants only)*
- (d) Form SF-LLL, *Disclosure of Lobbying Activities (PHAs receiving CFP grants only)*
- (e) Form SF-LLL-A, *Disclosure of Lobbying Activities Continuation Sheet (PHAs receiving CFP grants only)*
- (f) Resident Advisory Board (RAB) comments.
- (g) Challenged Elements. Include any element(s) of the PHA Plan that is challenged.
- (h) Form HUD-50075.1, *Capital Fund Program Annual Statement/Performance and Evaluation Report (Must be attached electronically for PHAs receiving CFP grants only)*. See instructions in 8.1.
- (i) Form HUD-50075.2, *Capital Fund Program Five-Year Action Plan (Must be attached electronically for PHAs receiving CFP grants only)*. See instructions in 8.2.


