





RESPONSE BY AUTHORITY STAFF TO ADVISORY BOARD COMMENTS

As a result of the discussions and recommendations of the Resident Advisory Board, there were no changes made to the “5-Year Plan for Fiscal Years 2010-2014/Annual Plan for Fiscal Year 2010”.

Resident Council was advised that WRHA has assessed the physical needs of our housing units and, due to the age of the buildings, it will be necessary to address the items related to the building envelope such as window replacement, roof replacement and exterior doors first. Items such as elevator modernization, parking lot repaving, plumbing and electrical upgrades, new appliances, new water heaters, new HVAC units and cabinets will also be given priority because they are the key elements needed to provide our tenants with decent, safe and sanitary housing. All of these items are all listed in WRHA’s 5-Year Action Plan

While WRHA will give consideration to meeting the additional needs and suggestions of our tenants, we also have to take into account the lack of funding for non-essential items such as garbage disposals, curtains and shades in common areas, and picnic tables.

Resident Council was advised that some of the items such as repainting the exterior doors, dumpster enclosures, additional landscaping, and bike racks are all items WRHA will be working toward accomplishing, using our operating funds, in the 2010-11 fiscal year.

Resident Council was also advised the WRHA does not charge tenants for wear and tear, they are only charged for tenant damages.

Resident Council was told that their suggestions were helpful and that WRHA will take their suggestions into consideration as we move forward with planning for the upcoming fiscal year.
