Use HUD funding with utmost integrity in order to maintain our building, units, and grounds in the best possible condition. We will continue to seek training in order to provide better management and maintenance of the Housing Authority.

We have made great progress within the past five years by: constructing 14 garage stalls; repaving our parking lot and concrete curb and sidewalk work; kitchen and dining room upgrade; and hi-rise toilet and vanity replacement. We also installed a new jack replacement and remodeled the inside of our elevator. Our latest project was a complete remodel of our shower units in each apartment including walls, hardware, doors and base. We also installed a back up generator for our building. Our tenants seem very pleased with the updates and prospective tenants have commented on how well maintained the building and units are kept.

The identification of housing needs must address issues of affordability, supply, quality, accessibility, size of units, and location.</p> <p>In 2009, we saw an influx of calls from people who had lost their jobs and were losing their homes. We directed many of them who did not qualify for housing with us to the other various programs in our community. Now in 2010, we are seeing a shift in our tenant base from elderly to younger disabled. Our tenant base is made up of 74% over age 62 and 26% under age 62. The criteria and requirements are still the same no matter what age. We continue to update our building as projects become necessary. Many of the updates are for items we cannot get the parts for anymore, as with the shower units. As far as accessibility, our building is one block from a supermarket, medical clinic, and park. We have bus service that picks up tenants at the front door. If a tenant needs a handicap accessible feature for their unit, we do our best to accommodate them. All of our tenants are made aware of this when they are briefed at move-in. Our vacancies are low at this time and we have limited turnover. We do not have a waiting list at this time. Our units are income based at 30% and our minimum rent is \$50 with our cap at \$425. This includes all utilities. The present morale in our building is high and many of our tenants help each other out with various tasks. Overall, I am proud of how our tenants have adjusted to each other with the different age groups.</p>
