Through the Rental Assistance Voucher Program we serve the entire county with 68 Rental Assistance Vouchers and 40 Public Housing units. The Ashland County Housing Authority also has 24 miscellaneous units to serve other families in the county.</p> <p>There is a very small minority population in Ashland County with approximately 90% White, 8% American Indian, 2% Misc.</p> <p>The Ashland County Housing Authority is in the process of building 6 units of rental for family housing on Madeline Island. There are no rental units presently available for families that are year round residents of the island. By providing rental housing units and possibly providing vouchers for these units will allow seasonal workers housing year round affordable housing.</p> <p>We do have available public housing units for individuals over the age of 50 available in Mellen, Glidden, and Butternut without a waiting period, so no new units are needed in this area.</p>

3. Upon completion or termination of the activities funded in a specific capital fund program year.




