Based on this mutual goal the Housing Authority continues to partner with the City of Hollywood to benefit low-income residents from the City's "First Time Homebuyer's Program". Participants are counseled by the City's Community Development Division on issues of credit, housing code violations, Fair Housing and the step by step process of homeownership under the Lease Purchase Program. This program has led to 4 single family homes being purchased while a fifth home has recently been added to this total due to NSP funds made available by Federal Funds. The success of this program will thereby create opportunities for homeownership to residents of Hollywood, who without such assistance would not have their dream of homeownership a reality. This collaboration of a partnership is further supported by the acquisition of an Apartment complex consisting of 29 units purchased with NSP funds and additional grants that will allow the Housing Authority to hold title and to manage the property. The City will additionally assist by the procurement of labor and material services needed for the rehabilitation of this three story complex. All tenants will need to qualify at 50% of AMI or less in the household. Further, the Housing Authority has partnered with the Gatehouse Corporation for a Tax Credit Project that will consist of 120 units split evenly between one and two bedrooms. This project is due to be completed by January of 2011 with an estimated cost of 19 million dollars. From 1995 through 2007 the LIHTC program has raised capital for the construction and rehabilitation of 18,865 affordable rental housing projects nationwide. This is the universal method of choice to build affordable rental Housing.

The shortage of 3 bedroom units is largely a historical issue as Hollywood was primarily a retirement area thus, 3 bedroom units which are code compliant are fewer in number than one and two bedrooms. The south-central quadrant of the City has the largest concentration of racial minorities and a lack of affordable rental units. At present the continuing problems of Foreclosures thru-out the City has temporarily increased the rental numbers of single family homes. There are in excess of 22,000 rental units within the City of Hollywood. The majority of residential structures were built prior to 1969.

3. 4. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
6. The PHA certifies that it will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
7. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.

9. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
10. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
11. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.

13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments), 2 CFR Part 225, and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments).
19. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
20. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.
21. The PHA provides assurance as part of this certification that:
 - (i) The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;
 - (ii) The changes were duly approved by the PHA Board of Directors (or similar governing body); and
 - (iii) The revised policies and programs are available for review and inspection, at the principal office of the PHA during normal business hours.
22. The PHA certifies that it is in compliance with all applicable Federal statutory and regulatory requirements.



In accordance with Violence Against Women Act (VAWA) of 2005, the HHA is committed to providing tenant based rental assistance as well as Public Housing assistance to victims of domestic violence, dating violence, sexual assault or stalking in the HHA's jurisdiction. Specifically, the HHA acknowledges that a victim of domestic violence may have an unfavorable history that would warrant denial under the HHA's general policies (i.e. income, assets, history of public housing eviction). In the event a determination to deny admission to an applicant is made, the HHA will include in its Notice of Denial a certification form of Domestic Violence, Dating Violence, Sexual Assault or Stalking HUD 50066. The applicant is offered the opportunity to provide documentation affirming that the cause of the unfavorable history is that a member of the applicant family is or has been a victim of domestic violence. The HHA also prohibits the eviction or the removal of assistance from persons living in Section 8 rental assistance if the asserted grounds for such actions(s) or act(s) are of domestic violence, dating violence, sexual assault or stalking as those terms are defined in the VAWA Act of 2005. All new participants are informed of the Violence Against Women's Act (VAWA) at the Section 8 and Public Housing "Orientation" session as well as annually in the re-certification packet for current participants. Section 8 landlords are informed that they may be required to terminate a lease to ensure the continued safety and protection of the victim and or family members afflicted by domestic violence.

Staff members at HHA continue to attend Seminars held by the Domestic Violence Division of the Broward County Clerk of Courts. Written materials from these seminars are distributed to clients in both English and Spanish. Referrals are made to Women in Distress and Legal Services of Broward County for assistance, thereby affirmatively marketing to local agencies that assist victims with domestic violence as well as educating staff to the rights and protection afforded under the Violence Against Women and Department of Justice Reenactment Act of 2005 (VAWA).
