The Tanglewood Apartments which housed over 368 tenants has been closed since December 31, 2009. Many of them has come to apply with us. As far as we can see, there is an extreme need for low and very-low income housing because of lost jobs and the sinking economy at this time. We have various races, ethnic groups, elderly and families with disabilities that have been housed. At this time most of our units are occupied. The tenant needs are met because of the size, quality, accessibility and the location of their unit is very reasonable. They all are within walking distance (if need be) to schools, shopping centers, churches and bus stops. We also make sure if a family needs upgrading to a unit because of their disability, we will make the necessary accommodation for them.</p>

The PHA feels the sooner an empty apartment is made ready, the faster we can get someone off the waiting list and into a unit.</p>






