Policy Changes/Updates Since 2009

1. Admissions and Continued Occupancy Policy (September 27, 2010)

– Amended minimum rent from \$25.00 to \$50.00 per month.

2. Travel Guide (June 28, 2010)

-established and updated travel policies that outline the rules, processes, procedures and payment for directors and employees of Ayden Housing Authority in order to ensure public funds are expended for travel only when it serves Authority purposes.

3. Personnel Policy

a. Grievance Procedures (June 28, 2010)

-provides direction related to various matters of employment to include procedures for the presentation, consideration and disposition of employee grievances; assure all employees that a response to the complaints and grievances will be prompt and fair; clearly outline the purpose and process for resolving grievances made by an employee of the Authority.

b. Rules for Conduct, Safety and Health (June 28, 2010)

-provides direction related to various matters of employment to include procedures for the rules for conduct, safety and health; assure all employees that a response to any misconduct will be prompt and fair; clearly outline the rules and process for resolving misconduct made by an employee of the Authority.

c. Sexual Harassment Policy (June 28, 2010)

-provide direction related to various matters of employment to include procedures for the presentation, consideration and disposition of sexual harassment policy; assure all employees that a response to the complaints will be prompt and fair; clearly outlines the purpose and process for resolving complaints made by an employee of the Authority.

4. Admissions and Continued Occupancy Policy (January 11, 2010)

Changes/updates include the following that are underlined:

A. Page 6, Section B, 2. (d)

Provides documentation of Social Security numbers for all family members, or certifies that they do not have Social Security numbers and will disclose at a later date if they obtain one; and

B. Pages 7 and 8, Section C, 4. (a)

However, if the applicant did not respond because of the applicant's disability or hospitalization, PHA may reinstate the applicant to the former position on the waiting list after verification of such disability or hospitalization through independent sources.

C. Page 35, VI Eligibility for Continued Occupancy, Annual Reexaminations and Remaining Family members, Section A, 3.

All family members must have Social Security numbers or have certifications on file indicating they have no Social Security number and will disclose the Social Security Number if they obtain one.

D. Page 35, VI Eligibility for Continued Occupancy, Annual Reexaminations and Remaining Family Members, Section C, 1.

Regular reexaminations: PHA will, at least once a year, re-examine the family composition, the community service and self-sufficiency requirement, and incomes of all resident families, except that families paying Flat Rent will have their incomes reexamined only every three years.

E. Page 51, add the following:

XII. Community Service and Self-Sufficiency Requirement ("CSSR")

A. Requirement.

Unless exempt, every adult public housing resident must contribute 8 hours of community service each month or participate in an economic self-sufficiency program for 8 hours each month or participate in a combination of community service and economic self-sufficiency for 8 hours each month.

1. Community service activities include, but are not limited to, service at a childcare center, hospital, homeless shelter, nursing home, school, recreation center and nonprofit organizations dedicated to seniors, youth, the performing arts or that serve PHA residents. Community service is volunteer work and not employment and does not include political activities.
2. Self-sufficiency activities include, but are limited to, job training, substance abuse or mental health counseling, budgeting and credit counseling, GED classes, higher education (junior college or college), English as a second language and/or English proficiency classes.

B. Exempt Residents.

The following are exempt from the CSSR:

1. Individuals that are 62 years of age or older;
2. Individual that are disabled and certify that the disability prevents compliance with the CSSR;
3. Individuals that are the primary caretaker of a disabled individual;
4. Individuals that are engaged in work activities as defined in Section 407 (d) of the Social Security Act for at least 20 hours per week; and,
5. A member of the family receiving assistance from and in compliance with a state program funded under part A of Title IV of the Social Security Act or under any other state welfare program.

C. Compliance

1. Exempt residents must provide documentation that they qualify for an exemption and sign an annual certification that they have received and read the CSSR policy. Nonexempt residents must provide documentation that they have complied with the CSSR. Residents may obtain the appropriate forms from PHA to certify exemption or compliance.
2. PHA will review documentation and verify exemptions and compliance at least 30 days prior to the annual reexamination and/or lease expiration. If PHA determines that a resident has not complied with the CSSR, PHA will notify the resident in writing of the noncompliance

and that PHA will not renew the lease at the end of the term unless the resident: (1) enters into an agreement with PHA that the resident will satisfy the service requirement over the next 12 months; or (2) provides assurance to PHA that the noncompliance family member no longer resides in the household. The resident may request a grievance hearing on PHA's determination in accordance with PHA's grievance procedures.

3. If there is a change in the status of a resident, from exempt to nonexempt or nonexempt to exempt, the resident must notify PHA within 10 days of change.
4. Residents should seek PHA approval prior to volunteering for organizations or participating in activities to make sure such organization or activity will count toward their obligation. To the extent possible, PHA will provide residents with a list of qualified organizations and activities. It is the resident's responsibility to make the necessary arrangements and ensure compliance with CSSR.
