1. The minimum rent requirement may be waived under certain circumstances. Financial hardship status is to be granted immediately for ninety (90) days in the event of the following:
 - a. The family has lost eligibility or is awaiting an eligibility determination to receive federal, state or local assistance, including a family having a non-citizen household member lawfully admitted for permanent residence and who would be entitled to public benefits but for Title IV of the Personal Responsibility and Work Opportunity Act of 1996;
 - b. The family income has decreased due to changed circumstances such as separation, divorce, and abandonment;
 - c. One or more family members have lost employment;
 - d. The family would be evicted as a result of imposing the minimum rent requirement;
 - e. There has been a death in the family; or
 - f. There are other hardship situations determined by the PHA on a case-by-case basis, i.e. alimony, child support, etc.Financial hardship exemption only applies to payment of minimum rent not to rent based on the statutory formula for determining the Total Tenant Payment (TTP).
2. If tenant initiates a request for a hardship exemption that the PHA determines is temporary in nature:
 - a. If the hardship is determined to be temporary, minimum rent may be suspended; during the ninety (90) day period beginning on the day the request is made. At the end of the ninety (90) day period, the minimum rent is reinstated retroactively to the date of suspension and the HAP is again adjusted.
 - b. In the case of a temporary hardship, the PHA will allow the family a maximum of six (6) months to make payment of any delinquent minimum rent payments accrued during the suspension period. However, the family must execute a Repayment Agreement.
 - c. If the hardship is subsequently determined to be long-term, the PHA will retroactively exempt residents from the minimum rent requirement for the ninety (90)-day period.
 - d. Note that the PHA can only suspend the minimum rent contribution. If the family is residing in a unit whose Gross Rent exceeds the Payment Standard, the family will be responsible for the excess rent.

Minutes of Meeting

A regular meeting of the Board of Directors of The Village of New Square Housing Authority (VNSPHA) was duly called and held on December 9, 2010 at the offices of the Corporation commencing at 11:30 a.m.

There were present and participating at the meeting:
Moti Dirnfeld; Arthur Feldheim; Jacob Braun; Betty Mermelstein.

With approval of those present, Moti Dirnfeld acted as Chairperson of the meeting and Betty Mermelstein recorded the minutes.

On motions duly made and seconded, it was voted:

1. The Minutes of the previous meeting were approved as read.
2. The financial statements prepared by Sichler, Torchia, Allen and Churchill were reviewed and approved. The Board agreed to hire the same firm to prepare the following year's financial statements.
3. The Board reviewed and approved the PHA Annual Plan and authorized its submission to the U S Department of Housing and Urban Development (HUD).
4. A proposal to adopt a Project Based Section 8 Program (PBV) was discussed and it was agreed to postpone a decision pending further discussion and review. The Board authorized a moratorium on releasing any available Section 8 Housing Choice Voucher slots pending the decision regarding the PBV Program.
