The average rental vacancy is rate is 4%. There has been moderate single family custom and speculative development, esp. outside of Chandler. There has been limited rental development in areas near Oklahoma County border.</p> <p>The Housing Authority has three families on the four bedroom waiting list, has six families on the three bedroom waiting list, has twenty-five families on the two bedroom waiting list, and has thirteen families on the one bedroom waiting list. A few the accomplishments include adoption and implementation of a new Admissions and Continued Occupancy Policy (ACOP), physical improvements including and upgrade of the fall surface of the playground, replacement of remaining HVAC units, replacement of carpet in ten units, replacement of a sewer line, installation of a security system, and replacement of five ranges and refrigerators. This was accomplished using a combination of ARRA and annual CFP. Other efforts made include adopting policies in the ACOP that address reasonable accommodations according to established guidelines and conducting one Resident Advisory Board meeting on July 24, 2009 and scheduling one for the July, 2010 during the process of approving the 2011 Annual Agency Plan.

4. 12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.
13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.




