There are households of various races and ethnic groups, families of varied ages, peoples with and without disabilities, and varied incomes. In the current economic situation , including job losses/reductions, the HRA continues to see additional needs on an ongoing basis.</p>

6. **Designated Housing for Elderly and Disabled Families.** With respect to public housing projects owned, assisted, or operated by the PHA, describe any projects (or portions thereof), in the upcoming fiscal year, that the PHA has designated or will apply for designation for occupancy by elderly and disabled families. The description shall include the following information: **1)** development name and number; **2)** designation type; **3)** application status; **4)** date the designation was approved, submitted, or planned for submission, and; **5)** the number of units affected.
7. **Community Service and Self-Sufficiency.** A description of: **(1)** Any programs relating to services and amenities provided or offered to assisted families; **(2)** Any policies or programs of the PHA for the enhancement of the economic and social self-sufficiency of assisted families, including programs under Section 3 and FSS; **(3)** How the PHA will comply with the requirements of community service and treatment of income changes resulting from welfare program requirements. **(Note: applies to only public housing).**

The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

8.2 Capital Fund Program Five-Year Action Plan

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

8.3 Capital Fund Financing Program (CFFP). Separate, written HUD approval is required if the PHA proposes to pledge any

portion of its CFP/RHF funds to repay debt incurred to finance capital improvements. The PHA must identify in its Annual and 5-year capital plans the amount of the annual payments required to service the debt. However, the provisions of Section 7 of the ACC shall remain in effect for so long as HUD determines there is any outstanding indebtedness of the PHA to HUD which arose in connection with any development(s) under the ACC(s) and which is not eligible for forgiveness, and provided further that, no disposition of any development covered by this amendment shall occur unless approved by HUD.







Chair Person Jengenson called meeting to order at 1:00 PM

APPROVAL OF PREVIOUS MINUTES: Motion was made by Deloris Schmidt and seconded by John Hall to approve the March 11, 2011 minutes.

Motion was approved.

NEW BUSINESS: Lori Haugland handed out copies of pages 1 and 2 of 2011 Plan and reminded us to bring those to each meeting.

Lori Haugland presented her views for the 2012 PHA Plan. Pages 1&2 of the 2012 plan will be almost identical to 2011 plan. Normally Grants were up to \$43,000.00. Now, for 2012 Grants are expected to A\$20,000.00

Because we are considered a small agency; (less than 250 units) Lori will request that the Grant received for 2012 be put into Operating Fund Account for Public Housing, just in order to maintain, and nothing be put into Capitol Funds account.

HUD requires that PHA maintains a \$50,000.00 to \$60,000.00 checkbook/assets balance.

Lori's goal is to have the 2012 plan completed by July 1, 2011. When completed a copy of the plan will be sent to RAB members. The Plan will be posted for 45 days for public review. Then be sent to HUD for approval.

Lori stated that a lot of money was spent for improvements after HUD inspections.

There are 28 Public Housing Units and just under 200 Vouchers in this agency.

DIFFERENCE : Section 8 vouchers /vs Public housing vouchers.

A Section 8 vouch can travel. Section 8 vouchers have to move where section 8 vouchers are accepted.

A Public Housing Voucher are fixed units.

Exp. If a person moves away - the unit is still a Public Housing Unit for the next person.

OPEN DISCUSSION:

Deloris Schmidt is no longer under Section 8 and may have to relinquish her Vice-Chair position. Lori will be checking with attorneys for legal advice on how to proceed. The Board may have to hold a special meeting for election to fill that position.

Bridget will be preparing and sending out a friendly letter to PH and Voucher persons in an attempt to get new members before March 2012 meeting.
