The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

8.2 Capital Fund Program Five-Year Action Plan

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

portion of its CFP/RHF funds to repay debt incurred to finance capital improvements. ADDENDUM: *Violence Against Women Act*

The Housing Authority of Cass County will work on a referral basis with the Rape and Abuse Crisis Center of Fargo for any family or individual that has been a victim of domestic violence, dating violence, sexual assault, or stalking.

Programs that are offered include Crisis Intervention using their 24-hour crisis line and in-person assistance. They include support counseling for female and male victims of all ages and their families and friends. Play therapy is used for young child victims. Support groups are offered for female and male victims of all ages. Lastly, Rape and Abuse Crisis Center will provide legal advocacy to assist those needing assistance with Protection Orders.

Since the Housing Authority of Cass County is quite small, we will use the Rape and Abuse Crisis Center and other service agencies to provide activities, services or programs to help child and adult victims of domestic violence, dating violence, sexual assault, or stalking to obtain or maintain housing.

Lastly, the Housing Authority of Cass County will use the Community Education speakers from the Rape and Abuse Crisis Center to provide education on domestic violence, sexual assault, and child sexual abuse should it be determined appropriate.

4. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
