Increase opportunity for resident input by conducting at least one Resident Advisory Board meeting each year. <p>Progress on goals of the 2005 – During the last five years improvements to the management of the Prague PHA have been a consistent theme for the Prague PHA's Board of Commissioners. These efforts resulted in the Board ultimately looking at the question of whether or not to hire a new Executive Director or to select another option when the position of Executive Director became vacant. Their decision was a difficult one but with HUD's guidance it ultimately resulted in a Cooperative Agreement with the Housing Authority of the City of Shawnee, OK for management services in August, 2005. Ensuring the rating of a High Performing Housing Authority was a goal that was achieved under the Cooperative Agreement. In addition during the five year period, the Prague PHA was able to use Capital Fund to modernize the public housing units replacing hot water tanks, problem HVAC systems, and several showers. A picnic area was installed and new washers and dryers for the laundry room were purchased. Handrails were installed throughout the property and new fencing was completed.</p>

For the state as a whole it contains voluminous amounts of information related to the requested information above, however for the City of Prague the information is quite limited. The State Consolidated Plan provides information related to the county as opposed to the City of Prague. In the Consolidated Plan they reference the Housing Market Analysis Real Estate Consultation for Lincoln County conducted by the University of Oklahoma College of Continuing Education dated May 18, 2002. It says the, <i>“Anticipated need for 371 new owner-occupied units and 93 new rental units over the next five years. Need located throughout Lincoln County Demand for owner-occupied residences greatest below \$80,000 in the city of Chandler and below \$105,000 in outlying areas.”</i> It continues saying, <i>“Lincoln county has had increasing population, households, and housing units for the past 30 years. The economy is primarily centered around manufacturing and services. Due to its close proximity, the local economy is moderately tied to that of Tulsa and Oklahoma City metro Areas.”</i> The median 2001 Household income in Lincoln County is \$33,937.</p> <p>The Housing Authority has 22 households on the one bedroom waiting list, 38 households on the two bedroom waiting list, and 5 households on the three bedroom waitlist. There are 20 caucasian and 2 african American applicants for the one bedroom list, 33 Caucasian, 4 African American and 1 Native American on the two bedroom waiting list, and 5 Caucasian on the three bedroom waiting list.</p>

- (a) In 2010 the Prague Housing Authority renewed a Cooperative Agreement with the Shawnee Housing Authority for management services. The Board of Commissioners approved an updated utility allowance schedule, directed staff to implement a risk control policy, and adopted an investment policy. Physical improvements to the property were made with the Capital Fund program and included two roof replacements, replacement of 30 storm doors, and an addition of 5 parking spaces. A handicapped ramp was purchased and installed as a reasonable accommodation. A Resident Advisory Board meeting was held February 26, 2010 at 10:00 a.m. and no one attended.

Again in 2011 the Prague Housing Authority renewed the Cooperative Agreement with the Shawnee Housing Authority for management Services. The Board Of Commissioners approved an updated utility allowance schedule. Physical improvements to the property were made with Capital Fund program and included roof replacement of five buildings, the replacement of five showers, a remodel of the Community Room including new tile and kitchen cabinets and countertops. In addition one range, 2 HVAC condensers and a coil were purchased. Operations funded the replacement of 4 building's roofs. A Resident Advisory Board meeting was held February 25, 2011.

The Housing Authority of the Town of Prague, Oklahoma met for its annual R.A.B. (Resident Advisory Board) meeting on Friday, February 24, 2012 at 9:00 a.m. in the Housing Authority Community Building at 607 Mitacek Street, Prague, Oklahoma.

The meeting was called to order by Jason Boyer.

Present: Jason Boyer, and 4 residents

Jason opened the meeting by thanking those in attendance he then stated that the agency plan has been complete; however, it was still a work in progress. He then turned the floor over to the residents and asked what suggestions they had for the spending of the Capital Fund money.

The residents had several suggestions on the spending of the capital fund money. The following items are those suggestions.

- 1) New addresses on buildings
- 2) Painting, Mr. Boyer informed the residents that this could possibly be a capital fund item; however, it was more of a work order item. Mr. Boyer explained that the best time to paint an occupied unit would be in the winter when maintenance did not have the grounds to worry about. Mr. Boyer noted that he did have a list of units that needed painting and when maintenance had some down time it would be completed.
- 3) New Storm windows in units

Mr. Boyer asked if there were any other suggestions; no other suggestions were given, Mr. Boyer thanked the residents for attending and stated the meeting was adjourned.


WHEREAS, the Housing Authority believes it still in the best interest of the Authority to submit the plan to HUD for approval, and



The Plan contains a certification by the appropriate State or local officials that the Plan is consistent with the applicable Consolidated Plan, which includes a certification that requires the preparation of an Analysis of Impediments to Fair Housing Choice, for the PHA's jurisdiction and a description of the manner in which the PHA Plan is consistent with the applicable Consolidated Plan.
3. The PHA certifies that there has been no change, significant or otherwise, to the Capital Fund Program (and Capital Fund Program/Replacement Housing Factor) Annual Statement(s), since submission of its last approved Annual Plan. The Capital Fund Program Annual Statement/Annual Statement/Performance and Evaluation Report must be submitted annually even if there is no change.
4. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
6. The PHA certifies that it will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.

The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
8. For PHA Plan that includes a policy for site based waiting lists:
 - The PHA regularly submits required data to HUD's 50058 PIC/IMS Module in an accurate, complete and timely manner (as specified in PIH Notice 2006-24):

12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.
13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments), 2 CFR Part 225, and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments).
19. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
20. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.
21. The PHA provides assurance as part of this certification that:
 - (i) The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;
 - (ii) The changes were duly approved by the PHA Board of Directors (or similar governing body); and
 - (iii) The revised policies and programs are available for review and inspection, at the principal office of the PHA during normal business hours.
22. The PHA certifies that it is in compliance with all applicable Federal statutory and regulatory requirements.




