8. **Safety and Crime Prevention.** For public housing only, describe the PHA's plan for safety and crime prevention to ensure the safety of the public housing residents. The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

## 7.0

The Beloit Community Development Authority (CDA) is currently engaged in the rehabilitation of their entire public housing portfolio. The process will be completed in two phases. The phases are respectively called Beloit Apartment Redevelopment Phase 1 (Phase1) and Beloit Apartment Redevelopment Phase 2 (Phase 2).

Phase 1 construction began on September 23, 2011. The units involved were approved for Disposition by the SAC office. The units in Phase 1 consisted of single-family housing and duplexes. The Disposition was approved to allow for the modernization and weatherization of these units with a Mix-Finance agreement utilizing CFP monies, Tax Credit Investors and Loans from the City of Beloit. (Please see the attached Matrix for a listing of each address and the proposed changes and improvement to each of the units.)

Phase 1 is 95% complete and fully occupied. The remaining construction entails finishing the garages on the McLenegan site, and completing landscaping after the garages are constructed. The expected date of total completion is November 14, 2011.

Phase 2 construction will begin on October 17, 2011. The CDA received approval for the Disposition application on August 11, 2011. The project consists of a newly constructed two-story building that will have (40) one- bedroom and (1) two-bedroom housing units. This building will replace the (10) four-plex bulidings and (1) two-bedroom house at 220 Portland Avenue. The four-plex bulidings are being demolished.

There will also be (9) two-bedroom townhomes built at this location. These 9 townhomes will replace 9 four and five-bedroom homes which are currently in the portfolio. This adjustment will allow the PHA to better serve the high demand for two-bedroom units in the Beloit area. The two-bedroom waiting list for public housing far exceeds that of the list for the larger units.

Sixteen single-family homes will receive modernization and weatherization as part of Phase 2. The units will receive extensive interior update, insulation, windows, doors, and new appliances. Please see the attached address list for these properties.

The Mixed-Financing for this project is through Tax-Credit Investments, City of Beloit loans and a grant from the Federal Home Bank. The project is expected to be completed by September of 2012.
