

Definitions

MFP Grantee – A state that has been awarded a 5 year financial grant through the Center for Medicare and Medicaid Services (CMS) Money Follows the Person (MFP) Demonstration Project. This initiative will assist States in their efforts to reduce their reliance on institutional care, while developing community-based long-term care opportunities that enable the elderly and people with disabilities to live and fully participate in their communities. Depending upon the MFP grantee state, MFP participants will receive some combination of regular State Plan Medicaid services (i.e., services like personal care), Home and Community-Based Services (HCBS) under a waiver, or special MFP supplemental services.

HCBS Waiver Services – Medicaid Home and Community-Based Services (HCBS) Waiver Services are for people who are eligible for Medicaid and eligible for institutional services covered by Medicaid. Waiver services are used to prevent persons from entering, or to assist them in transitioning from, an institution. These Waivers are CMS approved proposals by the State to provide services that are not otherwise covered by their State Plan Medicaid. Waivers help provide services to specific populations such as older adults, young adults with physical disabilities, developmentally disabled, or traumatic brain injuries. The service package of a specific waiver is developed with the special needs of the population being served. They may include services such as transition services, personal care services, adult/medical day programs, assistive technology, and other type services that provide support for individuals moving back into a community setting so that they may live independently with health and safety in mind.
