Family Unification	Vouchers	Vouchers	Required to be issued to FUP-eligible families for 5 years. After that period, if the HA wants to roll available vouchers into MTW, HA to advise prior to expiration whether any FUP families are still assisted; these must remain as vouchers until the family vacates the unit or leaves the program; balance can be rolled into MTW
Litigation	Vouchers	Vouchers	HA to advise prior to expiration whether consent decree or litigation results requires any number to remain as Vouchers and they want the balance rolled into MTW; if HA does not notify HUD, Vouchers will be renewed
Disaster Relocation	Vouchers	MTW	HUD replaces only the number of units leased
Hsg Conv - PD Relocation	Vouchers	Vouchers	If the HA wants to roll them into MTW, HA to advise prior to expiration whether any enhanced vouchers are still in use; these must remain as vouchers until the tenant vacates the unit or leaves the program. If HA does not notify HUD, Vouchers will be renewed
Hsg Conv - Enforcement Actions	Vouchers	Vouchers	If the HA wants to roll them into MTW, HA to advise prior to expiration whether any enhanced vouchers are still in use; these must remain as vouchers until the tenant vacates the unit or leaves the program. Rent Supplement Replacements	Vouchers	Vouchers	If the HA wants to roll them into MTW, HA to advise prior to expiration whether any enhanced vouchers are still in use; these must remain as vouchers until the tenant vacates the unit or leaves the program.

Designated Housing	Vouchers	Vouchers	FY 2003 Appropriations requires that vouchers provided for disabled must keep their identity and serve the disabled
Project Based / Certain Developments	Vouchers	Vouchers	FY 2003 Appropriations requires that vouchers provided for disabled must keep their identity and serve the disabled
Welfare to Work	Vouchers	Vouchers	Must remain as Welfare to Work voucher until tenant vacates the unit or leaves the program. At renewal, the WTW vouchers may be rolled into the block grant if so requested by the HA.
