Pursuant to the provisions of Section 1616( e) of the Social Security Act, I certify that the Tennessee Health Facilities Commission (HFC), as the designated State Survey Agency for coordinating compliance with the Keys Amendment; the Tennessee Department of Mental Health and Substance Abuse Services (TDMHSAS); and the Tennessee Department of Disabilities and Aging (DDA), are in compliance with the statutory and regulatory provisions of the Keys Amendments.

In the 2022 legislative session, the Tennessee General Assembly passed Public Chapter 1119 to create a new independent state agency, HFC. HFC is formed from the former Health Services and Development Agency (HSDA) and Department of Health's Office of Health Care Facilities (OHCF). The Health Facilities Commission is the Centers for Medicare & Medicaid (CMS) designated State Surveying Agency (SSA). The Health Facilities Commission encompasses the Certificate of Need Program, the Health Facilities Commission (formerly the Board for Licensing Health Care Facilities which sunset July 1, 2024), the Nursing Home Civil Monetary Penalty Reinvestment Program, Clinical Laboratory Improvement Amendments (CLIA) Program, conducts the surveys and investigations of health facilities to ensure compliance with state and federal regulations, and licenses seventeen (17) different types of health care facilities.

- SB1135/HB1050 Nuisances - Establishes that the occurrence of certain specified circumstances is prima facie evidence of a nuisance. Authorizes a court to require the person or entity keeping, maintaining, or carrying on a nuisance in certain instances to pay statutory damages of not less than \$1,000 and not more than \$50,000 to any person who owns real property within the zip code in which the nuisance exists, and who files a claim with the court that the person's property value was damaged by the continued existence of the nuisance.
