SUBJECT: Under Evaluation: Project-Specific Nonavailability Waiver of Build America Buy America Act (BABA) Requirements to the Goldfinch Lofts Affordable Housing Project for an Elevator (HUD Waiver #W-0000085)

Introduction

The U.S. Department of Housing and Urban Development (HUD) is issuing a final BABA waiver to an assistance recipient based on nonavailability of a single product for a single project.

Solicitation of Public Comment

The proposed waiver was posted on HUD's public facing webpage and a notice of the proposed waiver was posted to the Made in America website from January 21, 2026, through February 4, 2026, thus satisfying the requirement to publish any BABA project waiver and provide the public with fifteen (15) days to submit comments. HUD is seeking public and industry comments from all interested parties and encouraging current manufacturers of the subject products to submit comments regarding potential availability. HUD did not receive any public comments on this waiver during the public comment period. Therefore, no changes were made to the proposed waiver, except to replace references to the “proposed waiver” with references to the “final waiver.”

Background

The Buy America Preference set forth in section 70914 of BABA included in the Infrastructure Investment and Jobs Act (IIJA) (Pub. L. No. 117-58), requires that all iron, steel, manufactured products, and construction materials used for infrastructure projects under Federal financial assistance awards be produced in the United States.

Under section 70914(b), HUD may waive the application of the Buy America Preference (BAP), in any case in which it finds that: applying the domestic content procurement preference would be inconsistent with the public interest; types of iron, steel, manufactured products, or construction materials are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or the inclusion of iron, steel, manufactured products, or construction materials produced in the United States would increase the cost of the overall project by more than twenty-five (25) percent. All waivers must have a written explanation for the proposed determination; provide a period of not less than fifteen (15) days for public comment on the waiver; and be submitted to the Office of Management and Budget’s (OMB) Made in America Office for review to determine if the waiver is consistent with policy.

Summary

Final Waiver: HUD is issuing a project waiver of the requirements of section 70914 of BABA included in the IIJA, for an elevator in an infrastructure project funded through the HOME Investment Partnerships Program (HOME).

Waiver Type: Partial nonavailability of domestic products in sufficient and reasonably available quantities or of a satisfactory quality. This waiver will waive part 2(ii) of the definition of “Produced in the United States” at 2 CFR 184.3, which requires the cost of components of a manufactured product that are produced in the United States to exceed 55% of the total cost of all components of the manufactured product.

Waiver Level and Scope: Project-level waiver for a single product for a single project. No other project will utilize the waiver.

Waiver Description: Project-specific nonavailability waiver of BABA requirements to the Goldfinch Lofts affordable housing project in Des Moines, Iowa for an elevator.

Project Summary: The project is in Des Moines, Iowa. The project consists of a 28-unit affordable housing building located at 35th and Ingersoll Avenue.

Length of the Waiver: From February 23, 2026, until December 31, 2027.

Items Covered in Waiver: The Iowa Finance Authority is being issued a waiver for an elevator, as described in detail below:

- Residential Elevator
 - Category: Manufactured Product
 - Cost: \$70,000.00
 - Quantity: 1
 - PSC: 3960 – Freight Elevators
 - NAICS: 333921 – Elevators, passenger and freight, manufacturing
 - Country of Origin: Assembled in USA; Component parts sourced from Canada, Mexico, India, and China
 - Technical Specifications:
 - Guiderail-mounted in overhead of hoistway
 - Capacity: 2500 lbs/150 fpm
 - Landings: 3
 - Entrances: 3 front
 - Control System: Full Collective Control Simplex
 - ASME_A17.1-2019

Description of Efforts Made to Avoid the Need for a Waiver

Both the grantee and HUD made every effort to obtain a BABA-compliant elevator.

Due to the technical specifications of this project, an elevator that can be affixed to a Cross Laminated Timber (CLT) mass timber elevator shaft is required for this project. The grantee completed market research between May and September 2025 which consisted of outreach to total of five (5) manufacturers or suppliers of elevators. None of the manufacturers or suppliers were able to provide fully BABA-compliant products that met the technical specifications of the project. However, one manufacturer was able to provide an elevator that meets the technical specifications of the project and is assembled in the USA from foreign parts.

HUD conducted an online search of manufacturers and suppliers and did not locate any manufacturers or suppliers that could provide a fully BABA-compliant elevator.

Anticipated Impact if No Waiver is Issued

Failure to grant a waiver for this project would result in the termination of the project because an elevator is necessary for the building to be compliant with the Americans with Disabilities Act (ADA).

HUD additionally believes this waiver is justified because most items used in this project will be compliant with BABA. This waiver is for items whose total value is less than one (1) percent of the total infrastructure expenditure for this project. Approval of this waiver will ensure that the remainder of materials costs support BABA-compliant manufacturers, consistent with the intent of BABA.

Assessment of Cost Advantage of a Foreign-Sourced Product Under OMB M-24-02, agencies are expected to assess "whether a significant portion of any cost advantage of a foreign-sourced product is the result of the use of dumped steel, iron, or manufactured products or the use of injuriously subsidized steel, iron, or manufactured products" as appropriate before granting a public interest waiver. HUD has concluded that this assessment is not applicable to this waiver as this waiver is not based on the cost of foreign-sourced products.
