Purpose of eVMS

Purpose of the System

What is eVMS?

The Enterprise Voucher Management System (eVMS) is used for managing funds for the Housing Choice Voucher (HCV) Program. eVMS performs the following functions:

- Automatically calculates housing assistance payments (HAPs) using 50058 family-level data derived from PIC (PIH Information Center), and from any future successor system.
 - eVMS does not directly collect 50058 data and is view only to PHAs.
- Calculates and tracks administrative fees across all programs (available in later releases).
- Provides a daily view of funding balances.
- Eventually replace the Voucher Management System and provide stakeholders with an efficient centralized HCV financial system that has increased functionality and transparency.

HUD is developing eVMS to further support its mission to create strong, sustainable, inclusive communities and quality affordable homes for all.

Monthly Disbursement



Use of 50058 Data

- Unit Months Leased (UML) and HAP expenses will be gathered via submitted 50058s.
- Data will be used to determine monthly disbursements of HAP and eventually administrative fee eligibility.

PHAs will still need to monitor disbursement schedules and work with the Financial Management Center (FMC) to request changes to disbursement amounts if anticipated HAP need exceeds planned eVMS disbursements.

NOTE: Confirm PIC 50058 information is current and accurate prior to requesting additional disbursements from FMC.

Upon logging in, the **PHA landing page** or the **Payment Analysis Report (PAR) Summary** page displays.

- PHA Available Funds and Activity
- Admin Fees

Users can view **Column A Rates** and **Unit counts**, **Column B Rates** and **Unit counts**, the **total of Column A**, the **total of Column B**, the **total of both Column A and B combined**, and the **total after being multiplied by the proration factor**. The proration factor is a hard-coded value and may need to be updated on an annual basis.

The **Admin Fee** section has a column for PAR Today, Last Month Calculated, Difference, and Last Payment.

NOTE: Admin fee calculations are currently unavailable.

Examples of HCV Program Rules

Other Program Rules	Details
Zero HAP Families	HAP Amount = \$0
HAP “Stops”	EOPs, Port Outs, Port Absorbs, etc.
Proration	Lease Ups and Exits with varying effective dates.
Partial Month Payments	HAP Changes with effective dates during a month.
Retro-Adjustments	Automatically adjust previous calculations if “older” effective dates are submitted.



50058 Reporting PHA Deadlines

Best Practices

Deadline*	PHA Best Practice
1 st through 19 th of the Month	PHAs complete 50058 submissions and submit to HUD
Weekly	PHA should review and verify the corrections no longer appear on the PIC Error Dashboard
15 th of the Month	PHAs complete all 50058 submissions and corrections to HUD
18 th of the Month	PHA's final check of the PIC Error Dashboard to ensure all corrections have been accepted
19 th of the Month	PHA submits all 50058s to HUD

*If a date falls on a weekend or holiday, the action will take place on the following business day.

50058 Reporting PHA Deadlines

20 th of the Month	eVMS locks overnight and close processes begin 12am ET of 21 st
21 st of the Month	eVMS calculations completed and monthly statements generated

- eVMS uses the current month HAP data to calculate the next months disbursement amount.
 - Example: The April 21st lock will calculate PHAs May HAP disbursement using their April 50058 data.
- The 50058s that are submitted after the lock date will be automatically captured and incorporated into the next HAP disbursement.
 - Example: Any 50058s with an April effective date submitted after the April 21st lock, will be captured in the May 21st close cycle and included in the June HAP Disbursement.
- PHAs should follow their normal procedures to request HUD-Held Reserves (HHR) from their FMC FA if the monthly calculation is not sufficient to cover their HAP need.

**If the close cycle falls on a weekend or holiday, the action will take place on the following business day.*

Possible Differences Between System of Record and eVMS

- 1. Manual Adjustments:** Prior period adjustments in VMS may not be reflected on 50058s.
- 2. Payment Abatements/Holds:** 50058s do not capture payments that are processed but not remitted for enforcement or operational reasons.
- 3. 50058 Fatal Errors:** PHAs should work with HCV Program staff to ensure that 50058 fatal errors are being corrected in a timely manner. [Refer to PIC Error Dashboard training.](#)
- 4. Timing of 50058 Submissions:** Are there 50058s for the upcoming month that have been processed in the system of record but not yet transmitted to HUD?
- 5. MTW PHAs:** eVMS is currently unable to calculate HAP for MTW PHAs. If an MTW PHA is billing your PHA for a portability participant, the associated HAP will not be captured or calculated.

eVMS Reports & Best Practices

Reports

- eVMS is currently developing a Reporting module that will give users extensive reporting capabilities, including ADHOC and custom reports.
- In the current system version, there is the **"50058 Family Level Detail Report."**
- This report will enable PHAs to view all applicable 50058s used in their HAP Disbursement.

eVMS Reports & Best Practices

Best Practices

How can I be sure all applicable 50058s were included in a HAP disbursement calculation?

- Pull a PIC ADHOC report showing all current 50058 records and compare it to a similar report from your system of record.
 - *Historic 50058 records in PIC need to be viewed by participant.*
- Compare the eVMS "50058 Family Level Detail Report" to a 50058 report from your system of record.

What should I look for?

- Check that all 50058s were submitted and accepted to PIC.
- Check the timing of when the 50058 was submitted to PIC.
 - Was it before or after that month's close cycle?
- Is there a hold or abatement?
- Is the participant out of a unit and searching?
- Is it a portability billing participant with an MTW PHA?

eVMS Reports & Best Practices

Best Practices

What happens if my calculated HAP disbursement is lower than my monthly need?

- Confirm that all 50058s have been submitted and accepted to PIC prior to that month's close cycle.
- Identify any 50058s needing correction and ensure they are submitted/accepted to PIC.
 - eVMS will automatically create a retro-adjustment in the following months calculation.
- Contact your assigned Financial Management Center (FMC) Financial Analyst to request a drawdown from your available HUD Held Reserves.

What happens if there was an overpayment in my HAP disbursement?

- Identify the 50058s that need to be corrected and ensure they are submitted/accepted to PIC.
 - EVMS will automatically create a retro-adjustment in the following months payment.
- The HUD Financial Management Division (FMD) performs annual VMS HAP reconciliations, which can result in overpayments and offsets against future HAP disbursements.
 - For example: an active participant is out of a unit and searching, abatement/holds/etc.



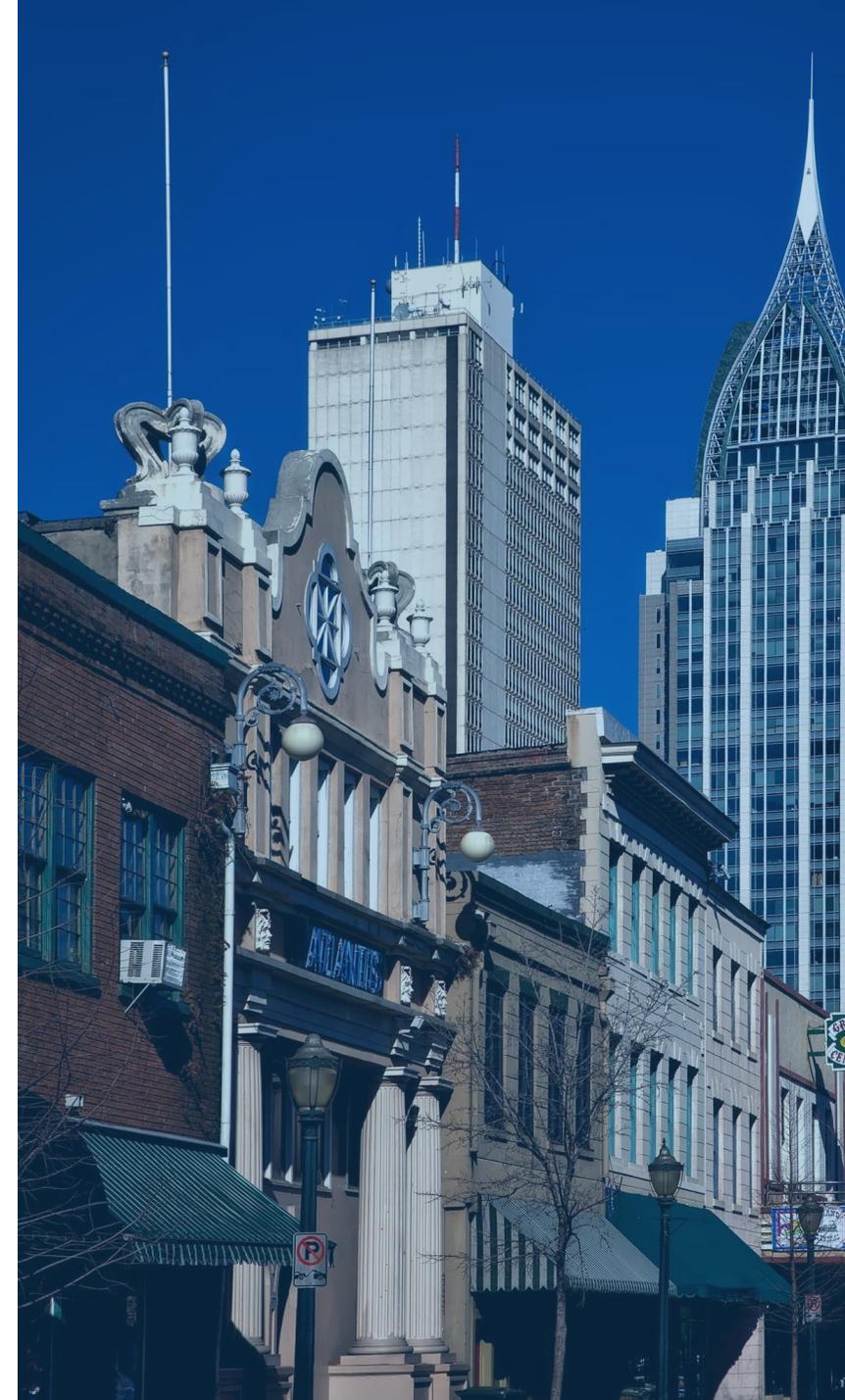
Importance of Accurate 50058 Reporting

Importance of Accurate 50058 Reporting

Since disbursements of HAP will be dependent on 50058 data, the timely and accurate submissions of 50058s have greater importance.

For SEMAP purposes, 50058s are due within 60 days of the effective date of the transmission. However, 50058s should be submitted on a regular basis and rejected submissions should be corrected quickly.

Incomplete 50058 reporting could result in inaccurate disbursements of HAP and administrative fees.

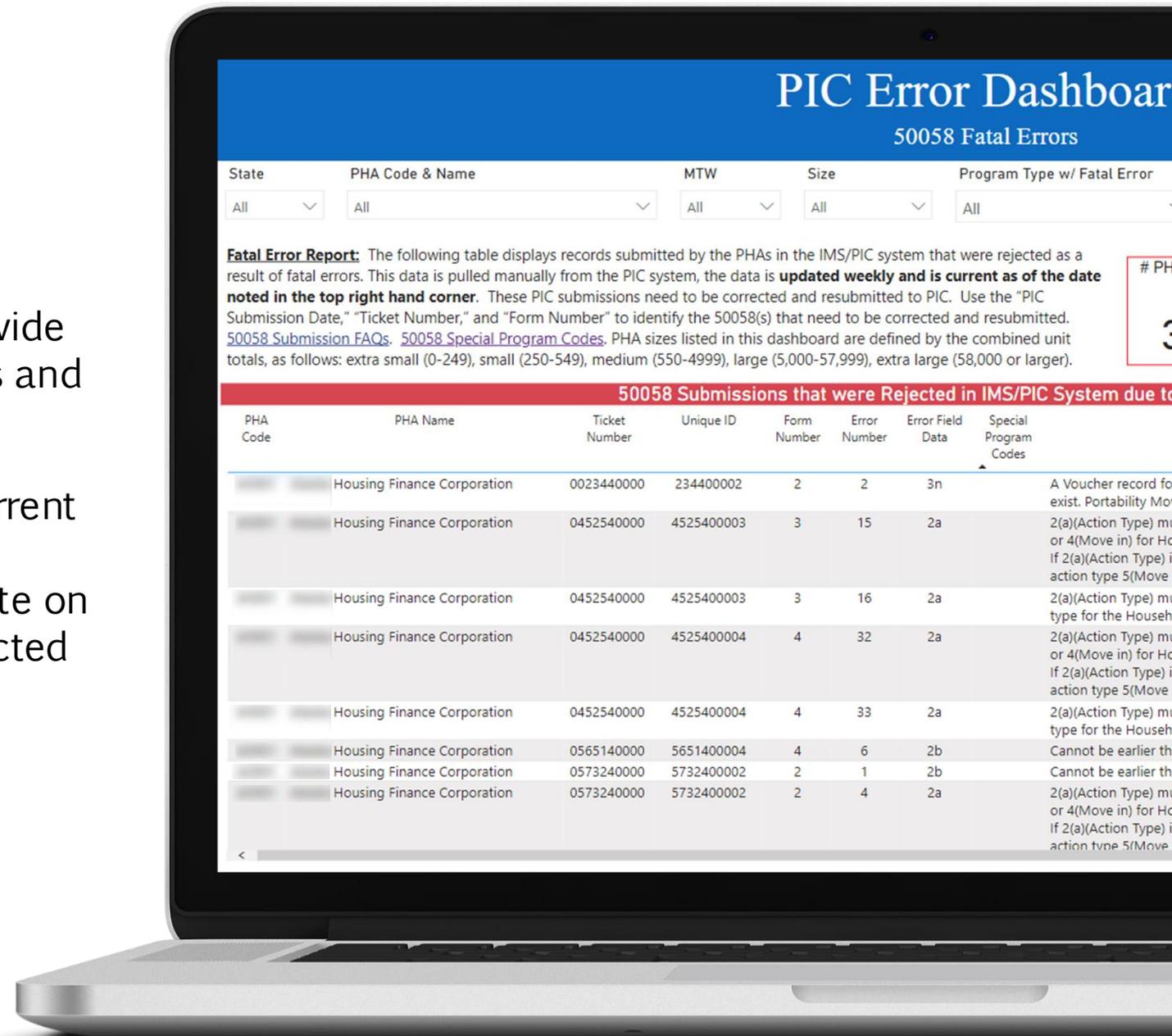


PIC Error Dashboard

HUD developed the PIC Error Dashboard to provide PHAs with an updated view of current PIC errors and a snapshot of performance.

Use the dashboard to determine your PHA's current errors. Once corrected in the system of record, check the dashboard regularly (see updated date on the dashboard) to ensure the errors were corrected and accepted in PIC.

1.2 50058 Family-Level Calculation

The **58 Calculation** page can be viewed by clicking the link to the right of the line item **58 Calculation**. Under that line, the date of the most recent data is displayed. On this page, the calculated HAP is shown. The dollar amounts generated are based on calculations using 50058 data from the previous day.

Line items for the 50058 are displayed, including:

- Section 11: Project-Based HAP
- Section 12: Tenant-Based HAP
- Section 15: Homeownership (HOV) HAP

In addition, tracking for port-ins is provided on this page. This is the number of vouchers that are classified as portability-in (action code 4 from the 50058) for the current and last month calculation for the PHA.

See the image below for an example of the 58 Calculation page. Just like the PAR Summary page, there are columns with the value for that day, the previous month, and the difference from the previous month. A user can extract the current view of the 58 Calculation page at any time by clicking the **Print** button (Print) in the upper right corner of the screen.

To exit the 58 Calculation page, select the **X** in the upper right corner of the screen.

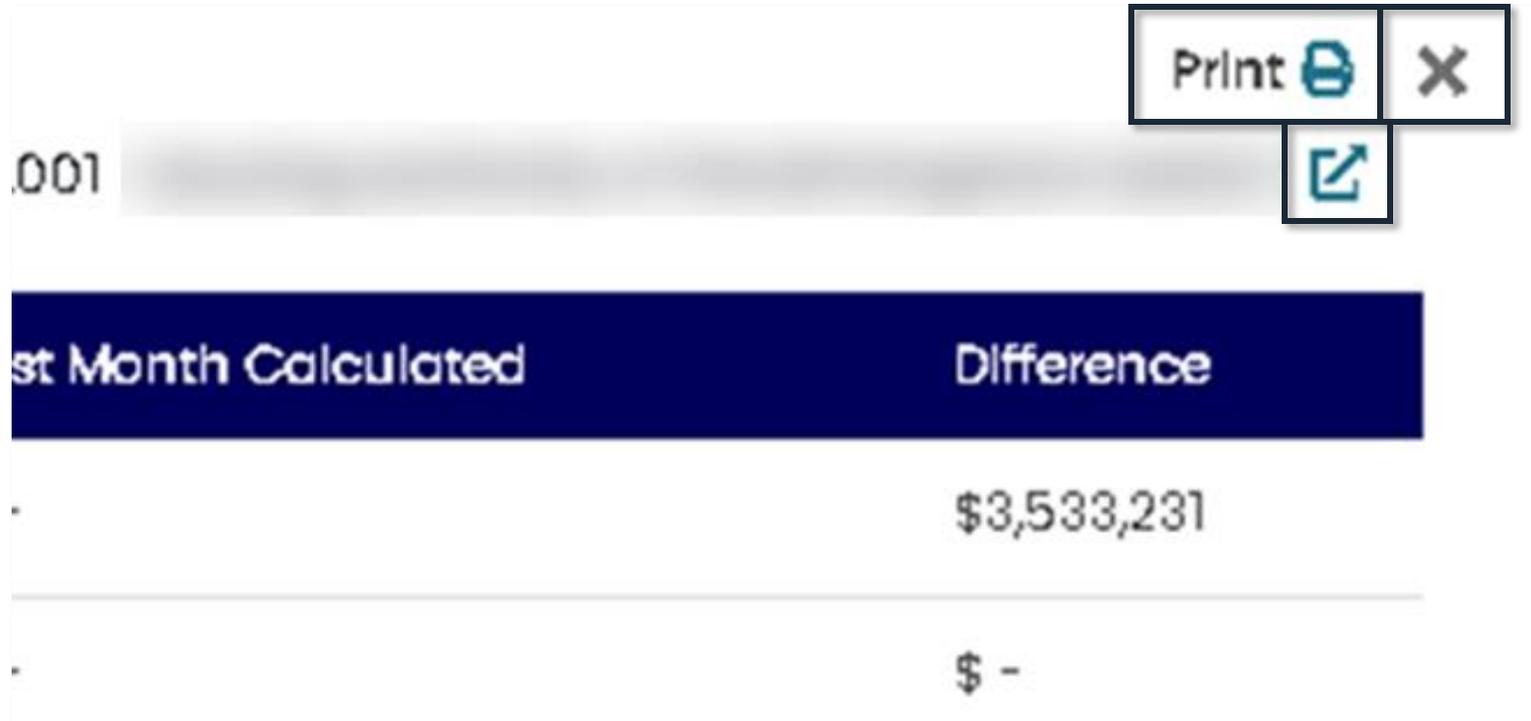

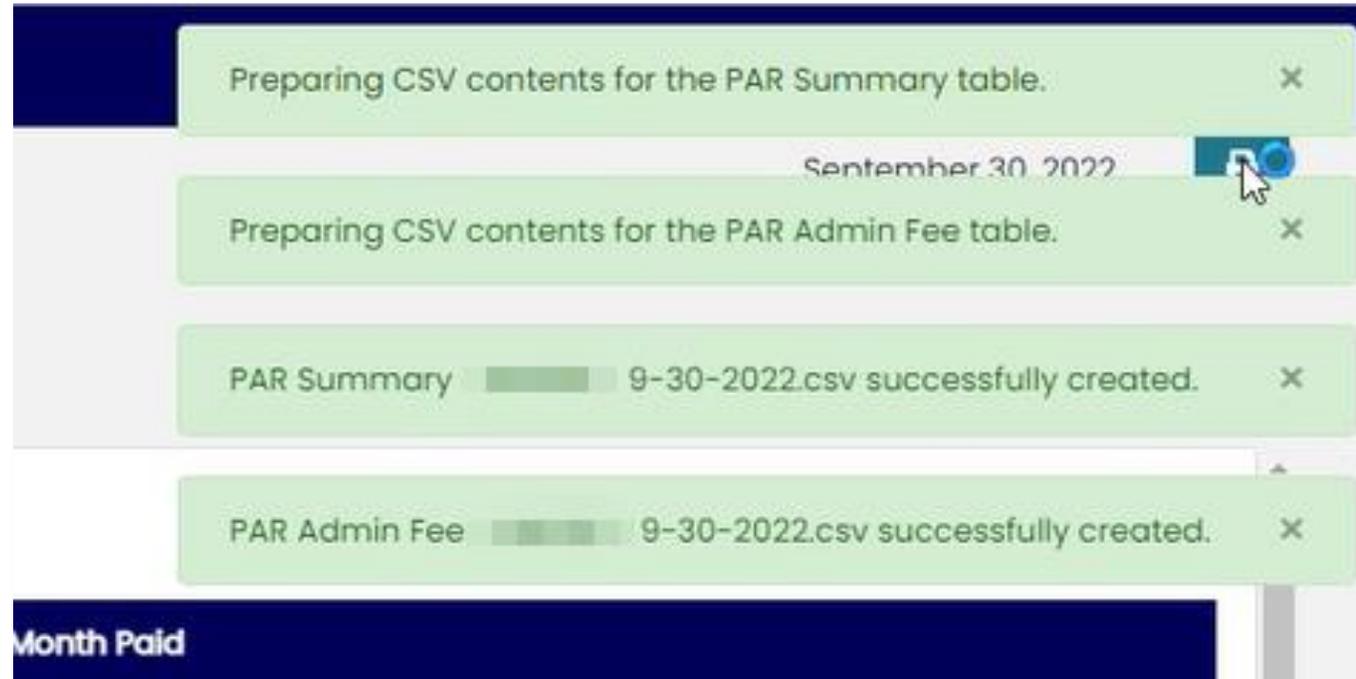
