Insured Property State	State	State of insured property
Insured Property Zip Code	zip_code	Five-digit zip code of insured property
Insured Property Zip Code + 4	zip_plus_4	Four-digit zip code extension of insured property
Occupancy Type	occupancy_type	Code indicating the use and occupancy – E.G. , Single Family, Residential mobile/manufactured home, etc. etc.
Insured Property County	county	Name of county as determined by geocoding the address
Post FIRM	post_firm_construction	Yes or No Indicator on whether construction was started before or after publication of the Federal Insurance Rate Map (FIRM)
Building Type	building_type	Building characteristics, typically number of stories

Insured Building Longitude	longitude	Approximate longitude of the insured building
Insured Building Latitude	latitude	Approximate latitude of the insured building
Geocode Accuracy	accuracy	Qualitative assessment of the accuracy of geocode
Repetitive Loss (FMA)	is_fma_rl	Property is FMA Repetitive Loss
Severe Repetitive Loss (FMA)	is_fma_srl	Property is FMA Severe Repetitive Loss
