

## Continuum of Care Builds (CoC Builds) NOFO Final Pro Rata Need (FPRN) Report

As stated in Section I.A.2 of the CoC Builds NOFO, funding of approximately \$75,000,000 is available. Additional funds may become available for award. Use of these funds is subject to statutory constraints. All awards are subject to the selection process contained in the NOFO.

Of this \$75,000,000 not less than \$30,000,000 is available only for CoC's that are located in state with populations of fewer than 2.5 million people.

The following FPRN Report includes each CoC's Preliminary Pro Rata Need (PPRN) amount and Estimated Annual Renewal Demand (ARD) as recorded on the FY 2025 CoC Program Grant Inventory Worksheets (GIW).
