Your local government must have an average unemployment rate of 9 percent or more over the past three years when calculated using American Community Survey (ACS) 5-Year Estimates to meet this criterion. <u>Instructions:</u> View the "Employment Status" Table, click on the "Geographies" button above the table, and search for your community. Make sure you find the data for the three most recent ACS 5-Year tables. Your local government must have a poverty rate of 20 percent or more among individuals not enrolled in higher education (undergraduate or graduate school), as of the most recent ACS 5-Year Estimates to meet this criterion. <u>Instructions:</u> View the "Poverty Status in the Past 12 Months by School Enrollment by Level of School for the Population 3 Years and Over" Table, click on the "Geographies" button above the table, and search for your community. We use a crosswalk to translate the 2000 estimates into the 2010 census tract geographies, as some census tracts have been altered. Eligibility	5	Why does DCTA focus on local governments serving communities with less than 50,000 people?	Local governments with 50,000 or more people are entitlement communities and tend to receive resources directly from the federal government and HUD. DCTA intends to directly provide capacity building technical assistance to smaller local governments that typically do not receive resources directly from the federal government.	7/29/21	N/A

Eligibility	7	What types of activities are eligible under the DCTA Program?	Most local governments that participate in HUD's DCTA program will complete a capacity needs assessment (CNA). This helps HUD, the technical assistance (TA) provider, and the local government to explore and better understand the challenges that may be addressed through TA. Following the CNA, local governments participate in engagements designed for them. This may include training, developing tools, establishing protocols and procedures, or establishing cross-sector working groups. DCTA is not intended to provide funding for staffing positions or building physical infrastructure (e.g. sidewalks, case managers, etc.). However, this TA might be used to rethink a local government's administrative structure or strategic plan (including a hiring schedule and assistance developing appropriate job descriptions for the needed positions), develop strategies for leveraging private sector investment, or access existing federal grant programs to finance community development projects.	7/29/21	9/13/22
Eligibility	8	I believe my community meets the economically distressed threshold(s) for unemployment, poverty, population decline, or inclusion of persistent poverty census tracts. May I provide alternate data to demonstrate eligibility for this program?	If you have alternate state or local data from a reputable data source, you may use this data to demonstrate your Unit of General Local Government's (UGLG's) eligibility for this program. Eligibility	9	Does a community need to meet all three distressed criteria to be considered eligible under Category 1?	A community only needs to meet the economically distressed criteria for one of three areas (unemployment rate, poverty rate, or population decline). Meeting more than one criterion will not impact prioritization. However, if a community meets both an economically distressed criterion (Category 1) and includes census tracts experiencing persistent poverty (Category 2), this may increase prioritization and TA resources that are available.	7/29/21	N/A

Eligibility	10	Is there a minimum population size for a local government to be eligible for Distressed Cities and Persistent Poverty Technical Assistance (DCTA)?	DCTA prioritizes communities with populations between 8,000 and 50,000 people. There may be flexibility with communities with populations under 8,000 if the local government demonstrates the capacity to engage in the DCTA Program. This is evaluated on a case-by-case basis. Please note, the direct recipient of the TA must be a local government (e.g. county, city, or tribe). Eligibility	11	What types of entities or organizations are eligible to receive technical assistance under the DCTA program?	The primary recipients of DCTA will be Units of General Local Government (UGLGs or local governments) (cities, townships, counties, parishes, villages, etc.) and tribal governments. UGLG equivalents in U.S. territories (e.g. districts, counties, or municipalities) may also be eligible to receive DCTA. The entity that receives the technical assistance must either directly govern the community or be directly involved in policy making and/or program development for that community. As of HUD fiscal year 2022, nonprofit organizations may receive technical assistance through this program by partnering with their associated local government.	7/29/21	9/13/22
Eligibility	12	Can tribal governments be eligible for DCTA?	Yes. Both Federal and State recognized tribal governments that meet Category 1 (economically distressed) and/or Category 2 (experiencing persistent poverty) criteria that have fewer than 50,000 people are eligible for DCTA. Tribal governments with populations over 50,000 may still be eligible if the focus of the TA will benefit specific communities that meet these requirements within the tribal territory. Eligibility	13	Are local governments in the U.S. territories (Puerto Rico, U.S. Virgin Islands, Northern Mariana Islands, Guam, American Samoa) eligible for the DCTA?	All local governments in U.S. territories may be considered for this technical assistance. We recognize that local governments in these territories are not found in the list of Units of General Local Government (UGLGs), and we also recognize that the Census data HUD is using to determine eligibility may not be available for some of these communities. HUD will work with representatives of these communities to determine eligibility. Process	15	How will HUD determine who gets technical assistance?	The DCTA Team reviews requests for assistance on a case-by-case basis. This begins with determining whether the primary applicant represents a Unit of General Local Government (UGLG or local government) or tribal government, and whether the community meets the selection criteria (economically distressed or experiencing persistent poverty, and population size). For more information on these criteria, as well as instructions for submitting requests for technical assistance, please visit the Distressed Cities and Persistent Poverty Technical Assistance page on the <a href="http://HUD.gov">HUD.gov</a> . The DCTA Team will also evaluate the local government's capacity to receive and benefit from DCTA in a sustainable way, the tenure and priorities of local/tribal government leadership, and the local/tribal government's previous interactions with HUD. These previous interactions with HUD may include conversations with the local HUD office. Process	16	Is there a deadline for applying for DCTA?	There is no deadline for applying. We will continue to review applications for assistance until the funding runs out. Please note that not all requests for assistance will be approved. We encourage you to submit your application at a time when you have the capacity to work with HUD's technical assistance (TA) provider. Eligibility	17	Is a match required for recipients of DCTA?	No, a match is not required for recipients of DCTA. No funding is provided to units of general local government or non-profit organizations that receive support through DCTA.	3/24/23	N/A
Eligibility	18	Is this TA available to public housing authorities?	DCTA is available to units of general local government (UGLGs). As a quasi-governmental entity, public housing authorities (PHAs) are not eligible to request DCTA. However, if a PHA's affiliate UGLG requests and receives DCTA, the PHA may receive TA indirectly as it relates to the UGLG's technical assistance priorities and goals.	3/24/23	N/A

Eligibility	19	What role can Metropolitan Planning Organizations play in DCTA?	DCTA is available to units of general local government – such as cities, counties, or townships. A metropolitan planning organization (MPO) is not eligible to receive DCTA directly as it is not a UGLG. DCTA may support a local government’s work with regional organizations, nonprofits, philanthropy, and other cross-sector partnerships as it relates to the UGLG’s technical assistance priorities and goals.	3/24/23	N/A
Process	20	How does an eligible entity submit a request for DCTA?
