# HOME Investment Partnerships American Rescue Plan (HOME-ARP) Funding Allocation Plan March 2022

Participating Jurisdiction: City of Clarksville, TN Date: 4/04/2022



#### Introduction

On March 11, 2021, the United States Congress appropriated \$5 billion in American Rescue Plan (ARP) funds to assist individuals or households who are experiencing homelessness, at risk of experiencing homelessness, and other vulnerable populations, by providing housing, rental assistance, supportive services, and non-congregate shelter, to reduce homelessness and increase housing stability across the country.

In September 2021, HUD awarded the City of Clarksville \$1,882,125 in HOME-ARP funds. HOME-ARP funds must primarily assist people in HOME-ARP "qualifying populations," which include:

· Sheltered and unsheltered homeless populations

- Those currently housed populations at risk of homelessness
- Those fleeing or attempting to flee domestic violence or human trafficking

• Other Populations where providing supportive services or assistance would prevent the family's homelessness or would serve those at greatest risk of housing instability.

To receive funding, the City of Clarksville must develop and submit a HOME-ARP Allocation Plan to HUD, which describes the distribution of HOME-ARP funds and identifies any preferences for eligible activities. The City of Clarksville must also inform the development of the HOME-ARP Allocation Plan through stakeholder consultation and community engagement. The following is the draft HOME-ARP Plan.

#### Consultation

#### Summarize the consultation process:

The City of Clarksville consultation process included surveying the public and private entities that provide services or shelter facilities to the above qualifying populations to obtain their views and comments regarding the community's needs. The City sent the survey to 46 organizations, and 22 organizations responded.

#### **Public Participation**

# Describe the public participation process, including information about and the dates of the public comment period and public hearing(s) held during the development of the plan:

The public's participation is a vital part of the HOME-ARP planning process as it assists in assessing the needs of and gathering input from all those who live in Clarksville.

The Public Comment period for the HOME-ARP Allocation Plan (15 days) began on Friday, January 14 and concluded on Saturday, January 29, 2022

A Public Notice was published in the Leaf Chronicle on January 14th and included information regarding the HOME-ARP plan as well as the scheduled Public Hearing information. The Public Hearing took place on Monday, January 24, 2022 at 2 p.m., meeting held at City Hall, 1 Public Square, Neighborhood & Community Services Conference Room with the option to attend virtually.

#### Describe any efforts to broaden public participation:

In addition to the Public Notice being published in the Leaf-Chronicle, it was also posted on the City's official website. As required, the online notice provided the amount of HOME-ARP funds expected to be received and the range of activities that the City can undertake.

To increase public participation, the list below are the examples of effects taken to broaden public involvement:

- The City provided information regarding the purpose and eligible uses for the HOME-ARP Fund at the City Council and Neighborhood and Community Services Council Committee meetings;
- The City conducted community town hall meetings at various locations throughout the City;
- The City shared with the faith-based leaders the proposed HOME-ARP range of activities that they could undertake.
- The option to attend the Public Hearing virtually was offered to enable citizens and organizations to participate in the development and comment on the HOME-ARP Plan.

# Summarize the comments and recommendations received through the public participation process:

The comments from the community partners and organizations are listed in the consultation table above. However, one additional comment gaven from a City Council member suggested that all HOME-ARP funds go to the TBRA program and not withhold any funds for Administrative and Planning cost.

#### **Needs Assessment and Gaps Analysis**

PJs must evaluate the size and demographic composition of qualifying populations within its boundaries and assess the unmet needs of those populations. # Describe the size and demographic composition of qualifying populations within the PJ's boundaries:

#### **Population Experiencing Homeless:**

Per HUD's definition of homeless as defined in 24 CFR 91.5 is described as:

• An individual or family who lacks a permanent and adequate permanent home

• A person or family who will imminently lose their permanent home due to a lack of resources or support

• A youth under the age of 25, even if accompanied by an adult, that does not have a permanent home

Within the Central Tennessee CoC region, there are a total of 517 households that are currently experiencing homelessness as of 2020. Approximately 215 households, or 42%, are family households (and are not veterans). An estimated 305 households, or 58%, are adult-only households (and are not veterans). An additional 51 households, or 9%, are veterans.

Based on the 2020 Point-in-Time (PIT) Count Report, the racial/ethnic background of persons experiencing homelessness in Montgomery County is as follows:

- Transgender (less than 1%)

- Black, African-American, or African (44%)
- White (46%)
- Asian or Asian American (less than 1%)
- Native Hawaiian or Pacific Islander (less than 1%)

- Multi-Racial (6%)

#### ETHNICITY

- Hispanic (7%)
- Non-Hispanic (93%)

AGE

- 0-17 (13%)
- 18-24 (11%)
- Over 25 (76%)

#### **Population At Risk Of Homelessness:**

The term "at risk of homelessness" with respect to an individual or family whose income is less than or equal to 30% AMI with a cost burden greater than 50% are at risk of experiencing homelessness. Based on the 2020 Census data, over 13 % of Clarksville's population is in this category of potential risk. The Five-Year Consolidated Plan identified the following statistics:

- The highest disproportionately greater need for housing cost to income ratio between 30% and 50% cost burden is White with 56%, Black/African American with 29%, and Hispanic with 8%.
- The highest disproportionately greater need for housing cost to income ratio greater than 50% severely cost burdened is White with 56%, Black/African American with 28% and Hispanic with 10%.

#### Population Fleeing or attempting to flee domestic violence or human trafficking:

For HOME-ARP, this population includes any individual or family who is fleeing, or is attempting to flee, domestic violence, dating violence, sexual assault, stalking, or human trafficking. It includes cases where an individual or family reasonably believes that there is a threat of imminent harm from further violence due to dangerous or life-threatening conditions that relate to violence against the individual or a family member, including a child, that has either taken place within the individual's or family's primary nighttime residence or has made the individual or family afraid to return or remain within the same dwelling unit.

Statistics show that 38% of all domestic violence victims become homeless at some point in their lives. When facing a life-threatening or dangerous domestic violence situation, an individual may be forced out of their home leaving them without safe shelter. In many cases, the housing options are scarce especially for victims who are jobless, have children, have a substance abuse problem, or have a criminal record.

• The Clarksville Police reports in 2021 they had 5,385 calls to 911 and 1,235 arrests related to domestic violence.

• Over the past fiscal year, SafeHouse (*Clarksville's only domestic violence shelter*) provided emergency shelter to 84 unduplicated households (136 individuals) for a total of 2,118 bednights. Also, SafeHouse reported 618 crisis hotline calls for FY 2021-2022.

#### **Other Populations:**

- Operation Stand Down, provides and connects Veterans and their families resources focused on transition, employment, housing, benefits, peer engagement, volunteerism and connection to the community, reported over 30 emergency rental and mortgage assistance requests during 2021.
- Urban Ministries' Grace Assistance, a non-profit organization that provides emergency utility assistance, served over 250 people with partial emergency payments of their gas, water, or electric bills. By doing this, individuals and families could remain in their homes.

# Describe the unmet housing and service needs of qualifying populations, including but not limited to:

- Sheltered and unsheltered homeless populations;
- Those currently housed populations at risk of homelessness;
- Other families requiring services or housing assistance or to prevent homelessness; and,
- Those at greatest risk of housing instability or in unstable housing situations:

Clarksville is the fifth-largest city and the third fastest-growing city in Tennessee. Due to the rapid population growth, there has been an increase in the community's unmet housing and service needs. Below describes the challenges and unmet needs of the qualifying populations.

- There is a severe lack of affordable, quality housing in the jurisdiction, especially among households with less than 50% AMI yearly incomes.
- Affordable housing, in any condition, is nearly non-existent for households with annual incomes at 0-30% AMI.
- These low-income figures mean that it is more difficult for households to meet monthly expenses, especially when housing costs more than 30% of their income, it is more challenging to save for a down payment for a home. It is more difficult to qualify for a mortgage to purchase a home.
- The highest disproportionated and greater need for housing cost to income ratio between 30% and 50% cost burden is White with 56%, Black/African American with 29% and Hispanic with 8%.
- And the highest disproportionated and greater need for housing cost to income ratio greater than 50% severely cost-burdened is White with 56%, Black/African American with 28%, and Hispanic with 10%.

- A recent survey given to the community partners and organizations revealed that over 68% of them have a waiting list for their services to the community.
  - Soldiers and Families Embraced (SAFE) and Veterans Affairs HUD/VASH serves veterans, active duty, first responders, and their families have a combined waiting list of over 60.
  - CMCCAA Head Start Program, which helps low-income families with children ages 3 to 5, has a waiting list of 125.
  - The Clarksville Housing Authority waitlist currently has 380 applicants: families, the elderly, and the disabled. The average wait time for a home is from three (3) months to one (1) year or longer.
- According to the 2020 Point-in-Time (PIT) Count Report for Montgomery County, the total number of homeless is 125, and the number of beds available is 94.
- The current Domestic Violence facility only has seven staff members and four bedrooms (sixteen beds) to operate 24/7. Due to limited bed space and staffing, SafeHouse routinely turns away an average of 30 individuals plus their minor children monthly because of these limitations.

#### Identify and consider the current resources available to assist qualifying populations, including congregate and non-congregate shelter units, supportive services, TBRA, and affordable and permanent supportive rental housing:

Shelter Units: Clarksville currently has a scattered-site shelter system, with different organizations providing different services to a diverse population. The majority of shelters use a dormitory setting. There are currently 94 year-round shelter beds.

Services: The City uses CDBG to fund public services to stabilize individuals and families by providing wraparound services; however, the City can use a cap of 15% of the total grant amount CDBG for public services.

- Households that are fleeing from domestic violence can access shelter and counseling services to support their housing needs, and referrals to Urban Ministries Safe House.
- Matthew Walker Comprehensive Health Center, providing primary care services, pediatrics, laboratory, Behavioral Health, nutritional counseling, dental services and mobile clinic outreach program.
- Several local faith-based organizations provide rent, mortgage, food, utilities, and homeless services.

Tenant Based Rental Assistance (TBRA): There is currently no Tenant Based Rental Assistance (TBRA) program in Clarksville.

Permanent Supportive Housing: The Clarksville Housing Authority offers public housing 510 units ranging from 1-5 bedrooms.

# Identify any gaps within the current shelter and housing inventory as well as the service delivery system:

#### Gaps within the current shelter inventory:

• Shelters for larger family sizes

#### Gaps within the current housing program inventory:

• Rentals that are "affordable"; three bedroom and larger units; handicap-accessible units; one bedroom units; two-bedroom units

• Housing specific for people, the elderly and those with disabilities.

#### Gaps within the service delivery system:

• Waiting lists are long - Clients are often not reachable when shelter/housing becomes available.

# Identify the characteristics of housing associated with instability and an increased risk of homelessness if the PJ will include such conditions in its definition of "other populations" as established in the HOME-ARP Notice:

Characteristics attributed to housing instability and increased risk of homelessness include:

- Having a household income between 0-30% AMI;
- Experiencing severe housing cost burden;
- A person with a disability living alone on a fixed income;
- Household members with physical disabilities and other chronic health issues;
- Poor credit or no credit history;
- Households with a member who has a record of criminal history.

#### Identify priority needs for qualifying populations:

HOME-ARP qualifying populations often have many competing needs. The priority needs identified are affordable housing through a tenant-based rental assistance program that allows those in the lowest income groups to afford market-rate housing and valuable support services.

# Explain how the level of need and gaps in its shelter and housing inventory and service delivery systems based on the data presented in the plan were determined:

Gaps were determined based on various sources of information and analysis, including PIT and HIC reports, U.S. Census Data, consultations and data from community partners.

The City of Clarksville will not administer the proposed activities directly. The subrecipient will be selected through a request for proposals process in accordance with the established City of Clarksville policies and procedures. This process will involve development of a scope of services consistent with the HOME ARP Notice, solicitation to local non-profit and governmental agencies who serve homeless populations, review, scoring, interviews, and award.

#### **Use of HOME-ARP Funding**

#### Describe how the characteristics of the shelter and housing inventory, service delivery system, and the needs identified in the gap analysis provided a rationale for the plan to fund eligible activities:

The gap analysis shows a need to strengthen the City's crisis response system to identify those experiencing homelessness, prevent homelessness when possible, connect people with housing quickly, and provide services when needed. One significant gap is the ability to access affordable housing. People experiencing a housing crisis or fleeing an unsafe situation need to quickly find a place to stay. After a wide range of responses on system gaps and strategies to address them, supplement rental assistance would be the most rational plan to assist this community.

#### Estimate the number of affordable rental housing units for qualifying populations that the PJ will produce or support with its HOME-ARP allocation:

Based on the estimates provided above, the City estimates it can directly assist 114 households with HOME-ARP funding.

The City of Clarksville does not intend to use HOME-ARP funds to produce new rental housing.

A recent survey, conducted in December 2021, by Clarksville Neighborhood & Community Services (CNCS) revealed that HOME-ARP funding will have the most significant impact for the City of Clarksville by creating a program that offers rental assistance for up to 24 months for low- to very-low-income persons.

The City will be receiving \$1,882,125 in HOME-ARP funding. These funds will be used for Tenant-Based Rental Assistance (TBRA) and eligible Administration costs of up to 20%. The HOME-ARP TBRA program can be used to provide rental assistance, security de-posits, and utility deposits to income-eligible house-holds. Eligible households include:

- People experiencing homelessness
- Those at risk of homelessness Individuals fleeing, or attempting to fiee, domestic violence, dating violence, or sexual assault Victims of stalking or human trafficking Veterans and Families that include a Veteran
- Family Member
